The State of Nebraska, Administrative Services (AS), Materiel Division, State Purchasing Bureau, is issuing this Request for Proposal, RFP Number 5145Z1 for the purpose of selecting a qualified person, persons, or firm to assist the Nebraska Power Review Board (NPRB) in representing the interests of the NPRB, the State of Nebraska, and Nebraska’s electric ratepayers in matters pertaining to electric transmission issues before the Southwest Power Pool (SPP).

Bidder should submit one (1) original of the entire proposal. Proposals must be submitted by the proposal due date and time.

GLOSSARY OF TERMS

Acceptance Test Procedure: Benchmarks and other performance criteria, developed by the State of Nebraska or other sources of testing standards, for measuring the effectiveness of products or services and the means used for testing such performance.

Addendum: Something to be added or deleted to an existing document; a supplement.

Agency: Any state agency, board, or commission other than the University of Nebraska, the Nebraska State colleges, the courts, the Legislature, or any other office or agency established by the Constitution of Nebraska.

Agent/Representative: A person authorized to act on behalf of another.

Amend: To alter or change by adding, subtracting, or substituting.

Amendment: A written correction or alteration to a document.

Appropriation: Legislative authorization to expend public funds for a specific purpose. Money set apart for a specific use.

ARO: After Receipt of Order

Award: All purchases, leases, or contracts which are based on competitive proposals will be awarded according to the provisions in the Request for Proposal. The State reserves the right to reject any or all proposals, wholly or in part, or to award to multiple bidders in whole or in part. The State reserves the right to waive any deviations or errors that are not material, do not invalidate the legitimacy of the proposal, and do not improve the bidder's competitive position. All awards will be made in a manner deemed in the best interest of the State.

Best and Final Offer (BAFO): In a competitive bid, the final offer submitted which contains the bidder's (vendor's) most favorable terms for price.

Bid/Proposal: The offer submitted by a vendor in a response to written solicitation.

Bid Bond: An insurance agreement, accompanied by a monetary commitment, by which a third party (the surety) accepts liability and guarantees that the vendor will not withdraw the bid.

Bidder: A vendor who submits an offer bid in response to a written solicitation.

Business: Any corporation, partnership, individual, sole proprietorship, joint-stock company, joint venture, or any other private legal entity.

Business Day: Any weekday, except State-recognized holidays.

Calendar Day: Every day shown on the calendar including Saturdays, Sundays, and State/Federal holidays.

Cancellation: To call off or revoke a purchase order without expectation of conducting or performing it at a later time.

Collusion: An agreement or cooperation between two or more persons or entities to accomplish a fraudulent, deceitful, or unlawful purpose.

Commodities: Any equipment, material, supply or goods; anything movable or tangible that is provided or sold.

Commodities Description: Detailed descriptions of the items to be purchased; may include information necessary to obtain the desired quality, type, color, size, shape, or special characteristics necessary to perform the work intended to produce the desired results.

Competition: The effort or action of two or more commercial interests to obtain the same business from third parties.

Confidential Information: Unless otherwise defined below, "Confidential Information" shall also mean proprietary trade secrets, academic and scientific research work which is in progress and unpublished, and other information which if released would give advantage to business competitors and serve no public purpose (see Neb. Rev. Stat. § 84-712.05(3)). In accordance with Nebraska Attorney General Opinions 92068 and 97033, proof that information is proprietary requires identification of specific, named competitor(s) who would be advantaged by release of the information and the specific advantage the competitor(s) would receive.

Contract: An agreement between two or more parties creating obligations that are enforceable or otherwise recognizable at law; the writing that sets forth such an agreement.

Contract Administration: The management of the contract which includes and is not limited to; contract signing, contract amendments and any necessary legal actions.

Contract Management: The management of day to day activities at the agency which includes and is not limited to ensuring deliverables are received, specifications are met, handling meetings and making payments to the Contractor.

Contract Period: The duration of the contract.

Contractor: Any individual or entity having a contract to furnish commodities or services.

Cooperative Purchasing: The combining of requirements of two or more political entities to obtain advantages of volume purchases, reduction in administrative expenses or other public benefits.

Copyright: A property right in an original work of authorship fixed in any tangible medium of expression, giving the holder the exclusive right to reproduce, adapt and distribute the work.

Cost Allocation Working Group (CAWG): A working group that was created by the Southwest Power Pool's Regional State Committee.

CPU: Any computer or computer system that is used by the State to store, process, or retrieve data or perform other functions using Operating Systems and applications software.

Critical Program Error: Any Program Error, whether or not known to the State, which prohibits or significantly impairs use of the Licensed Software as set forth in the documentation and intended in the contract.

Customer Service: The process of ensuring customer satisfaction by providing assistance and advice on those products or services provided by the Contractor.

Default: The omission or failure to perform a contractual duty.

Deviation: Any proposed change(s) or alteration(s) to either the terms and conditions or deliverables within the scope of the written solicitation or contract.

Evaluation: The process of examining an offer after opening to determine the vendor's responsibility, responsiveness to requirements, and to ascertain other characteristics of the offer that relate to determination of the successful award.

Evaluation Committee: Committee(s) appointed by the requesting agency that advises and assists the procuring office in the evaluation of bids/proposals (offers made in response to written solicitations).

Extension: Continuance of a contract for a specified duration upon the agreement of the parties beyond the original Contract Period. Not to be confused with "Renewal Period".

Free on Board (F.O.B.) Destination: The delivery charges are included in the quoted price and prepaid by the vendor. Vendor is responsible for all claims associated with damages during delivery of product.

Free on Board (F.O.B.) Point of Origin: The delivery charges are not included in the quoted price and are the responsibility of the agency. Agency is responsible for all claims associated with damages during delivery of product.

Foreign Corporation: A foreign corporation that was organized and chartered under the laws of another state, government, or country.

Installation Date: The date when the procedures described in "Installation by Contractor", and "Installation by State", as found in the RFP, ITB (written solicitation) or contract are completed.

Integrated Marketplace: A Regional Transmission Organization's market that coordinates next-day generation across the region to maximize cost-effectiveness, provide participants with greater access to reserve energy, improve regional balancing of electricity supply and demand, and facilitate the integration of renewable resources.

Late Bid/Proposal: An offer received after the Opening Date and Time.

Licensed Software Documentation: The user manuals and any other materials in any form or medium customarily provided by the Contractor to the users of the Licensed Software which will provide the State with sufficient information to operate, diagnose, and maintain the Licensed Software properly, safely, and efficiently.

Mandatory/Must: Required, compulsory, or obligatory.

May: Discretionary, permitted; used to express possibility.

Module (see System): A collection of routines and data structures that perform a specific function of software.

Must: See Shall/Will/Must.

NPRB: Nebraska Power Review Board.

National Institute for Governmental Purchasing (NIGP): National Institute of Governmental Purchasing – Source used for assignment of universal commodity codes to goods and services.

Open Market Purchase: Authorization may be given to an agency to purchase items above direct purchase authority due to the unique nature, price, quantity, location of the using agency, or time limitations by the AS Materiel Division, State Purchasing Bureau.

Opening Date and Time: Specified date and time for the public opening of received, labeled, and sealed formal proposals.

Operating System: The control program in a computer that provides the interface to the computer hardware and peripheral devices, and the usage and allocation of memory resources, processor resources, input/output resources, and security resources.

Outsourcing: The contracting out of a business process which an organization may have previously performed internally or has a new need for, to an independent organization from which the process is purchased back.

Payroll & Financial Center (PFC): Electronic procurement system of record.

Performance Bond: An insurance agreement, accompanied by a monetary commitment, by which a third party (the surety) accepts liability and guarantees that the Contractor fulfills any and all obligations under the contract.

Platform: A specific hardware and Operating System combination that is different from other hardware and Operating System combinations to the extent that a different version of the Licensed Software product is required to execute properly in the environment established by such hardware and Operating System combination.

Pre-Bid/Pre-Proposal Conference: A meeting scheduled for the purpose of clarifying a written solicitation and related expectations.

Product: Something that is distributed commercially for use or consumption and that is usually (1) tangible personal property, (2) the result of fabrication or processing, and (3) an item that has passed through a chain of commercial distribution before ultimate use or consumption.

Program Error: Code in Licensed Software which produces unintended results or actions, or which produces results or actions other than those described in the specifications. A program error includes, without limitation, any Critical Program Error.

Program Set: The group of programs and products, including the Licensed Software specified in the RFP, plus any additional programs and products licensed by the State under the contract for use by the State.

Project: The total scheme, program, or method worked out for the accomplishment of an objective, including all documentation, commodities, and services to be provided under the contract.

Proposal: See Bid/Proposal.

Proprietary Information: Proprietary information is defined as trade secrets, academic and scientific research work which is in progress and unpublished, and other information which if released would give advantage to business competitors and serve no public purpose (see Neb. Rev. Stat. § 84-712.05(3)). In accordance with Attorney General Opinions 92068 and 97033, proof that information is proprietary requires identification of specific, named competitor(s) who would be advantaged by release of the information and the specific advantage the competitor(s) would receive.

Protest/Grievance: A complaint about a governmental action or decision related to an Invitation to Bid or resultant contract, brought by a vendor who has timely submitted a bid response in connection with the award in question, to AS Materiel Division or another designated agency with the intention of achieving a remedial result.

Public Proposal Opening: The process of opening correctly submitted offers at the time and place specified in the written solicitation and in the presence of anyone who wished to attend.

Recommended Hardware Configuration: The data processing hardware (including all terminals, auxiliary storage, communication, and other peripheral devices) to the extent utilized by the State as recommended by the Contractor.

Release Date: The date of public release of the written solicitation to seek offers

Renewal Period: Optional contract periods subsequent to the original Contract Period for a specified duration with previously agreed to terms and conditions. Not to be confused with Extension.

Request for Information (RFI): A general invitation to vendors requesting information for a potential future solicitation. The RFI is typically used as a research and information gathering tool for preparation of a solicitation.

Request for Proposal (RFP): A written solicitation utilized for obtaining competitive offers.

Responsible Bidder: A bidder who has the capability in all respects to perform fully and lawfully all requirements with integrity and reliability to assure good faith performance.

Responsive Bidder: A bidder who has submitted a bid which conforms to all requirements of the solicitation document.

Regional State Committee (RSC): A committee of the Southwest Power Pool, consisting of a designated voting member from each state regulatory agency with primary jurisdiction over electric utilities in states where qualifying transmission-owning members of the SPP are located.

Shall/Will/Must: An order/command; mandatory.

Should: Expected; suggested, but not necessarily mandatory.

Software License: Legal instrument with or without printed material that governs the use or redistribution of licensed software.

Sole Source – Commodity: When an item is available from only one source due to the unique nature of the requirement, its supplier, or market conditions.

Sole Source – Services: A service of such a unique nature that the vendor selected is clearly and justifiably the only practical source to provide the service. Determination that the vendor selected is justifiably the sole source is based on either the uniqueness of the service or sole availability at the location required.

Specifications: The detailed statement, especially of the measurements, quality, materials, and functional characteristics, or other items to be provided under a contract.

System (see Module): Any collection or aggregation of two (2) or more Modules that is designed to function, or is represented by the Contractor as functioning or being capable of functioning, as an entity.

Southwest Power Pool (SPP): A multi-state regional transmission organization in which certain Nebraska electric utilities are members.

Termination: Occurs when either party, pursuant to a power created by agreement or law, puts an end to the contract prior to the stated expiration date. All obligations which are still executory on both sides are discharged but any right based on prior breach or performance survives.

Trade Secret: Information, including, but not limited to, a drawing, formula, pattern, compilation, program, device, method, technique, code, or process that (a) derives independent economic value, actual or potential, from not being known to, and not being ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use; and (b) is the subject of efforts that are reasonable under the circumstances to maintain its secrecy (see Neb. Rev. Stat. § 87-502(4)).

Trademark: A word, phrase, logo, or other graphic symbol used by a manufacturer or vendor to distinguish its product from those of others, registered with the U.S. Patent and Trademark Office.

Upgrade: Any change that improves or alters the basic function of a product of service.

Vendor: An individual or entity lawfully conducting business in the State of Nebraska, or licensed to do so, who seeks to provide goods or services under the terms of a written solicitation.

Vendor Performance Report: A report issued to the Contractor by State Purchasing Bureau when products or services delivered or performed fail to meet the terms of the purchase order, contract, and/or specifications, as reported to State Purchasing Bureau by the agency. The State Purchasing Bureau shall contact the Contractor regarding any such report. The vendor performance report will become a part of the permanent record for the Contractor. The State may require vendor to cure. Two such reports may be cause for immediate termination.

Will: See Shall/Will/Must.

Work Day: See Business Day.

I. SCOPE OF THE REQUEST FOR PROPOSAL

The State of Nebraska, Administrative Services (AS), Materiel Division, State Purchasing Bureau (hereafter known as State Purchasing Bureau), is issuing this Request for Proposal, RFP Number 5145Z1 for the purpose of selecting a qualified Contractor to provide SPP Consulting. Any resulting contract is not an exclusive contract to furnish the services provided for in this Request for Proposal, and does not preclude the purchase of similar services from other sources.

A contract resulting from this Request for Proposal will be issued for a period of approximately six (6) months from the date of award and ending on June 30, 2016. The contract has the option to be renewed for five (5) additional one (1) year periods as mutually agreed upon by all parties. The State reserves the right to extend the period of this contract beyond the termination date when mutually agreeable to the Contractor and the State of Nebraska.

B. GENERAL INFORMATION

The Request for Proposal is designed to solicit proposals from qualified vendors who will be responsible for providing SPP Consulting at a competitive and reasonable cost. Proposals that do not conform to the mandatory items as indicated in the Request for Proposal will not be considered.

Proposals shall conform to all instructions, conditions, and requirements included in the Request for Proposal. Prospective bidders are expected to carefully examine all documentation, schedules, and requirements stipulated in this Request for Proposal, and respond to each requirement in the format prescribed.

A fixed-price contract will be awarded as a result of this proposal. In addition to the provisions of this Request for Proposal and the awarded proposal, which shall be incorporated by reference in the contract, any additional clauses or provisions required by the terms and conditions will be included as an amendment to the contract.

C. CUSTOMER SERVICE

In addition to any specified service requirements contained in this agreement, the Contractor agrees and understands that satisfactory customer service is required. Contractor, its employees, Sub-Contractors, and agents must be accountable, responsive, reliable, patient, and have well-developed communication skills.

D. COMMUNICATION WITH STATE STAFF AND EVALUATORS

From the date the Request for Proposal is issued until a determination is announced regarding the selection of the Contractor, contact regarding this project between potential Contractors and individuals employed by the State is restricted to only written communication with the staff designated above as the point of contact for this Request for Proposal. Bidders shall not have any communication with, or attempt to communicate with or influence in any way, any evaluator involved in this RFP.

Once a Contractor is preliminarily selected, as documented in the intent to contract, that Contractor is restricted from communicating with State staff until a contract is signed. Violation of this condition may be considered sufficient cause to reject a Contractor's proposal and/or selection irrespective of any other condition.

The following exceptions to these restrictions are permitted:

1. written communication with the person(s) designated as the point(s) of contact for this Request for Proposal or procurement;
2. contacts made pursuant to any pre-existing contracts or obligations; and
3. State-requested presentations, key personnel interviews, clarification sessions or discussions to finalize a contract.

Violations of these conditions may be considered sufficient cause to reject a bidder's proposal and/or selection irrespective of any other condition. No individual member of the State, employee of the State, or member of the Evaluation Committee is empowered to make binding statements regarding this Request for Proposal. The buyer will issue any clarifications or opinions regarding this Request for Proposal in writing.

E. WRITTEN QUESTIONS AND ANSWERS

Any explanation desired by a bidder regarding the meaning or interpretation of any Request for Proposal provision must be submitted in writing to the State Purchasing Bureau and clearly marked "RFP Number 5145Z1; SPP Consulting Questions". It is recommended that Bidders submit questions sequentially numbered, include the RFP reference and page number using the following format.

F. ORAL INTERVIEWS/PRESENTATIONS AND/OR DEMONSTRATIONS

The Evaluation Committee(s) may conclude after the completion of the Technical and Cost Proposal evaluation that oral interviews/presentations and/or demonstrations are required in order to determine the successful bidder. All bidders may not have an opportunity to interview/present and/or give demonstrations; the State reserves the right to select only the top scoring bidders to present/give oral interviews in its sole discretion. The scores from the oral interviews/presentations and/or demonstrations will be added to the scores from the Technical and Cost Proposals. The presentation process will allow the bidders to demonstrate their proposal offering, explaining and/or clarifying any unusual or significant elements related to their proposals. Bidders' key personnel may be requested to participate in a structured interview to determine their understanding of the requirements of this proposal, their authority and reporting relationships within their firm, and their management style and philosophy. Bidders shall not be allowed to alter or amend their proposals. Only representatives of the State and the presenting bidders will be permitted to attend the oral interviews/presentations and/or demonstrations.

Once the oral interviews/presentations and/or demonstrations have been completed the State reserves the right to make a contract award without any further discussion with the bidders regarding the proposals received.

Detailed notes of oral interviews/presentations and/or demonstrations may be recorded and supplemental information (such as briefing charts, et cetera) may be accepted; however, such supplemental information shall not be considered an amendment to a bidders' proposal. Additional written information gathered in this manner shall not constitute replacement of proposal contents.

Any cost incidental to the oral interviews/presentations and/or demonstrations shall be borne entirely by the bidder and will not be compensated by the State.

G. SUBMISSION OF PROPOSALS

The following describes the requirements related to proposal submission, proposal handling, and review by the State.

To facilitate the proposal evaluation process, one (1) original of the entire proposal should be submitted. Proposals must be submitted by the proposal due date and time. **A separate sheet must be provided that clearly states which sections have been submitted as proprietary or have copyrighted materials.** All proprietary information the bidder wishes the State to withhold must be submitted in accordance with the instructions outlined in Section III, Proprietary Information. Proposal responses should include the completed Form A, Bidder Contact Sheet. Proposals must reference the Request for Proposal number and be sent to the specified address. Please note that the address label should appear as specified in Section II part A on the face of each container or bidder's bid response packet. Rejected late proposals will be returned to the bidder unopened, if requested, at bidder's expense. If a recipient phone number is required for delivery purposes, 402-471-6500 should be used. The Request for Proposal number must be included in all correspondence.

Emphasis should be concentrated on conformance to the Request for Proposal instructions, responsiveness to requirements, completeness, and clarity of content. If the bidder's proposal is presented in such a fashion that makes evaluation difficult or overly time consuming, it is likely that the proposal will be rejected.

IMPORTANT NOTICE: Pursuant to Neb. Rev. Stat. § 84-602.02, all State contracts in effect as of January 1, 2014 will be posted to a public website beginning July 1, 2014. All information not specifically excluded by State Law **WILL BE POSTED FOR PUBLIC VIEWING**.

The Technical and Cost Proposals should be presented in separate sections (loose-leaf binders are preferred) on standard 8 ½" x 11" paper, except that charts, diagrams and the like may be on fold-outs which, when folded, fit into the 8 ½" by 11" format. Pages may be consecutively numbered for the entire proposal, or may be numbered consecutively within sections. Figures and tables must be numbered consecutively within sections. Figures and tables must be numbered and referenced in the text by that number. They should be placed as close as possible to the referencing text.

H. PROPOSAL OPENING

The sealed proposals will be publicly opened and the bidding entities announced on the date, time, and location shown in the Schedule of Events. Proposals will be available for viewing by those present at the proposal opening. Vendors may also contact the State to schedule an appointment for viewing proposals after the Intent to Award has been posted to the website.

I. LATE PROPOSALS

Proposals received after the time and date of the proposal opening will be considered late proposals. Rejected late proposals will be returned to the bidder unopened, if requested, at bidder's expense. The State is not responsible for proposals that are late or lost due to mail service inadequacies, traffic, or any other reason(s). Bidders are encouraged to contact the State Purchasing Bureau, prior to the scheduled opening date and time, to ensure that the proposal response was received.

J. REJECTION OF PROPOSALS

The State reserves the right to reject any or all proposals, wholly or in part, or to award to multiple bidders in whole or in part. The State reserves the right to waive any deviations or errors that are not material, do not invalidate the legitimacy of the proposal and do not improve the bidder's competitive position. All awards will be made in a manner deemed in the best interest of the State.

K. EVALUATION OF PROPOSALS

All responses to this Request for Proposal which fulfill all mandatory requirements will be evaluated. Each category will have a maximum possible point potential. The State will conduct a fair, impartial, and comprehensive evaluation of all proposals in accordance with the criteria set forth below. The State may elect to use a third-party to conduct credit checks as part of the corporate overview evaluation. Areas that will be addressed and scored during the evaluation include:

1. Corporate Overview shall include but is not limited to:
 - a. the ability, capacity, qualifications and skill of the bidder to deliver and implement the system or project that meets the requirements of the Request for Proposal;
 - b. the character, integrity, reputation, judgment, experience, and efficiency of the bidder;
 - c. whether the bidder can perform the contract within the specified time frame;
 - d. the quality of bidder performance on prior contracts;
 - e. such other information that may be secured and that has a bearing on the decision to award the contract;
2. Technical Approach; and
3. Cost Proposal.

Neb. Rev. Stat. § 73-107 allows for a preference for a resident disabled veteran or business located in a designated enterprise zone. When a State contract is to be awarded to the lowest responsible bidder, a resident disabled veteran or a business located in a designated enterprise zone under the Enterprise Zone Act shall be allowed a preference over any other resident or nonresident bidder, if all other factors are equal.

Resident disabled veterans means any person (a) who resides in the State of Nebraska, who served in the United States Armed Forces, including any reserve component or the National Guard, who was discharged or otherwise separated with a characterization of honorable or general (under honorable conditions), and who possesses a disability rating letter issued by the United States Department of Veterans Affairs establishing a service-connected disability or a disability determination from the United States Department of Defense and (b)(i) who owns and controls a business or, in the case of a publicly owned business, more than fifty percent of the stock is owned by one or more

persons described in subdivision (a) of this subsection and (ii) the management and daily business operations of the business are controlled by one or more persons described in subdivision(a) of this subsection. Any contract entered into without compliance with this section shall be null and void.

Therefore, if a resident disabled veteran or business located in a designated enterprise zone submits a bid in accordance with Neb. Rev. Stat. § 73-107 and has so indicated on the RFP cover page under “Bidder must complete the following” requesting priority/preference to be considered in the award of this contract, the following will need to be submitted by the vendor within ten (10) business days of request:

- a. Documentation from the United States Armed Forces confirming service;
- b. Documentation of discharge or otherwise separated characterization of honorable or general (under honorable conditions);
- c. Disability rating letter issued by the United States Department of Veterans Affairs establishing a service-connected disability or a disability determination from the United States Department of Defense; and
- d. Documentation which shows ownership and control of a business or, in the case of a publicly owned business, more than fifty percent of the stock is owned by one or more persons described in subdivision (a) of this subsection; and the management and daily business operations of the business are controlled by one or more persons described in subdivision (a) of this subsection.

Failure to submit the requested documentation within ten (10) business days of notice will disqualify the bidder from consideration of the preference.

Evaluation criteria will become public information at the time of the Request for Proposal opening. Evaluation criteria and a list of respondents will be posted to the State Purchasing Bureau website at <http://das.nebraska.gov/materiel/purchasing.html> Evaluation criteria will not be released prior to the proposal opening.

L. EVALUATION COMMITTEE

Proposals will be independently evaluated by members of the Evaluation Committee(s). The Evaluation Committee(s) will consist of NPRB staff and Board members with the appropriate expertise to conduct such proposal evaluations. Names of the members of the Evaluation Committee(s) will not be published.

Prior to award, bidders are advised that only the point of contact indicated on the front cover of this Request for Proposal For Contractual Services Form can clarify issues or render any opinion regarding this Request for Proposal. No individual member of the State, employee of the State, or member of the Evaluation Committee(s) is empowered to make binding statements regarding this Request for Proposal.

Any contact, or attempted contact, with an evaluator that is involved with this RFP may result in the rejection of this proposal and further administrative actions may be taken.

M. MANDATORY REQUIREMENTS

The proposals will first be examined to determine if all mandatory requirements listed below have been addressed to warrant further evaluation. Proposals not meeting mandatory requirements will be excluded from further evaluation. The mandatory requirement items are as follows:

1. Request for Proposal For Contractual Services form, signed in ink;
2. Corporate Overview;
3. Technical Approach; and
4. Cost Proposal.

N. REFERENCE CHECKS

The State reserves the right to check any reference(s), regardless of the source of the reference information, including but not limited to, those that are identified by the bidder in the proposal, those indicated through the explicitly specified contacts, those that are identified during the review of the proposal, or those that result from communication with other entities involved with similar projects. The State may use a third-party to conduct reference checks.

Information to be requested and evaluated from references may include, but is not limited to, some or all of the following: financial stability of the company, project description and background, job performed, functional and technical abilities, communication skills and timeliness, cost and schedule estimates and accuracy, problems (poor quality deliverables, contract disputes, work stoppages, et cetera), overall performance, and whether or not the reference would rehire the firm or individual. Only top scoring bidders may receive reference checks, and negative references may eliminate bidders from consideration for award.

O. SECRETARY OF STATE/TAX COMMISSIONER REGISTRATION REQUIREMENTS

All bidders should be authorized to transact business in the State of Nebraska. All bidders are expected to comply with all Nebraska Secretary of State Registration requirements. It is the responsibility of the bidder to comply with any registration requirements pertaining to types of business entities (e.g. person, partnership, foreign or domestic limited liability company, association, or foreign or domestic corporation or other type of business entity). The bidder who is the recipient of an Intent to Award will be required to certify that it has so complied and produce a true and exact copy of its current (within ninety (90) calendar days), valid Certificate of Good Standing or Letter of Good Standing; or in the case of a sole proprietorship, provide written documentation of sole proprietorship. This must be accomplished prior to the award of the contract. Further, all bidders shall comply with any and all other applicable Nebraska statutes regarding transacting business in the State of Nebraska. Bidders should submit the above certification(s) with their bid.

P. VIOLATION OF TERMS AND CONDITIONS

Violation of the terms and conditions contained in this Request for Proposal or any resultant contract, at any time before or after the award, shall be grounds for action by the State which may include, but is not limited to, the following:

1. Rejection of a bidder's proposal;
2. Suspension of the bidder from further bidding with the State for the period of time relative to the seriousness of the violation, such period to be within the sole discretion of the State.

III. TERMS AND CONDITIONS

By signing the “Request for Proposal for Contractual Services” form, the bidder guarantees compliance with the provisions stated in this Request for Proposal, agrees to the Terms and Conditions unless otherwise agreed to, and certifies bidder maintains a drug free work place environment.

Bidders are expected to closely read the Terms and Conditions and provide a binding signature of intent to comply with the Terms and Conditions; provided, however, a bidder may indicate any exceptions to the Terms and Conditions by (1) clearly identifying the term or condition by subsection, and (2) including an explanation for the bidder’s inability to comply with such term or condition which includes a statement recommending terms and conditions the bidder would find acceptable. Rejection in whole or in part of the Terms and Conditions may be cause for rejection of a bidder’s proposal. Bidders must include completed Section III with their proposal response.

IV. PROJECT DESCRIPTION AND SCOPE OF WORK

The bidder should provide the following information in response to the Request for Proposal.

A. PROJECT OVERVIEW

The Nebraska Power Review Board (NPRB) is seeking the services of a person, persons, or firm to assist the NPRB in representing the interests of the NPRB, the State of Nebraska, and ultimately Nebraska's electric ratepayers in matters pertaining to electric transmission issues before the Southwest Power Pool (SPP), and in particular the SPP's Regional State Committee (RSC) and its subsidiary committees and task forces such as the Cost Allocation Working Group (CAWG). The contractor will act as the NPRB's voting representative on the SPP RSC's CAWG and represent the NPRB on other working groups and task forces created by or placed under the direction of the RSC and/or CAWG, act as the advisor to the NPRB's designated voting representative on the SPP's RSC, to coordinate activities with Nebraska's electric utilities and specifically with those utilities that are transmission-owning members of the SPP, and keep the NPRB apprised of SPP, RSC, CAWG and related activities.

The three largest electric utilities in the State of Nebraska (i.e., Lincoln Electric System, Nebraska Public Power District and Omaha Public Power District) joined the SPP as transmission owning members in 2009. The SPP is a regional transmission organization approved by the Federal Energy Regulatory Commission that operates in the states of Arkansas, Kansas, Louisiana, Missouri, Nebraska, New Mexico, Oklahoma and Texas. The SPP's operating area may in the near future expand to include members in the states of Iowa, Montana, North Dakota and South Dakota.

One group formed as part of the SPP is the Regional State Committee (RSC). The RSC is comprised of one designated commissioner or board member from each state regulatory agency having jurisdiction over an SPP member. Due to the Nebraska utilities' membership, the NPRB was entitled to designate one of its Board members to be the NPRB's voting representative on the RSC. According to the SPP bylaws, the RSC has primary responsibility for determining regional proposals and the transition process in the following areas: 1) whether and to what extent participant funding will be used for transmission enhancements; 2) whether the license plate or postage stamp rates will be used for the regional access charge; 3) Financial Transmission Rights (FTR) allocation, where a locational price methodology is used; and 4) the transition mechanism to be used to assure that existing firm customers receive FTRs equivalent to the customers' existing firm rights. The RSC also determines the approach for resource adequacy across the entire SPP region, and the RSC determines whether transmission upgrades for remote resources will be included in the regional transmission planning process and the role of transmission owners in proposing transmission upgrades in the regional planning process. A copy of the SPP bylaws creating the RSC is available on the SPP's website at <http://www.spp.org/publications/RSCBylaws042709-f.pdf>. Prior to each meeting, the RSC provides background materials for the RSC members to review. The RSC holds face-to-face meetings at least quarterly in various locations within the SPP's operating area. Recently the RSC has been holding meetings monthly, with quarterly meetings held in person and the remaining meetings via conference call. Occasionally the RSC holds special meetings or educational "retreats" in addition to its regularly scheduled meetings.

The RSC has committees and working groups that study information, conduct research, devise plans, and provide recommendations and proposals to the RSC regarding how to proceed on topics within the RSC's jurisdiction. To address specific issues the RSC

sometimes forms working groups or task forces that operate for a limited duration, normally three to twelve months. Some committees and working groups operate on a permanent basis. The NPRB is entitled to have staff members participate in some or all of these committees and working groups. One permanent group is the Cost Allocation Working Group (CAWG). Examples of issues the CAWG has worked on in the past or plans to work on in the near future include:

1. Implementation and operation of the SPP's Integrated Marketplace.
2. Topics related to aggregators of retail customers (ARC).
3. Monitoring and analysis of cost allocation issues.
4. Assist in preparing an annual Aggregate Study Safe Harbor Report.
5. Input in planning transmission routing.
6. Evaluation and reporting on Integrated Transmission Planning and seams progress.
7. Monitoring and reporting on the activities of the Federal Energy Regulatory Commission, Eastern Interconnection Planning Collaborative, Eastern Interconnection State's Planning Council, Electric Power Research Institute, and other similar organizations.

The CAWG meets at the discretion of its voting members and the consultant(s) retained by the SPP to coordinate its activities. It has normally met once or twice each month, with the opportunity to participate via telephonic conference call for most meetings. Each state regulatory agency in the RSC is entitled to have one staff member designated to represent it as a voting member on the CAWG. Other stakeholders in the electric industry participate in the discussions at CAWG meetings. LES, NPPD and OPPD each have non-voting representatives that participate in the CAWG meetings. Prior to each meeting, background materials are provided to the CAWG members and non-voting participants to review. In-person meetings of the CAWG are often held in Dallas, Texas, but can be held at various locations in the SPP operating area.

Other SPP groups deal with issues relating closely to topics over which the RSC or the CAWG have direct responsibility. In such instances, the contractor will need to monitor the activities of those groups during the time the applicable issue is involved. These other groups include the Economic Studies Working Group, the Long-Term Congestion Rights Task Force, the Rate Impact Task Force, the Regional Allocation Review Task Force, the Project Cost Working Group, the Transmission Planning Improvement Task Force and the Strategic Planning Committee.

The NPRB does not have adequate staff or the necessary expertise to monitor and participate in the activities of the RSC, CAWG and other related SPP groups in order to represent Nebraska's interests. This is particularly true with regard to the CAWG. The NPRB also requires a person or firm with experience in transmission issues and engineering or related experience in order to adequately represent Nebraska's interests as a participant in these SPP groups. The Board does not currently have staff with these qualifications, necessitating the hiring of a person or firm with the appropriate education and experience to attend the RSC and CAWG meetings, review background documents, brief the NPRB's designated voting member on the RSC, and serve as Nebraska's representative on the CAWG.

B. PROJECT ENVIRONMENT

Bidder should have experience in planning and designing transmission lines. It is preferable, but not mandatory, that the bidder have practical experience as an engineer responsible for planning, designing, and analyzing the costs involved with bulk transmission

lines. Excellent organizational and communication skills are essential. A thorough understanding of Nebraska's consumer-owned electric industry and electric transmission needs is strongly preferred, but is not mandatory. The contractor must be willing and able to travel to meetings in various locations in the SPP region, either by air or vehicle, depending on the distance involved.

Any entity that is subject to assessments necessary to defray the NPRB's expenses as set out in Neb. Rev. Stat. § 70-1020, or any other entity that is otherwise subject to the NPRB's jurisdiction due to having filed an application that requires the NPRB's approval for generation or transmission facilities, is not eligible to apply for this contract due to the potential conflict of interest it would create.

C. PROJECT REQUIREMENTS

The contractor will not be responsible for authorized travel expenditures to attend SPP-related meetings. The SPP reimburses travel expenditures authorized by the State's RSC member for that State to send representatives to the meetings of the RSC, CAWG, SPP Board of Directors, and other related working groups and task forces as needed. As an authorized representative of the NPRB at those meetings, the contractor will be reimbursed for travel expenditures by the SPP. If for some reason the SPP cannot or will not reimburse the NPRB's authorized representative, the NPRB will reimburse the representative for said authorized travel expenses pursuant to the policies in the State of Nebraska State Accounting Manual (<http://das.nebraska.gov/accounting/nis/am005.htm>). The Applicant will prepare and submit travel reimbursement documents directly to the SPP, with approval required by the NPRB's designated RSC member. NPRB staff will assist in this process whenever necessary. The NPRB will expect its contractor to follow expenditure limits established by the SPP. In the absence of expenditure limits set by the SPP, the contractor will be expected to abide by reimbursement guidelines established by the Internal Revenue Service for hotel, meals, and mileage expenses.

The SPP and RSC reimburse state agencies for travel expenses of necessary staff to attend SPP-related functions. The NPRB's contractor is treated, for membership and reimbursement purposes at SPP functions, as a staff member of the NPRB (even though the contractor is actually an independent contractor with the State of Nebraska). Therefore, the contractor's reimbursement for travel to attend any SPP-related meeting will necessarily be limited to that amount that would have been incurred if travel originated from the NPRB's headquarters or the nearby vicinity. The NPRB's headquarters is located in Lincoln, Nebraska. This does not preclude travel costs incurred to fly out of an alternate airport, such as the Omaha airport (Epply Airfield), if the cost and availability of flights justify it. The contractor will receive prior approval from the NPRB's RSC member or the NPRB's executive director for travel plans that involve reimbursement and the departure point will be from a location other than Lincoln, Nebraska. The RSC voting member or the Board's executive director may give the contractor standing approval to fly out of another airport, such as the Omaha airport.

The contractor will not be reimbursed for travel expenses necessary to meet with the NPRB's executive director, RSC representative, or the NPRB. Likewise, the contractor will not be reimbursed for travel expenses necessary to attend Board meetings of the NPA, LES, NPPD or OPPD.

Contractor will be responsible for incidental expenses, such as office supplies, etc. Contractor must have the ability to communicate regularly through the use of e-mail and telephone. Contractor must have a telephone with speakerphone capability, so that NPRB staff and/or

Board members could participate in CAWG and other related meetings via conference calls with the Contractor, if necessary. It is strongly preferred that contractor own a laptop computer, with internet access capability, for use when attending SPP related meetings. SPP staff normally coordinates the use of wi-fi connections during SPP meetings.

D. SCOPE OF WORK

The Contractor will be designated as the NPRB's representative on the CAWG. Contractor will attend all CAWG meetings, in person, unless otherwise directed or authorized by the NPRB's designated RSC member or the NPRB's Executive Director to attend via conference call. Contractor will also attend all meetings of and monitor the activities of the SPP Board of Directors, RSC, CAWG, and Markets and Operations Policy Committee (MOPC). It will likely be necessary for the contractor to also monitor activities of the task forces and working groups formed under the aforementioned SPP Board of Directors, RSC, CAWG and MOPC in order to follow and understand all activities at SPP. These groups include the Economic Studies Working Group, the Long-Term Congestion Rights Task Force, the Rate Impact Task Force, the Regional Allocation Review Task Force, the Project Cost Working Group, the Transmission Planning Improvement Task Force and the Strategic Planning Committee. Not all these groups meet on a regular basis. Some meet on an as-needed basis. Contractor may need to attend meetings of these groups when they work on topics pertinent to the CAWG, RSC, or projects or topics affecting or important to the NPRB or Nebraska. Contractor will likely be able to participate in many of the additional working group and task force meetings via conference call or web conference.

Contractor will be responsible, at a minimum, to review and analyze background and preparatory documents for the SPP Board of Directors, RSC and CAWG meetings; brief the NPRB's designated RSC member prior to each RSC meeting; conduct a conference call with the NPRB's RSC voting member and representatives of Nebraska's utilities that are transmission-owning members of SPP prior to each SPP RSC meeting to discuss the NPRB's position on voting items and brief the NPRB voting member on discussion items; occasionally update the entire NPRB and/or the NPRB's executive director on SPP activities; attend all meetings of the RSC and CAWG, and all meetings of the SPP Board of Directors, unless otherwise directed or authorized by the NPRB's designated RSC member or the NPRB's Executive Director; prepare a monthly report showing the hours worked by each employee attributable to each SPP committee, task force, or working group. Contractor will also attend meetings of the Rate Impact Task Force (RITF) if requested by the NPRB's RSC representative; monitor the activities of the Economic Studies Working Group, the Long-Term Congestion Rights Task Force, the Rate Impact Task Force, the Regional Allocation Review Task Force, the Project Cost Working Group, the Transmission Planning Improvement Task Force and the Strategic Planning Committee, and attend meetings of these groups when they work on issues affecting or important to the NPRB or Nebraska's electric ratepayers.

Contractor should expect to attend an average of two in-person meetings of these additional groups per month, and participate in an average of two more meetings per month via conference call or web conference. Contractor will attend RSC meetings with the NPRB's designated voting member as his or her advisor. Contractor will coordinate closely with representatives from LES, NPPD, and OPPD, and any other Nebraska utility that might join the SPP as a transmission-owning member, when formulating the position to be taken by the NPRB on behalf of the State of Nebraska in matters before the SPP, RSC, and related groups and organizations. Contractor may be asked to occasionally meet with and brief the governing body of Nebraska utilities that are SPP members, or the Nebraska Power Association (NPA) Board of Directors (the NPA is a voluntary association comprised of representatives from all

sectors of Nebraska's electric industry), concerning NPRB activities and positions on SPP issues. Absent an unusual amount of SPP activity or sensitive issues pertaining to Nebraska, it is anticipated contractor would only rarely be asked to attend meetings or give briefings to utility governing bodies or the NPA, likely no more often than quarterly. In recent years the contractor has only attended NPA meetings once per year, and has not briefed individual utility governing bodies in the past two to three years. The NPA normally meets every other month, on the third Wednesday of the month, in Lincoln, Nebraska.

The quarterly in-person meetings of the SPP RSC and Board of Directors are normally, but not always, held in conjunction with one another. The contractor will be expected to attend meetings in person, unless otherwise directed or authorized by the NPRB's designated RSC member or the NPRB's executive director. Contractor will maintain close contact with the NPRB's designated RSC member and executive director, provide updates and advice to them, and receive general policy directions from them when time permits. When time does not permit, contractor will coordinate with the Nebraska utility representatives present at the applicable meeting and use his or her judgment to represent Nebraska's best interests. Contractor is expected to use his or her judgment in the event the Nebraska utilities do not have a uniform position on a particular matter. In all cases, contractor will follow the directives of the NPRB's RSC member or the NPRB's executive director when such has been given. The contractor will be expected to , upon request, provide an update or briefing on SPP, RSC and CAWG activities to the NPRB during the NPRB's monthly public meetings. Contractor will not be asked to provide such updates more than four times per year. Past experience has been that such updates are normally requested only annually. Unless specifically authorized by the NPRB, contractor will not be reimbursed for travel expenses to attend NPRB meetings or to meet with the NPRB's RSC member or executive director. The contractor will prepare a brief written review (one to three pages) each month of the activities of the SPP, RSC and CAWG, as well as any additional related SPP groups with which contractor has dealt. The review will be disseminated to interested parties via e-mail, although contractor may choose to also send copies through the mail. For accounting purposes contractor will also provide the NPRB with an invoice each month for payment for services rendered during the preceding month.

The NPRB estimates that the workload will require the Contractor to spend approximately an average of 60 to 120 hours per month on activities related to this contract, not including travel time. It is expected that some months could be higher than this, while some months could be lower, depending on the level of SPP activities during a given month. The contractor will be expected to travel to attend all in-person meetings of the CAWG and RSC, and attend all or most meetings of the SPP Board of Directors, unless otherwise directed or authorized by the NPRB's designated RSC member or the NPRB's Executive Director. These trips will often require one or two overnight stays in another state, depending on scheduling and availability of flights. The SPP's current practice is to hold the RSC meeting on a Monday afternoon, followed by the SPP Board of Directors meeting the next day (Tuesday) at the same venue. Other task forces or working groups, such as the CAWG or MOPC, may occasionally be held on the Wednesday following the SPP Board of Directors meeting.

The State may request the Contractor perform other consulting services in regards to the NPRB in representing the interests of the NPRB, the State of Nebraska, and Nebraska's electric ratepayers in matters pertaining to electric transmission issues.

E. TECHNICAL CONSIDERATIONS

Bidders are to provide a statement in their bids describing how they or their firm would bring specific value to the relationship, and how they could develop and implement cost-saving measures.

The bidder should have experience, training, and/or education demonstrating a knowledge and understanding of electrical energy issues, specifically the development and planning of transmission infrastructure, transmission grid systems, and the recovery of costs for such transmission facilities. Bidder will need to provide a resume demonstrating his or her applicable experience, training, and/or education. If bidder is a firm or group of individuals, a resume must be submitted for all principals involved, particularly for the individual that would be designated as the NPRB's representative on the CAWG, as well as the individual(s) that would attend the SPP Board of Directors and RSC meetings with the NPRB's Board member (if different from the CAWG representative) and attend any meetings of the NPA or Nebraska SPP member utility governing bodies. It is preferable, but not mandatory, that the individual acting as the NPRB's representative on the CAWG be the same person that will act as the advisor to the NPRB's RSC member and attend SPP RSC and Board of Directors meetings with the NPRB's member or his or her proxy.

Bidders must present their understanding of the work that will be performed and the scope of work. Bidders shall summarize why they are best qualified to perform the work required herein.

F. DELIVERABLES

SPP Consulting Services per section IV. Project Description and Scope of Work as identified within the RFP and as identified on the cost sheet.

V. PROPOSAL INSTRUCTIONS

This section documents the mandatory requirements that must be met by bidders in preparing the Technical and Cost Proposal. Bidders should identify the subdivisions of "Project Description and Scope of Work" clearly in their proposals; failure to do so may result in disqualification. Failure to respond to a specific requirement may be the basis for elimination from consideration during the State's comparative evaluation.

Proposals are due by the date and time shown in the Schedule of Events. Content requirements for the Technical and Cost Proposal are presented separately in the following subdivisions; format and order:

A. TECHNICAL PROPOSAL SUBMISSION

The Technical Proposal shall consist of three (3) sections:

1. REQUEST FOR PROPOSAL FORM

By signing the "Request for Proposal for Contractual Services" form, the bidder guarantees compliance with the provisions stated in this Request for Proposal, agrees to the Terms and Conditions stated in this Request for Proposal unless otherwise agreed to, and certifies bidder maintains a drug free work place environment.

The Request for Proposal for Contractual Services form must be signed in ink and returned by the stated date and time in order to be considered for an award.

Further, Section III. Terms and Conditions must be returned with the proposal response.

2. CORPORATE OVERVIEW

The Corporate Overview section of the Technical Proposal must consist of the following subdivisions:

a. BIDDER IDENTIFICATION AND INFORMATION

The bidder must provide the full company or corporate name, or if none, the full name of the individual bidder(s), address of the company's headquarters or the individual's office address, the entity's organization structure (corporation, partnership, proprietorship), state in which the bidder is incorporated or otherwise organized to do business, year in which the bidder first organized to do business and whether the name and form of organization has changed since first organized. Do not include the entity's Federal Employer Identification Number or any individual's Social Security Number with the bid. This information will be obtained from the successful bidder after the Letter of Intent to Contract has been issued.

b. FINANCIAL STATEMENTS

The bidder must provide financial statements applicable to the firm. If publicly held, the bidder must provide a copy of the corporation's most recent audited financial reports and statements, and the name, address, and telephone number of the fiscally responsible representative of the bidder's financial or banking organization.

If the bidder is not a publicly held corporation, either the reports and statements required of a publicly held corporation, or a description of the organization, including size, longevity, client base, areas of specialization and expertise, and any other pertinent information, must be submitted in such a manner that proposal evaluators may reasonably formulate a determination about the stability and financial strength of the organization. Additionally, a non-publicly held firm must provide a banking reference.

The bidder must disclose any and all judgments, pending or expected litigation, or other real or potential financial reversals, which might materially affect the viability or stability of the organization, or state that no such condition is known to exist.

The State may elect to use a third-party to conduct credit checks as part of the corporate overview evaluation.

c. CHANGE OF OWNERSHIP

If any change in ownership or control of the company is anticipated during the twelve (12) months following the proposal due date, the bidder must describe the circumstances of such change and indicate when the change will likely occur. Any change of ownership to an awarded vendor(s) will require notification to the State.

d. OFFICE LOCATION

The bidder's office location responsible for performance pursuant to an award of a contract with the State of Nebraska must be identified.

e. RELATIONSHIPS WITH THE STATE

The bidder shall describe any dealings with the State over the previous two (2) years. If the organization, its predecessor, or any party named in the bidder's proposal response has contracted with the State, the bidder shall identify the contract number(s) and/or any other information available to identify such contract(s). If no such contracts exist, so declare.

If the bidder is an entity subject to assessments necessary to defray the NPRB's expenses as set out in Neb. Rev. Stat. § 70-1020, or any other entity that is otherwise subject to the NPRB's jurisdiction due to having filed an application that requires the NPRB's approval, it shall so state. Entities in this category are not eligible to apply for this contract due to the potential conflict of interest it would create.

f. BIDDER'S EMPLOYEE RELATIONS TO STATE

If any party named in the bidder's proposal response is or was an employee of the State within the past twelve (12) months, identify the individual(s) by name, State agency with whom employed, job title or position held with the State, and separation date. If no such relationship exists or has existed, so declare.

If any employee of any agency of the State of Nebraska is employed by the bidder or is a Sub-Contractor to the bidder, as of the due date for proposal submission, identify all such persons by name, position held with the bidder, and position held with the State (including job title and agency). Describe the

responsibilities of such persons within the proposing organization. If, after review of this information by the State, it is determined that a conflict of interest exists or may exist, the bidder may be disqualified from further consideration in this proposal. If no such relationship exists, so declare.

g. CONTRACT PERFORMANCE

If the bidder or any proposed Sub-Contractor has had a contract terminated for default during the past five (5) years, all such instances must be described as required below. Termination for default is defined as a notice to stop performance delivery due to the bidder's non-performance or poor performance, and the issue was either not litigated due to inaction on the part of the bidder or litigated and such litigation determined the bidder to be in default.

It is mandatory that the bidder submit full details of all termination for default experienced during the past five (5) years, including the other party's name, address, and telephone number. The response to this section must present the bidder's position on the matter. The State will evaluate the facts and will score the bidder's proposal accordingly. If no such termination for default has been experienced by the bidder in the past five (5) years, so declare.

If at any time during the past five (5) years, the bidder has had a contract terminated for convenience, non-performance, non-allocation of funds, or any other reason, describe fully all circumstances surrounding such termination, including the name and address of the other contracting party.

h. SUMMARY OF BIDDER'S CORPORATE EXPERIENCE

The bidder shall provide a summary matrix listing the bidder's previous projects similar to this Request for Proposal in size, scope, and complexity. The State will use no more than three (3) narrative project descriptions submitted by the bidder during its evaluation of the proposal.

The bidder must address the following:

- i. Provide narrative descriptions to highlight the similarities between the bidder's experience and this Request for Proposal. These descriptions must include:
 - a) The time period of the project;
 - b) The scheduled and actual completion dates (if applicable);
 - c) The Contractor's responsibilities;
 - d) For reference purposes, a customer name (including the name of a contact person, a current telephone number, a facsimile number, and e-mail address); and
 - e) Each project description shall identify whether the work was performed as the prime Contractor or as a Sub-Contractor. If a bidder performed as the prime Contractor, the description must provide the originally scheduled completion date and budget, as well as the actual (or currently planned) completion date and actual (or currently planned) budget.

- ii. Contractor and Sub-Contractor(s) experience must be listed separately. Narrative descriptions submitted for Sub-Contractors must be specifically identified as Sub-Contractor projects.
- iii. If the work was performed as a Sub-Contractor, the narrative description shall identify the same information as requested for the Contractors above. In addition, Sub-Contractors shall identify what share of contract costs, project responsibilities, and time period were performed as a Sub-Contractor.

i. SUMMARY OF BIDDER'S PROPOSED PERSONNEL/MANAGEMENT APPROACH

The bidder must present a detailed description of its proposed approach to the management of the project.

The bidder must identify the specific professionals who will work on the State's project if they or their company is awarded the contract resulting from this Request for Proposal. The names and titles of the team proposed for assignment to the State project shall be identified in full, with a description of the team leadership, interface and support functions, and reporting relationships. The primary work assigned to each person should also be identified. If a team of individuals will be involved, bidder must designate one of the team members as the lead individual who would be the primary point of contact and would be the person to be designated by the NPRB as the voting member on the Cost Allocation Working Group. Bidder should also describe whether the person to be designated as the CAWG voting member would also attend RSC, SPP Board of Directors and related SPP meetings, or whether another individual(s) would normally attend those meetings.

The bidder shall provide resumes for all personnel proposed by the bidder to work on the project. The State will consider the resumes as a key indicator of the bidder's understanding of the skill mixes required to carry out the requirements of the Request for Proposal in addition to assessing the experience of specific individuals.

Resumes must not be longer than three (3) pages. Resumes shall include, at a minimum, academic background and degrees, professional certifications, understanding of the process, and at least three (3) references (name, address, and telephone number) who can attest to the competence and skill level of the individual(s). Any changes in proposed personnel shall only be implemented after written approval from the State.

j. SUB-CONTRACTORS

If the bidder intends to Sub-Contract any part of its performance hereunder, the bidder must provide:

- i. name, address, and telephone number of the Sub-Contractor(s);
- ii. specific tasks for each Sub-Contractor(s);
- iii. percentage of performance hours intended for each Sub-Contract; and
- iv. total percentage of Sub-Contractor(s) performance hours.

3. TECHNICAL APPROACH

- a. The technical approach section of the Technical Proposal must consist of the following subsections: Understanding of the project requirements and Scope of Work; Identify key staff necessary to conduct the Scope of Work and why those staff members are the best qualified to fulfill the contract's objective;
- b. Identify the specific value the bidder provides to the State;
- c. Identify how the bidder would identify, develop and implement cost-savings measures; and
- d. Deliverables and due dates.

B. COST PROPOSAL REQUIREMENTS

This section describes the requirements to be addressed by bidders in preparing the Cost Proposal. The bidder must submit the Cost Proposal in a section of the proposal that is a separate section or is packaged separately as specified in this RFP from the Technical Proposal section.

The component costs of the fixed price proposal for providing the services set forth in the Request for Proposal must be provided by submitting forms substantially equivalent to those described below.

1. PRICING SUMMARY

This summary shall present the monthly fixed price to perform all of the requirements of the Request for Proposal. The bidder must include details in the Cost Proposal supporting any and all costs. These details must include, at a minimum, detailed descriptions and/or specifications of the goods and/or services to be provided, quantities, and timing and unit costs, if applicable. The monthly fixed price is not to exceed a monthly total of fifteen thousand dollars (\$15,000) for the first two (2) contract periods.

Contractor **must** also provide the State with the hourly rate that contractor would charge for additional work. The hourly rate will not in any way affect the fixed price stated above. The purpose of the hourly rate is to establish the price the State will pay contractor for any additional services performed in regards to the NPRB in representing the interests of the NPRB, the State of Nebraska, and Nebraska's electric ratepayers in matters pertaining to electric transmission issues before the SPP. In the past, the contractor has been asked to perform work described as set out below.

Occasionally issues arise before the SPP for which no committee, working group or task force currently has jurisdiction, or that requires specialized expertise beyond that which is currently on a committee, etc. In such instances the SPP, RSC or SPP committee may create a task force, working group, or study group to research, analyze, and/or formulate opinions on the issues involved and provide advice to the board or committee that formed them. These groups are normally temporary in nature, lasting anywhere from a few weeks to as much as one year. When these issues are expected to impact Nebraska ratepayers, the NPRB or Nebraska's utilities that are SPP members, the NPRB may ask its contractor to participate in such groups. The work would likely consist of participating in conference calls, attending in-person meetings that involve travel outside Nebraska, assist other group members in performing research, drafting written opinions or whitepapers, and/or providing an oral report addressing the issues involved. The members of the group normally decide how

often they meet, whether meetings will be in-person or via conference call, and where in-person meetings would be held.

The State reserves the right to review all aspects of the Cost Proposal for reasonableness and to request clarification of any proposal where the cost component shows significant and unsupported deviation from industry standards or in areas where detailed pricing is required.

2. PRICES

Prices quoted shall be net, including transportation and delivery charges fully prepaid by the bidder, F.O.B. destination named in the Request for Proposal. No additional charges will be allowed for packing, packages, or partial delivery costs. When an arithmetic error has been made in the extended total, the unit price will govern.

C. PAYMENT SCHEDULE

The payment schedule for the project is tied to specific dates and deliverables. Invoices may be submitted by the Contractor on specific dates based on the completion and acceptance of related deliverables. No invoice will be approved unless the associated deliverables have been approved.
