SCOPE OF SERVICE

The State of Nebraska, Administrative Services (AS), Materiel Division, State Purchasing Bureau, is issuing this Request for Proposal, RFP Number 5296 Z1 for the purpose of selecting a qualified Contractor to provide **Maintenance and Service for Chillers**.

Written questions for the first Question and Answer period are due no later than April 26, 2016. Written questions for the second Question and Answer period are due no later than May 12, 2016 and should be submitted via e-mail to as.materiel purchasing@nebraska.gov Written questions may also be sent by facsimile to (402) 471-2089.

Bidder should submit one (1) original of the entire proposal. Proposals must be submitted by the proposal due date and time.

PROPOSALS MUST MEET THE REQUIREMENTS OUTLINED IN THIS REQUEST FOR PROPOSAL TO BE CONSIDERED VALID. PROPOSALS WILL BE REJECTED IF NOT IN COMPLIANCE WITH THESE REQUIREMENTS.

1. Sealed proposals must be received in State Purchasing Bureau by the date and time of proposal opening indicated above. No late proposals will be accepted. No electronic, e-mail, fax, voice, or telephone proposals will be accepted.
2. This form "REQUEST FOR PROPOSAL FOR CONTRACTUAL SERVICES" MUST be manually signed, in ink, and returned by the proposal opening date and time along with bidder's proposal and any other requirements as specified in the Request for Proposal in order for a bidder's proposal to be evaluated.

IMPORTANT NOTICE: Pursuant to Neb. Rev. Stat. § 84-602.02, all State contracts in effect as of January 1, 2014, and all contracts entered into thereafter, will be posted to a public website. Beginning July 1, 2014, all contracts will be posted to a public website managed by the Department of Administrative Services.

In addition, all responses to Requests for Proposals will be posted to the Department of Administrative Services public website. The public posting will include figures, illustrations, photographs, charts, or other supplementary material. Proprietary information identified and marked according to state law is exempt from posting. To exempt proprietary information you must submit a written showing that the release of the information would give an advantage to named business competitor(s) and show that the named business competitor(s) will gain a demonstrated advantage by disclosure of information. The mere assertion that information is proprietary is not sufficient. Failure to agree to the reservation and waiver of protection will result in the response to the RFP being non-conforming and rejected.

I. SCOPE OF THE REQUEST FOR PROPOSAL

The State of Nebraska, Administrative Services (AS), Materiel Division, Purchasing Bureau (hereafter known as State Purchasing Bureau), is issuing this Request for Proposal, RFP Number 5296 Z1 for the purpose of selecting a qualified Contractor to provide **Maintenance and Service for Chillers**. Any resulting contract is not an exclusive contract to furnish the services provided for in this Request for Proposal, and does not preclude the purchase of similar services from other sources.

A contract resulting from this Request for Proposal will be issued approximately for a period of two (2) years effective from the date of award. The contract has the option to renew for three (3) additional two (2) year periods as mutually agreed upon by all parties. The State reserves the right to extend the period of this contract beyond the termination date when mutually agreeable to the Contractor and the State of Nebraska.

II. PROCUREMENT PROCEDURES

A. PROCURING OFFICE AND CONTACT PERSON

B. GENERAL INFORMATION

The Request for Proposal is designed to solicit proposals from qualified vendors who will be responsible for providing **Maintenance and Service for Chillers** at a competitive and reasonable cost. Proposals that do not conform to the mandatory items as indicated in the Request for Proposal will not be considered.

Proposals shall conform to all instructions, conditions, and requirements included in the Request for Proposal. Prospective bidders are expected to carefully examine all documentation, schedules, and requirements stipulated in this Request for Proposal, and respond to each requirement in the format prescribed.

A fixed-price contract will be awarded as a result of this proposal. In addition to the provisions of this Request for Proposal and the awarded proposal, which shall be incorporated by reference in the contract, any additional clauses or provisions required by the terms and conditions will be included as an amendment to the contract.

C. CUSTOMER SERVICE

In addition to any specified service requirements contained in this agreement, the Contractor agrees and understands that satisfactory customer service is required. Contractor will develop or provide technology and business procedures designed to enhance the level of customer satisfaction and to provide the customer appropriate information given their situation. Contractor, its employees, Subcontractors, and agents must be accountable, responsive, reliable, patient, and have well-developed communication skills as set forth by the customer service industry's best practices and processes.

D. COMMUNICATION WITH STATE STAFF AND EVALUATORS

From the date the Request for Proposal is issued until a determination is announced regarding the selection of the Contractor, contact regarding this project between potential Contractors and individuals employed by the State is restricted to only written communication with the staff designated above as the point of contact for this Request for Proposal. Bidders shall not have any communication with, or attempt to communicate with or influence in any way, any evaluator involved in this RFP.

Once a Contractor is preliminarily selected, as documented in the intent to contract, that Contractor is restricted from communicating with State staff until a contract is signed. Violation of this condition may be considered sufficient cause to reject a Contractor's proposal and/or selection irrespective of any other condition.

The following exceptions to these restrictions are permitted:

1. Written communication with the person(s) designated as the point(s) of contact for this Request for Proposal or procurement;
2. Contacts made pursuant to any pre-existing contracts or obligations;
3. State staff and/or Contractor staff present at the Pre-Proposal Conference when recognized by the State Purchasing Bureau staff facilitating the meeting for the purpose of addressing questions; and
4. State-requested presentations, key personnel interviews, clarification sessions or discussions to finalize a contract.

Violations of these conditions may be considered sufficient cause to reject a bidder's proposal and/or selection irrespective of any other condition. No individual member of the State, employee of the State, or member of the Evaluation Committee is empowered to make binding statements regarding this Request for Proposal. The buyer will issue any clarifications or opinions regarding this Request for Proposal in writing.

E. WRITTEN QUESTIONS AND ANSWERS

Any explanation desired by a bidder regarding the meaning or interpretation of any Request for Proposal provision must be submitted in writing to the State Purchasing Bureau and clearly marked "RFP Number 5296 Z1; **Maintenance and Service for Chillers Questions**". It is preferred that questions be sent via e-mail to as.materiel purchasing@nebraska.gov Questions may also be sent by facsimile to 402-471-2089, but must include a cover sheet clearly indicating that the transmission is to the attention of Annette Walton / Teresa Fleming showing the total number of pages transmitted, and clearly marked "RFP Number 5296 Z1; **Maintenance and Service for Chillers Questions**".

F. PRE-PROPOSAL CONFERENCE

A pre-proposal conference will be held on the date, time and location shown in the Schedule of Events. Attendance at the pre-proposal conference is mandatory in order to submit a proposal. Bidders will have an opportunity to ask questions at the conference to assist in the clarification and understanding of the Request for Proposal requirements. The State will make every reasonable attempt to answer those questions before the end of the conference. Bidders attending the pre-proposal meeting may submit further questions in writing for questions which the bidder requires an official written response as shown in the Schedule of Events. **See Attachment II for Mandatory Pre-Proposal Conference Agenda.**

Written answers to written questions along with a list of conference attendees will be provided through an addendum to be posted on the Internet at <http://das.nebraska.gov/materiel/purchasing.html> on or before the date shown in the Schedule of Events. Verbal responses provided during the pre-proposal meeting shall not be binding on the State of Nebraska

1. NOTIFICATION OF INTENT TO ATTEND MANDATORY PRE-PROPOSAL CONFERENCE

Notification of attendance should be submitted to the State Purchasing Bureau via e-mail (as.materiel purchasing@nebraska.gov), facsimile (402-471-2089), hand delivery or US mail by the date shown in the Schedule of Events. Potential bidders should utilize the "Notification of Intent to Attend Pre-Proposal Conference" (see Form B) that accompanies this document to the contact person shown on the cover page of the Request for Proposal Form. This form should be filled out in its entirety and returned no later than the date shown in the Schedule of Events.

G. SUBMISSION OF PROPOSALS

The following describes the requirements related to proposal submission, proposal handling, and review by the State.

To facilitate the proposal evaluation process, one (1) original of the entire proposal should be submitted. Proposals must be submitted by the proposal due date and time. **A separate sheet must be provided that clearly states which sections have been submitted as proprietary or have copyrighted materials.** All proprietary information the bidder wishes the State to withhold must be submitted in accordance with the instructions outlined in Section III, Proprietary Information. Proposal responses should include the completed Form A, Bidder Contact Sheet. Proposals must reference the Request for Proposal number and be sent to the specified address. Container(s) utilized for original documents should be clearly marked "ORIGINAL DOCUMENTS". Please note that the address label should appear as specified in Section II part A on the face of each container or bidder's bid response packet. Rejected late proposals will be returned to the bidder unopened, if requested, at bidder's expense. If a recipient phone number is required for delivery purposes, 402-471-6500 should be used. The Request for Proposal number must be included in all correspondence.

Emphasis should be concentrated on conformance to the Request for Proposal instructions, responsiveness to requirements, completeness and clarity of content. If the bidder's proposal is presented in such a fashion that makes evaluation difficult or overly time consuming, it is likely that the proposal will be rejected.

H. PROPOSAL OPENING

The sealed proposals will be publicly opened and the bidding entities announced on the date, time, and location shown in the Schedule of Events. Proposals will be available for viewing by those present at the proposal opening.

Vendors may also contact the State to schedule an appointment for viewing proposals after the Intent to Award has been posted to the website.

I. LATE PROPOSALS

Proposals received after the time and date of the proposal opening will be considered late proposals. Rejected late proposals will be returned to the bidder unopened, if requested, at bidder's expense. The State is not responsible for proposals that are late or lost due to mail service inadequacies, traffic, or any other reason(s).

J. REJECTION OF PROPOSALS

The State reserves the right to reject any or all proposals, wholly or in part, or to award to multiple bidders in whole or in part. The State reserves the right to waive any deviations or errors that are not material, do not invalidate the legitimacy of the proposal and do not improve the bidder's competitive position. All awards will be made in a manner deemed in the best interest of the State.

K. MANDATORY REQUIREMENTS

The proposals will first be examined to determine if all mandatory requirements listed below have been addressed to warrant further evaluation. Proposals not meeting mandatory requirements will be excluded from further evaluation. The mandatory requirement items are as follows:

1. Request For Proposal For Contractual Services form, signed in ink;
2. Completed Section III;
3. Cost Proposal.

Neb. Rev. Stat. §73-107 allows for a preference for a resident disabled veteran or business located in a designated enterprise zone. When a state contract is to be awarded to the lowest responsible bidder, a resident disabled veteran or a business located in a designated enterprise zone under the Enterprise Zone Act shall be allowed a preference over any other resident or nonresident bidder, if all other factors are equal.

Resident disabled veterans means any person (a) who resides in the State of Nebraska, who served in the United States Armed Forces, including any reserve component or the National Guard, who was discharged or otherwise separated with a characterization of honorable or general (under honorable conditions), and who possesses a disability rating letter issued by the United States Department of Veterans Affairs establishing a service-connected disability or a disability determination from the United States Department of Defense and (b)(i) who owns and controls a business or, in the case of a publicly owned business, more than fifty percent of the stock is owned by one or more persons described in subdivision (a) of this subsection and (ii) the management and daily business operations of the business are controlled by one or more persons described in subdivision (a) of this subsection. Any contract entered into without compliance with this section shall be null and void.

Therefore, if a resident disabled veteran or business located in a designated enterprise zone submits a bid in accordance with Neb. Rev. Stat. §73-107 and has so indicated on the RFP cover page under "Bidder must complete the following" requesting priority/preference to be considered in the award of this contract, the following will need to be submitted by the vendor within ten (10) business days of request:

1. Documentation from the United States Armed Forces confirming service;
2. Documentation of discharge or otherwise separated characterization of honorable or general (under honorable conditions);
3. Disability rating letter issued by the United States Department of Veterans Affairs establishing a service-connected disability or a disability determination from the United States Department of Defense; and
4. Documentation which shows ownership and control of a business or, in the case of a publicly owned business, more than fifty percent of the stock is owned by one or more persons described in subdivision (a) of this subsection; and the management and daily business operations of the business are controlled by one or more persons described in subdivision (a) of this subsection.

Failure to submit the requested documentation within ten (10) business days of notice will disqualify the bidder from consideration of the preference.

L. REFERENCE CHECKS

The State reserves the right to check any reference(s), regardless of the source of the reference information, including but not limited to, those that are identified by the company in the proposal, those indicated through the explicitly specified contacts, those that are identified during the review of the proposal, or those that result from communication with other entities involved with similar projects. The State may use a third-party to conduct reference checks.

Information to be requested and evaluated from references may include, but is not limited to, some or all of the following: financial stability of the company, project description and background, job performed, functional and technical abilities, communication skills and timeliness, cost and schedule estimates and accuracy, problems (poor quality deliverables, contract disputes, work stoppages, et cetera), overall performance, and whether or not the reference would rehire the firm or individual. Only top scoring bidders may receive reference checks, and negative references may eliminate bidders from consideration for award.

M. SECRETARY OF STATE/TAX COMMISSIONER REGISTRATION REQUIREMENTS

All bidders should be authorized to transact business in the State of Nebraska. All bidders are expected to comply with all Nebraska Secretary of State Registration requirements. It is the responsibility of the bidder to comply with any registration requirements pertaining to types of business entities (e.g. person, partnership, foreign or domestic limited liability company, association, or foreign or domestic corporation or other type of business entity). The bidder who is the recipient of an Intent to Award will be required to certify that it has so complied and produce a true and exact copy of its current (within (90) calendar days), valid Certificate of Good Standing or Letter of Good Standing; or in the case of a sole proprietorship, provide written documentation of sole proprietorship. This must be accomplished prior to the award of the contract. Construction Contractors are expected to meet all applicable requirements of the Nebraska Contractor Registration Act and provide a current, valid certificate of registration. Further, all bidders shall comply with any and all other applicable Nebraska statutes regarding transacting business in the State of Nebraska. Bidders should submit the above certification(s) with their bid.

If a bank is registered with the Office of Comptroller of Currency, it is not required to register with the State. However, the Office of Comptroller of Currency does have a certificate of good standing/registration. The bank could provide that for verification. (Optional)

N. VIOLATION OF TERMS AND CONDITIONS

Violation of the terms and conditions contained in this Request for Proposal or any resultant contract, at any time before or after the award, shall be grounds for action by the State which may include, but is not limited to, the following:

1. Rejection of a bidder's proposal;
2. Withdrawal of the Intent to Award
3. Termination of the resulting contract.
4. Legal action.
5. Suspension of the bidder from further bidding with the State for the period of time relative to the seriousness of the violation, such period to be within the sole discretion of the State.

III. TERMS AND CONDITIONS

By signing the "Request for Proposal for Contractual Services" form, the bidder guarantees compliance with the provisions stated in this Request for Proposal, agrees to the Terms and Conditions unless otherwise agreed to and certifies bidder maintains a drug free work place environment.

Bidders are expected to closely read the Terms and Conditions and provide a binding signature of intent to comply with the Terms and Conditions; provided, however, a bidder may indicate any exceptions to the Terms and Conditions by (1) clearly identifying the term or condition by subsection, and (2) including an explanation for the bidder's inability to comply with such term or condition which includes a statement recommending terms and conditions the bidder would find acceptable. Rejection in whole or in part of the Terms and Conditions may be cause for rejection of a bidder's proposal. **Bidders must include completed Section III with their proposal response.**

The State of Nebraska is soliciting bids in response to the RFP. The State of Nebraska will not consider proposals that propose the substitution of the bidder's contract, agreements, or terms for those of the State of Nebraska's. Any License, Service Agreement, Customer Agreement, User Agreement, Bidder Terms and Conditions, Document, or Clause purported or offered to be included as a part of this RFP must be submitted as individual clauses, as either a counter-offer or additional language, and each clause must be acknowledged and accepted in writing by the State. If the Bidder's clause is later found to be in conflict with the RFP or resulting contract the Bidder's clause shall be subordinate to the RFP or resulting contract.

The contract resulting from this Request for Proposal shall incorporate the following documents:

1. Amendment to Contract Award with the most recent dated amendment having the highest priority;
2. Contract Award and any attached Addenda;
3. The Request for Proposal form and the Contractor's Proposal, signed in ink;
4. Amendments to RFP and any Questions and Answers; and
5. The original RFP document and any Addenda.

These documents constitute the entirety of the contract.

Unless otherwise specifically stated in a contract amendment, in case of any conflict between the incorporated documents, the documents shall govern in the following order of preference with number one (1) receiving preference over all other documents and with each lower numbered document having preference over any higher numbered document: 1) Amendment to Contract Award with the most recent dated amendment having the highest priority, 2) Contract Award and any attached Addenda, 3) the signed Request for Proposal form and the Contractor's Proposal, 4) Amendments to RFP and any Questions and Answers, 5) the original RFP document and any Addenda.

Any ambiguity in any provision of this contract which shall be discovered after its execution shall be resolved in accordance with the rules of contract interpretation as established in the State of Nebraska.

Once proposals are opened they become the property of the State of Nebraska and will not be returned.

A. SCOPE OF WORK

The State of Nebraska is seeking a contractor to provide Maintenance and Service for Chillers at several Lincoln facilities for the State Building Division. The cost sheet shall include all costs to provide the service, including travel time and vehicle expense. No separate travel expenses will be allowed on the monthly billing invoices. See Attachment I for equipment specifications, models, and serial numbers.

Chiller maintenance / inspection to be a full service plan that shall include maintenance, repair, or replacement of the chiller equipment described in the work plan below due to normal wear and tear as determined by contractor and manager / supervisor and / or facility contact or his / her designee. Travel expenses to be included for all facilities. No additional travel, fuel adjustment, or emergency call-back labor expenses will be approved during the contract term.

The State reserves the right to add additional facilities with the coordination of the contractor should the need arise. Addition of facilities is in no way guaranteed. In the event either State Building Division wishes to add an additional facility, the contractor shall establish a cost based on the regular hourly rate (requested on the Cost Sheet) and that shall be amended to the contract as a new facility.

B. WORK PLAN

1. SCHEDULED MAINTENANCE

All preventive maintenance performed by the contractor shall be scheduled upon commencement of the contract and subject to final approval of the State. Monthly and Annual chiller maintenance / inspections shall be scheduled for the same day or days each month with each facility contact / designee in order to establish a routine, unless otherwise requested by the designated facility contact / designee. The schedule for each location shall be established with each facility contact / designee at commencement of contract.

Contractor's service technician will check in with designated facility contact or his / her designee prior to initiating any work and will check out prior to leaving the premises. An inspection report containing the time and location of service will be documented, and a copy will be left by the contractor (service technician) on site with the designated facility contact or his / her designee. A copy of this documentation, signed by the designated facility contact or his / her designee at the time of service, will be submitted with the monthly invoice.

When contractor observes a repair or replacement needed, the contractor shall submit a recommendation for repair / replacement to the designated facility contact / designee. The recommendation shall show the building name, equipment brand / model, and details of the repair / replacement needed.

Maintenance schedules shall be permanently located in the equipment rooms for each chiller. The schedules shall be accessible to the State for monitoring. Schedules shall be maintained by indicating the work performed, signature of the service technician performing the work, and the date the work was performed. Any equipment / parts that are replaced will be noted in permanent marker / ink on the equipment and on the schedule.

Contractor will provide a copy of the Safety Data Sheets for the liquid supplies left on site.

Contractor shall perform Eddy-Current testing on all chillers approximately 120 days after contract start date and every five (5) years thereafter.

2. PERFORMANCE CONFERENCES AND REPORTS

At the end of each ninety (90) day period, the contractor shall meet with the State to review performance and schedule major repairs contemplated during the next ninety (90) day period. The contractor shall submit to the State written inspection reports at the end of the annual period. The contractor shall submit, when applicable, any written recommendations related to safety issues, repairs, etc. Contractor's supervisory personnel shall be available at all times to report to and confer with the State. Contractor shall submit to the State such records and reports as may be identified in this Request for Proposal.

Contractor shall have a supervisor regularly conduct a field audit of the performance of contractor's field personnel. Contractor shall semi-annually survey all equipment covered by this contract to confirm compliance to the requirements of the contract.

3. THE CONTRACTOR MUST PERFORM THE FOLLOWING WORK:

Furnish all labor, parts, oil, and materials needed to maintain the State's equipment in good operating condition, perform service when required to complete predictive maintenance and repair.

Annually inspect the water side of water cooled condensers with procedures recommended by the equipment manufacturer.

Quarterly inspection of the air side of air cooled condensers with procedures recommended by the equipment manufacturer.

Maintain the following items related to the State's equipment,

- a. electric wiring from the motor starter to the motor;
- b. refrigerant piping between two or more pieces of equipment,
- c. the pressure and temperature controls,
- d. thermometers,
- e. gauges,
- f. control devices,
- g. thermostats,
- h. manual valves located on the equipment, and
- i. mechanical starters.

Contractor to provide written monthly inspection reports and an annual inspection report to the designated facility contract or his / her designee about the condition of the equipment and any recommendations for enhancements or repairs to maintain capacity, reliability, and efficiency.

4. ANNUAL INSPECTION PROCEDURES

- a. Test for refrigerant leaks including relief valve piping outlets,
- b. Check main starter and control panel,
- c. Inspect and tighten electrical connections,
- d. Check relays, operating, and safety controls,
- e. Check flow switch operation,
- f. Check vane control setting and operation,
- g. Take and record water side pressure drops across vessels,
- h. Perform MicroTech (for McQuay units) check, log, and last fault analysis, analyze performance,
- i. Perform operating log check if not MicroTech (non-McQuay units) and analyze,
- j. Clean oil cooler strainer on water cooled units,
- k. Check oil sump heater operation,
- l. Check purge operation,
- m. Perform oil analysis for wear metals, moisture, and acid,

- n. Inspect vibration eliminators and inspect water piping for leaks,
- o. Check minimum condenser water temperature operation; and
- p. Visually inspect water side of condensers by removing the head where accessible and cleaning condensers with a properly sized brush and machine.

5. MONTHLY OPERATIONAL INSPECTION PROCEDURES

- a. Review manufactures recommendation for operation and compare to existing conditions,
- b. Test for refrigerant leaks including relief valve piping outlets,
- c. Check auxiliary equipment operation,
- d. Check oil levels,
- e. Visually inspect compressor starters,
- f. Check oil sump heater and gear case heater where applicable,
- g. Check relays, operating, and safety controls,
- h. Check chilled water pump(s) for operation,
- i. Check condenser water pump(s) and cooling tower,
- j. Take and record water side pressure drops across vessels,
- k. Check condenser water temperature control operation,
- l. Check water chiller,
- m. Log all operating conditions, temperatures, pressures, and Delta-T, and
- n. Review operating procedures and conditions with State of Nebraska maintenance personnel.

6. LOCATIONS

Contractor shall provide the necessary labor, parts, oil, and materials to service and maintain chillers in working operation at the following Lincoln, Nebraska locations:

- a. Department of Administrative Services located at 1526 K Street
- b. State Data Center located at 501 South 14th Street
- c. State Testing Lab located at 3701 South 14th Street
- d. Transportation Services Bureau located at 1400 M Street
- e. Staff Training Academy located at 2320 North 57th Street
- f. State Capitol located at 1445 K Street

Possible additions of locations and/or subtractions of locations upon mutual agreement between State and Contractor.
