1.	On the rotenone powder it list the container as 110 gallons but it should be 110 pounds, this appears to be a typo.	Rotenone powder should be listed in pounds. Please see the revised Invitation to Bid.
2.	With the quantity listed as 4,320 pounds divided by 110 pounds it comes out to 39.27 by 110 pound containers so the quantity need to be adjust up or down to equal full containers.	Please round up to 4,400 pounds. The quantity will depend on the percentage concentration as the bid is based on 5% and if the concentration is higher than 5%, the poundage will be lower. Please see revised Invitation to Bid.

3.	The bid says that bidders must have "valid Certificate of Good Standing or Letter of Good Standing" from the NE Secretary of State. I have not been asked for this before and am not familiar with it, how do I go about obtaining these to satisfy the requirements?	<p>A Letter of Good Standing is available through the Secretary of State's on-line service only. To get one you start by doing a Corporate/ Business Search (look under the quick links at <a href="http://www.sos.ne.gov/admin/banners.html">http://www.sos.ne.gov/admin/banners.html</a> ). From the search results you view the "Details". This will show you the information about the company in our database, including a list of filed documents. Under the list of filed documents you have the option to order a letter of good standing or a certificate of good standing. You add what you want/need to your shopping cart and check out. Once the \$6.50 fee is paid, a letter of good standing will be sent to you via email. Included in the email is your receipt with a link to open and print the letter.
