Navigation: There are multiple menu paths for this report. This lesson uses the Inquiries and Reports menu path.

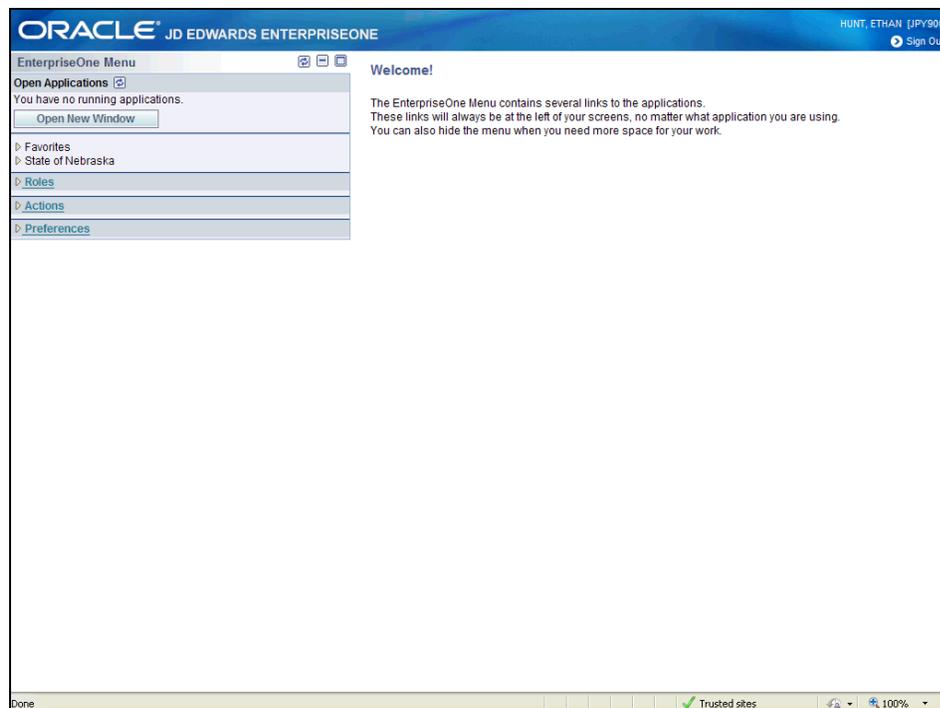

5.	Click the Voucher Journal link. 

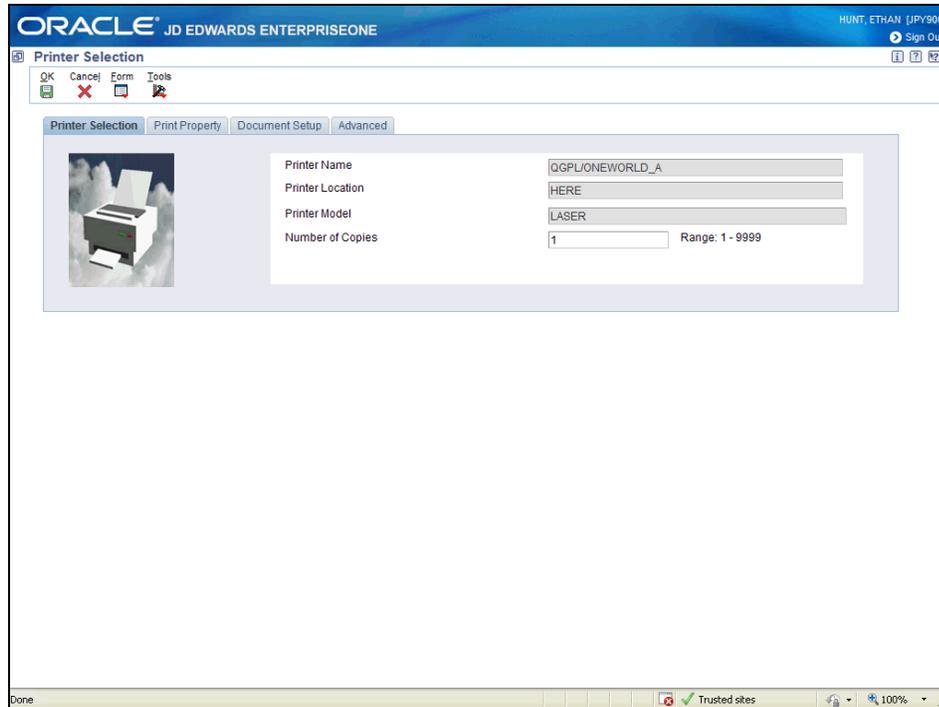
