Process Flow - Issuing Inventory (PF50001)

Process flow PF50001 illustrates the warehouse issue of a stock numbered item from inventory, upon manual receipt of a "request for stock". Two paths are depicted based on a determination of whether or not a mark-up is involved. Issues with markup use a document type of "IM". Issues without markup use a document type of "II". The document type is automatically supplied by the issue program (P4112), depending on the menu path is selected.
