ATTENTION PERMIT AGENTS

DO NOT DESTROY THIS BOOK, must be returned to the Game and Parks Commission when empty or at the end of the calendar year.

1. This book of Nebraska Licensed Vehicle Daily Park Entry Permits is consigned to your account. Do not transfer.
2. These permits are valid for Nebraska licensed vehicles. Please, **mark the effective date with a dark-colored marker in the space provided (ie: Day/Month)**. You may post-date as instructed by the purchaser, but the permit will not be valid until the date/month is marked.
3. The permit must be affixed to the inside, lower left-hand corner of the windshield (driver side). For vehicles without a windshield, it must be permanently affixed to bumper or a readily visible area of the frame. A permit may not be replaced for any reason.
4. Daily Park Entry Permits allow access to any area where such a permit is required. It conveys no other privilege or right. It does not entitle the driver or occupants to any service, facility or activity for which a separate fee is required. Signs are posted at the entrance to all areas where such permit is necessary.
5. Permit books from which all permits, stamps, or park entry permits have been issued are to be returned each month with the monthly remittance report.
6. All funds from the sale of these permits must be remitted monthly to the Game and Parks Commission. Any account that does not remit after a special notice is sent to them will be closed and no further books sent.


