ATTENTION, VISITORS...

1. A Motor Vehicle Permit is required on all licensed vehicles entering a state park, state recreation area, or state historical park.
2. **This self-service Daily Entry Permit is valid for one (1) day only and only for this area.** It expires at noon on the day following the date of purchase and must be renewed daily.
3. **Camping fees are required to be paid immediately, prior to occupying a campsite.** Campsites must be physically occupied immediately by a camping unit or tent as defined by the regulations.
4. Only (1) one camping unit and (1) one erected tent or (2) two erected tents are allowed per camp site.
5. Camping or occupying locations within a park area, or campground is permitted for a maximum of 14 consecutive days during any 30 day period.
6. Keep all vehicles and trailers, including tent trailers, on the camping pad.
7. Quiet hours are in effect from 10 p.m. to 6 a.m.
