ATTENTION PERMIT AGENTS

DO NOT DESTROY THIS BOOK, return to the Game and Parks Commission when empty or at the end of the calendar year.

1. This book of Non-Nebraska Licensed Vehicle Annual Park Entry Permits is consigned to your account. Do not transfer.

2. You may not replace a permit for any reason. See your handbook for replacements possible through the Game and Parks Commission.

3. These permits are valid for non-Nebraska licensed vehicles from Jan.1 through Dec. 31 of the year shown. The permit must be permanently affixed to the inside, lower left-hand corner of the windshield (driver side). For vehicles without a windshield, it must be permanently affixed to a readily visible area of the frame.

4. Park Entry Permits allow access to any area where such a permit is required. It conveys no other privilege or right. It does not entitle the driver or occupants to any service, facility or activity for which a separate fee is required. Signs are posted at the entrance to all areas where such permit is necessary.

5. Do **NOT** detach the Application for Duplicate Permit when issuing the Annual Permit. Customers may obtain one (1) duplicate permit for each Annual Permit purchased by presenting the Application for Duplicate Permit to a Permit Agent who is authorized to sell duplicate park entry permits and pay the applicable duplicate permit fee.

6. Permit books from which all permits, stamps, or park entry permits have been issued are to be returned each month with the monthly remittance report.


7. All funds from the sale of these permits must be remitted monthly to the Game and Parks Commission. Any account that does not remit after a special notice is sent to them will be closed and no further books sent.
