

## Technical Approach

a. Our project requires three distinct and exciting family friendly theatre experiences which require rapid change from one production to the other during the summer months, followed by a fall production on the weekends. We also have a unique family friendly show during the Winter and Spring.

b. Our development of these projects begins with the selection of fun scripts that are appropriate for all ages.

c. The technical considerations are an important part of our development as the three shows must have minimal technical requirements: lighting effects, sound effects, and/or special effects.

### d. Work Plan

- Select scripts
- Design setting, lighting, and sound for all productions.
- Design and execute a flyer promoting the season's schedule.
- Audition and hire actors
- Work with costumer to generate a separate plot for each production.
- Work with the park staff to promote our performance schedule.
- Use social media throughout the rehearsal period to generate interest and promote our schedule.
- Plan and execute an intensive rehearsal schedule to prepare the productions for the performances.
- Design and execute a program for the production.
- Write press releases with photographs, to promote show opening.
- Distribute approved press releases to media outlets.
- Work with Park Staff to arrange preview audiences to gauge audience reaction to the productions.
- Continue to generate interest in the shows throughout the season via social media and working with Park Staff.

e. All Summer shows will be ready for opening on the Friday before Memorial Day.

**SCOPE OF SERVICE**

The State of Nebraska (State), Department of Administrative Services (DAS), Materiel Division, State Purchasing Bureau (SPB), is issuing this Request for Proposal (RFP) Number 6663 Z1 for the purpose of selecting a qualified Bidder to provide Eugene T. Mahoney Summer and Winter Theater Melodrama Production. A more detailed description can be found in Section V. The resulting contract may not be an exclusive contract as the State reserves the right to contract for the same or similar services from other sources now or in the future.

The term of the contract will be three (3) years commencing upon execution of the contract by the State and the awarded bidder(s). The Contract includes the option to renew for two (2) additional two (2) year periods upon mutual agreement of the Parties. The State reserves the right to extend the period of this contract beyond the termination date when mutually agreeable to the Parties.

**PUBLIC POSTING NOTICE:**

Pursuant to the Taxpayer Transparency Act (Neb. Rev. Stat. §§ 84-602.02 to 84-602.0) and in furtherance of public records law, State contracts must be posted to a public website. The resulting contract, the solicitation, and the successful Bidder's proposal and response will be posted to a public website managed by DAS, which can be found at

These postings will include the entire proposal and response. Stat. § 84-712.05, the State will consider all information a public record subject to disclosure. If the State determines it is required to release proprietary information, the Bidder will be informed. It will be the Bidder's responsibility to defend the Bidder's asserted interest in non-disclosure.

To facilitate such public postings, with the exception of proprietary information, the State of Nebraska reserves a royalty-free, nonexclusive, and irrevocable right to copy, reproduce, publish, post to a website, or otherwise use any contract, proposal, or response to this solicitation for any purpose, and to authorize others to use the documents. Any individual or entity awarded a contract, or who submits a proposal or response to this solicitation, specifically waives any copyright or other protection the contract, proposal, or response to the solicitation may have; and acknowledges that they have the ability and authority to enter into such waiver. This reservation and waiver is a prerequisite for submitting a proposal or response to this solicitation, and award of a contract. Failure to agree to the reservation and waiver will result in the proposal or response to the solicitation being found non-responsive and rejected.

Any entity awarded a contract or submitting a proposal or response to the solicitation agrees not to sue, file a claim, or make a demand of any kind, and will indemnify and hold harmless the State and its employees, volunteers, agents, and its elected and appointed officials from and against any and all claims, liens, demands, damages, liability, actions, causes of action, losses, judgments, costs, and expenses of every nature, including investigation costs and expenses, settlement costs, and attorney fees and expenses, sustained or asserted against the State, arising out of, resulting from, or attributable to the posting of the contract or the proposals and responses to the solicitation, awards, and other documents.

## GLOSSARY OF TERMS

**Acceptance Test Procedure:** Benchmarks and other performance criteria, developed by the State of Nebraska or other sources of testing standards, for measuring the effectiveness of services and the means used for testing such performance.

**Addendum:** Something to be added or deleted to an existing document; a supplement.

**After Receipt of Order (ARO):** After Receipt of Order

**Agency:** Any state agency, board, or commission other than the University of Nebraska, the Nebraska State colleges, the courts, the Legislature, or any other office or agency established by the Constitution of Nebraska.

**Agent/Representative:** A person authorized to act on behalf of another.

**Amend:** To alter or change by adding, subtracting, or substituting.

**Amendment:** A written correction or alteration to a document.

**Appropriation:** Legislative authorization to expend public funds for a specific purpose. Money set apart for a specific use.

**Automated Clearing House:** Electronic network for financial transactions in the United States.

**Award:** All purchases, leases, or contracts which are based on competitive proposals will be awarded according to the provisions in the solicitation.

**Best and Final Offer:** In a competitive proposal, the final offer submitted which contains the bidder's most favorable terms for price.

**Bid Bond:** An insurance agreement, accompanied by a monetary commitment, by which a third party (the surety) accepts liability and guarantees that the bidder will not withdraw the bid.

**Bidder:** A vendor who submits a proposal in response to a written solicitation.

**Breach:** Violation of a contractual obligation by failing to perform or repudiation of one's own promise.

**Business:** Any corporation, partnership, individual, sole proprietorship, joint-stock company, joint venture, or any other private legal entity.

**Business Day:** Any weekday, except State-recognized holidays.

**Calendar Day:** Every day shown on the calendar including Saturdays, Sundays, and State/Federal holidays.

**Cancellation:** To call off or revoke a purchase order or contract without expectation of conducting or performing it at a later time.

**Change Order:** Document that provides an addendum and/or amendment to an executed purchase order or contract.

**Collusion:** An agreement or cooperation between two or more persons or entities to accomplish a fraudulent, deceitful, or unlawful purpose.

**Commodities:** Any equipment, material, supply or goods; anything movable or tangible that is provided or sold

**Confidential Information:** Unless otherwise defined below, "Confidential Information" shall also mean proprietary trade secrets, academic and scientific research work which is in progress and unpublished, and other information which if released would give advantage to business competitors and serve no public purpose (see Neb. Rev. Stat. §84-712.05(3)). In accordance with Nebraska Attorney General Opinions 92068 and 97033, proof that information is proprietary requires identification of specific, named competitor(s) who would be advantaged by release of the information and the specific advantage the competitor(s) would receive.

**Contract:** An agreement between two or more parties creating obligations that are enforceable or otherwise recognizable at law; the writing that sets forth such an agreement.

**Contract Administration:** The administration of the contract which includes and is not limited to; contract signing, contract amendments and any necessary legal actions.

**Contract Management:** The management of day-to-day activities at the agency which includes and is not limited to ensuring deliverables are received, specifications are met, handling meetings and making payments to the Contractor.

**Contract Period:** The duration of the contract.

**Contractor:** An individual or entity lawfully conducting business in the State who provides goods or services under the terms of a written solicitation.

**Copyright:** A property right in an original work of authorship fixed in any tangible medium of expression, giving the holder the exclusive right to reproduce, adapt and distribute the work.

**Customer Service:** The process of ensuring customer satisfaction by providing assistance and advice on those products or services provided by the Contractor.

**Default:** The omission or failure to perform a contractual duty.

**Deviation:** Any proposed change(s) or alteration(s) to either the terms and conditions or deliverables within the scope of the written solicitation or contract.

**Evaluation:** The process of examining an offer after opening to determine the bidder's responsibility, responsiveness to requirements, and to ascertain other characteristics of the offer that relate to determination of the successful award.

**Evaluation Committee:** Individual(s) selected by the requesting agency for the evaluation of proposals (offers made in response to written solicitations).

**Extension:** Continuance of a contract for a specified duration upon the agreement of the parties beyond the initial Contract Period. Not to be confused with "Renewal Period".

**Free on Board Destination:** The delivery charges are included in the quoted price and prepaid by the contractor. Contractor is responsible for all claims associated with damages during delivery of product.

**Late Proposal:** An offer received after the Opening Date and Time.

**Mandatory/Must/Shall/Will:** Required, compulsory, or obligatory.

**May:** Discretionary, permitted; used to express possibility.

**Non-Responsive Proposal:** Any proposal that does not comply with the requirements of the solicitation.

**Opening Date and Time:** Specified date and time for the public opening of received and labeled formal proposals.

**Performance Bond:** An insurance agreement, accompanied by a monetary commitment, by which a third party (the surety) accepts liability and guarantees that the Contractor fulfills any and all obligations under the contract.

**Point of Contact (POC):** The person designated to receive communications and to communicate.

**Pre-Proposal Conference:** A meeting scheduled for the purpose of clarifying a written Request for Proposal and related expectations.

**Project:** The total scheme, program, or method worked out for the accomplishment of an objective, including all documentation, commodities, and services to be provided under the contract.

**Proposal:** The offer submitted by a bidder in a response to a Request for Proposal.

**Proprietary Information:** Proprietary information is defined as trade secrets, academic and scientific research work which is in progress and unpublished, and other information which if released would give advantage to business competitors and serves no public purpose (see Neb. Rev. Stat. § 84-712.05(3)). In accordance with Attorney General Opinions 92068 and 97033, proof that information is proprietary requires identification of specific named competitor(s) advantaged by release of the information and the demonstrated advantage the named competitor(s) would gain by the release of information.

**Protest/Grievance:** A complaint about a governmental action or decision related to a solicitation or resultant contract, brought by a bidder who has submitted a proposal response by the opening date and time in connection with the award in question, to AS Materiel Division or another designated agency with the intention of achieving a remedial result.

**Public Proposal Opening:** The process of opening correctly submitted offers proposals at the time and place specified in the written solicitation and in the presence of anyone who wished to attend.

**Release Date:** The date of a public release of the Request for Proposal.

**Renewal Period:** Optional contract periods subsequent to the original initial Contract Period for a specified duration with previously agreed to terms and conditions. Not to be confused with "Extension".

**Request for Proposal:** Utilized for obtaining competitive proposals.

**Responsible Bidder:** A contractor who has the capability in all respects to perform fully and lawfully all requirements with integrity and reliability to assure good faith performance.

**Responsive Bidder:** A bidder who has submitted a proposal which conforms to all requirements of the Request for Proposal document.

**Should:** Expected; suggested, but not necessarily mandatory.

**Specifications:** The detailed statement, especially of the measurements, quality, materials, and functional characteristics, or other items to be provided under a contract.

**Statutory:** Those clauses that are controlled by state law and are not subject to negotiation.

**Subcontractor:** Individual or entity with whom the contractor enters a contract to perform a portion of the work awarded to the contractor.

**Termination:** Occurs when either Party, pursuant to a power created by agreement or law, puts an end to the contract prior to the stated expiration date. All obligations which are still executory on both sides are discharged but any right based on prior breach or performance survives.

**Third Party:** Any person or entity, including but not limited to fiduciaries, shareholders, owners, officers, managers, employees, legally disinterested persons, and subcontractors or agents, and employees. It shall not include any entity or person who is an interested Party to the contract or agreement.

**Trade Secret:** Information, including, but not limited to, a drawing, formula, pattern, compilation, program, device, method, technique, code, or process that (a) derives independent economic value, actual or potential, from not being known to, and not being ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use; and (b) is the subject of efforts that are reasonable under the circumstances to maintain its secrecy (see Neb. Rev. Stat. §87-502(4)).

**Trademark:** A word, phrase, logo, or other graphic symbol used by a manufacturer or contractor to distinguish its product from those of others, registered with the U.S. Patent and Trademark Office.

**Vendor Performance Report:** A report completed by the using agency and submitted to State Purchasing Bureau documenting products or services delivered or performed which exceed or fail to meet the terms of the purchase order, contract, and/or request for proposal specifications.

**Vendor:** An individual or entity lawfully conducting business in the State or licensed to do so, who seeks to provide goods or services under the terms of a written solicitation.

## I. PROCUREMENT PROCEDURE

### A. GENERAL INFORMATION

The Request for Proposal is designed to solicit proposals from qualified Bidders who will be responsible for providing Eugene T. Mahoney Summer and Winter Theater Melodrama Production at a competitive and reasonable cost. Terms and Conditions, Project Description and Scope of Work, Proposal instructions, and Cost Proposal Requirements may be found in Sections II through VI.

Proposals shall conform to all instructions, conditions, and requirements included in the Request for Proposal. Bidders are to carefully examine all documents, schedules, and requirements in this Request for Proposal, and respond to each requirement in the format prescribed. Proposals may be found non-responsive if they do not conform to the Request for Proposal.

**E. SECRETARY OF STATE/TAX COMMISSIONER REGISTRATION REQUIREMENTS (§ 21-2,203 Statutory)**

All contractors must be authorized to transact business in the State of Nebraska and comply with all Nebraska Secretary of State registration requirements. The bidder who is the recipient of an Intent to Award may be required to certify that it has complied and produced a true and exact copy of its current (within ninety (90) calendar days of the intent to award) Certificate of Good Standing, or in the case of a sole proprietorship, provide written documentation of sole proprietorship and complete the United States Citizenship Attestation Form, available on the Department of Administrative Services website at <http://das.nebraska.gov/materiel/purchasing.html>. This must be accomplished prior to execution of the contract.

**F. ETHICS IN PUBLIC CONTRACTING**

The State reserves the right to reject proposals, withdraw an award or intent to award, or terminate a contract if an ethical violation has been committed, which includes, but is not limited to:

1. Offering or giving, directly or indirectly, a bribe, fee, commission, compensation, gift, gratuity, or anything of value to any person or entity in an attempt to influence the bidding process;

2. Utilizing the services of lobbyists, attorneys, political activists, or consultants to influence or subvert the process;
3. Being considered for, presently being, or becoming debarred, suspended, ineligible, or excluded from contracting with any state or federal entity;
4. Submitting a proposal on behalf of another Party or entity; and
5. Collude with any person or entity to influence the bidding process, submit sham proposals, preclude bidding, fix pricing or costs, create an unfair advantage, subvert the proposal, or prejudice the State.

The Contractor shall include this clause in any subcontract entered into for the exclusive purpose of performing this contract.

Contractor Bidder shall have an affirmative duty to report any violations of this clause by the Contractor throughout the bidding solicitation process, and throughout the term of this contract for the successful Contractor and their subcontractors.

#### **G. PROPOSAL REQUIREMENTS**

The proposals will first be examined to determine if all requirements listed below have been addressed and whether further evaluation is warranted. Proposals not meeting the requirements may be rejected as non-responsive. The requirements are:

1. Original for Contractual Services form signed in ink or via DocuSign;
2. Clarity and responsiveness of the proposal;
3. Completed Corporate Overview;
4. Completed Sections II through VI;
5. Completed Technical Approach; Section V.A.6; and,
6. Completed State Cost Proposal Template.

#### **H. DEVIATIONS FROM THE REQUEST FOR PROPOSAL**

The requirements contained in the solicitation (Sections II thru VI) become a part of the terms and conditions of the contract resulting from this solicitation. Any deviations from the solicitation in Sections II through VI must be clearly defined by the bidder in its proposal and, if accepted by the State, will become part of the contract. Any specifically defined deviations must not be in conflict with the basic nature of the solicitation, requirements, or applicable state or federal laws or statutes. The State discourages deviations and reserves the right to reject proposed deviations.

#### **I. SUBMISSION OF PROPOSALS**

The State is accepting only electronically submitted responses. The State will not accept proposals by email, voice, or telephone.

Pages may be consecutively numbered for the entire proposal or may be numbered consecutively within sections. Figures and tables should be numbered and referenced in the text by that number. They should be placed as close as possible to the referencing text. The Technical Proposal should not contain any reference to dollar amounts. However, information such as data concerning labor hours and categories, materials, subcontracts and so forth, shall be considered in the Technical Proposal so that the bidder's understanding of the scope of work may be evaluated. The Technical Proposal shall disclose the bidder's technical approach in as much detail as possible, including, but not limited to, the information required by the Technical Proposal instructions.

It is the bidder's responsibility to ensure the response is received electronically by the date and time indicated in the Schedule of Events. Proposals must be submitted via ShareFile by the date and time of the proposal opening per the Schedule of Events. No late proposals will be accepted.

It is the responsibility of the bidder to check the website for all information relevant to this RFP to include addenda and/or amendments issued prior to the opening date. Website address is as follows:

Emphasis should be concentrated on conformance to the RFP instructions, responsiveness to requirements, completeness, and clarity of content. If the bidder's proposal is presented in such a fashion that makes evaluation difficult or overly time consuming the State reserves the right to reject the proposal as non-conforming.

#### **1. Bidders must submit responses via ShareFile using the proposal submission link.**

Note to bidders: Not all browsers are compatible with ShareFile. Currently Chrome, Internet Explorer and Firefox are compatible. After the bidder clicks the proposal submission link, the bidder will be prompted to enter contact information including an e-mail address. By entering an e-mail address, the bidder should receive a confirmation email confirming the successful upload directly from ShareFile.

- a. The Technical, Cost Proposal and Proprietary information should be uploaded as separate and distinct files.
  - i. If duplicated proposals are submitted, the State will retain only the most recently submitted response.
  - ii. If it is the bidder's intent to submit multiple proposals, the bidder must clearly identify the separate submissions.
  - iii. It is the bidder's responsibility to allow time for electronic uploading. All file uploads must be completed by the Opening date and time per the Schedule of Events. No late proposals will be accepted.
- b. **ELECTRONIC PROPOSAL FILE NAMES**

The bidder should clearly identify the uploaded RFP proposal files. To assist in identification the bidder should use the following naming convention:

  - i. RFP 6663 Z1, Company Name, Description of Service
  - ii. If multiple files are submitted for one RFP proposal, add number of files to file names: RFP 6663 Z1 Company Name, File 1 of 2.

Proposal responses should include the completed Form A, "Contact Information". Proposals must reference the RFP number and be sent to the specified address. The RFP number should be included in all correspondence.

**J. PROPOSAL PREPARATION COSTS**

The State shall not incur any liability for any costs incurred by Bidders responding to this solicitation, including but not limited to, costs associated with Pre-Proposals conferences, presentations and/or demonstrations.

**K. DISCOUNTS**

Prices quoted shall be inclusive of ALL trade discounts. Cash discount terms of less than 30 days will not be considered as part of the proposal. Cash discount periods will be computed from the date of receipt of a properly executed claim voucher or the date of completion of delivery of all items in a satisfactory condition, whichever is later.

**L. PRICES**

All prices, costs, and terms and conditions outlined in the proposal shall remain fixed and valid commencing on the opening date of the proposal until termination of the contract unless ticket prices are increased by the Commission or at the end of each contract term. The Contractor may then request an increase, but the increase may not exceed the percentage increase from the original ticket price to the new ticket price made by the Commission. The Contractor may be required to provide documentation substantiating the validity of the increase request. Further documentation may be required by the State to justify the increase. The State reserves the right to deny any requested price increase. No price increases are to be billed to any State Agencies prior to written amendment of the contract by the parties.

**M. COST CLARIFICATION**

The State reserves the right to review all aspects of cost for reasonableness and to request clarification of any proposal where the cost component shows significant and unsupported deviation from industry standards or in areas where detailed pricing is required.

**N. FAILURE TO COMPLY WITH REQUEST FOR PROPOSAL**

Violation of the terms and conditions contained in this solicitation or any resulting contract, at any time before or after the award, shall be grounds for action by the State which may include, but is not limited to, the following:

1. Rejection of a bidder's proposal;
2. Withdrawal of the Intent to Award;
3. Withdrawal of the Award;
4. Negative Vendor Performance Report(s);
5. Termination of the resulting contract;
6. Legal action; and
7. Suspension from further bidding

**O. PROPOSAL CORRECTIONS**

A bidder may correct a mistake in a proposal prior to the time of opening by uploading a revised and completed proposal if the original proposal was electronically submitted.

1. If a corrected electronic proposal is submitted, the file name(s) date/time stamped with latest date/time stamp will be accepted. The corrected proposal file name(s) should be identified as
  - a. Corrected 6663 Z1 Company Name Proposal #1,
  - b. Corrected 6663 Z1 Company Name Proposal #2, etc.

Changing a proposal after opening may be permitted if the change is made to correct a minor error that does not affect price, quantity, quality, delivery, or contractual conditions. In case of a mathematical error in extension of price, unit price shall govern.

**P. LATE PROPOSALS**

Proposals received after the proposal opening will be considered late and will not be evaluated. The State is not responsible for proposals that are late or lost regardless of cause or fault.

**Q. PROPOSAL OPENING**

The opening of proposals will be public, and the contractors will be announced. Proposals **WILL NOT** be available for viewing by those present at the proposal opening. Once proposals are opened, they become the property of the State of Nebraska and will not be returned. A Respondents List will be posted to the website.

**R. EVALUATION COMMITTEE**

Proposals are evaluated by members of an Evaluation Committee(s). The Evaluation Committee(s) will consist of individuals selected at the discretion of the State. Names of the members of the Evaluation Committee(s) will not be published.

Any contact, attempted contact, or attempt to influence an evaluator that is involved with this solicitation may result in the rejection of this proposal and further administrative actions.

**S. EVALUATION OF PROPOSALS**

All proposals that are responsive to the solicitation will be evaluated. Each evaluation category will have a maximum point potential. The State will conduct a fair, impartial, and comprehensive evaluation of all proposals in accordance with the criteria set forth below. Areas that will be addressed and scored during the evaluation include:

1. Corporate Overview should include but is not limited to:
  - a. the ability, capacity, and skill of the contractor to deliver and implement the system or project that meets the requirements of the solicitation;
  - b. the character, integrity, reputation, judgment, experience, and efficiency of the contractor;
  - c. whether the contractor can perform the contract within the specified time frame;
  - d. the quality of contractor performance on prior contracts;
  - e. such other information that may be secured and that has a bearing on the decision to award the contract;
2. Technical Approach; and,
3. Cost Proposal.

Neb. Rev. Stat. §81-161 allows the quality of performance of previous contracts to be considered when evaluating responses to competitively bid solicitations in determining the lowest responsible bidder. Information obtained from any Vendor Performance Report may be used in evaluating responses to a solicitation for goods and services to determine the best value for the State.

**Neb. Rev. Stat. §73-107 allows for a preference for a resident disabled veteran or business located in a designated enterprise zone.** When a state contract is to be awarded to the lowest responsible bidder, a resident disabled veteran or a business located in a designated enterprise zone under the Enterprise Zone Act shall be allowed a preference over any other resident or nonresident contractor, if all other factors are equal.

**Resident disabled veterans means any person (a) who resides in the State of Nebraska, who served in the United States Armed Forces, including any reserve component or the National Guard, who was discharged or otherwise separated with a characterization of honorable or general (under honorable conditions), and who possesses a disability rating letter issued by the United States Department of Veterans Affairs establishing a service-connected disability or a disability determination from the United States Department of Defense and (b)(i) who owns and controls a business or, in the case of a publicly owned business, more than fifty percent of the stock is owned by one or more persons described in subdivision (a) of this subsection and (ii) the management and daily business operations of the business are controlled by one or more persons described in subdivision(a) of this subsection. Any contract entered into without compliance with this section shall be null and void.**

Therefore, if a resident disabled veteran or business located in a designated enterprise zone submits a proposal in accordance with Neb. Rev. Stat. §73-107 and has so indicated on the solicitation cover page under "Contractor must

complete the following” requesting priority/preference to be considered in the award of this contract, the following will need to be submitted by the contractor within ten (10) business days of request:

Documentation from the United States Armed Forces confirming service;  
Documentation of discharge or otherwise separated characterization of honorable or general (under honorable conditions);  
Disability rating letter issued by the United States Department of Veterans Affairs establishing a service-connected disability or a disability determination from the United States Department of Defense; and  
Documentation which shows ownership and control of a business or, in the case of a publicly owned business, more than fifty percent of the stock is owned by one or more persons described in subdivision (a) of this subsection; and the management and daily business operations of the business are controlled by one or more persons described in subdivision (a) of this subsection.

Failure to submit the requested documentation within ten (10) business days of notice will disqualify the contractor from consideration of the preference.

Evaluation criteria will be released with the RFP.

**T. PRESENTATIONS AND/OR DEMONSTRATIONS**

The State may determine after the completion of the Technical and Cost Proposal evaluation that presentations and/or demonstrations are required. Not every bidder may be given an opportunity to present and/or give demonstrations. The State reserves the right, in its discretion, to select only the top scoring bidders to present/give demonstrations. The evaluations from the presentations and/or demonstrations will be added to the scores from the Technical and Cost Proposals. The presentation process will allow the bidders to demonstrate proposal offering, explaining and/or clarifying any unusual or significant elements related to the proposal(s). Bidders’ key personnel, identified in the proposal, may be requested to participate in a structured presentation. The presentation will determine the bidders understanding of the RFP requirements, demonstrating the authority and reporting relationships within the firm, including management style and philosophy. Only representatives of the State and the presenting bidder will be permitted to attend the presentations and/or demonstrations. A written copy or summary of the presentation, and demonstrative information (such as briefing charts, et cetera) may be offered by the bidder, but the State reserves the right to refuse or not consider the offered materials. Bidders shall not be allowed to alter or amend proposals.

Once the presentations and/or demonstrations have been completed, the State reserves the right to make an award without any further discussion with the bidders regarding the proposals received.

Any cost incidental to the presentations and/or demonstrations shall be borne entirely by the bidder and will not be compensated by the State.

**U. BEST AND FINAL OFFER**

Bidder should provide the best offer with the original proposal response and should not expect the State to request a best and final offer (BAFO).

Every bidder may not be given the opportunity to submit a BAFO. Any BAFO requested by the State, should be submitted by the bidder to be evaluated (using the stated BAFO criteria) and scored by the Evaluation Committee. The State reserves the right to conduct more than one BAFO. If requested by the State, the BAFO must be submitted on the BAFO Cost Proposal form. Failure to submit a requested BAFO may result in rejection of the bidder’s entire proposal response.

**V. REFERENCE AND CREDIT CHECKS**

The State reserves the right to conduct and consider reference and credit checks. The State reserves the right to use third parties to conduct reference and credit checks. By submitting a proposal in response to this solicitation, the bidder grants to the State the right to contact or arrange a visit in person with any or all of the bidder’s clients. Reference and credit checks may be grounds to reject a proposal, withdraw an intent to award, or rescind the award of a contract.

**W. AWARD**

The State reserves the right to evaluate proposals and award contracts in a manner utilizing criteria selected at the State's discretion and in the State’s best interest. After evaluation of the proposals, or at any point in the solicitation process, the State of Nebraska may take one or more of the following actions:

1. Amend the solicitation;
2. Extend the time of or establish a new proposal opening time;

3. Waive deviations or errors in the State's solicitation process and in proposals that are not material, do not compromise the solicitation process or a bidder's proposal, and do not improve a bidder's competitive position;
4. Accept or reject a portion of or all of a proposal;
5. Accept or reject all proposals;
6. Withdraw the solicitation;
7. Elect to rebid the solicitation;
8. Award single lines or multiple lines to one or more bidders; or,
9. Award one or more all-inclusive contracts.

Any protests must be filed by a bidder within ten (10) business days after the Intent to Award is posted. Grievance and protest procedure is available at: <http://das.nebraska.gov/materiel/purchasing.html>

**X. ALTERNATE/EQUIVALENT PROPOSALS**

Bidder may offer proposals which are at variance from the specifications of the solicitation. The State reserves the right to consider and accept such proposals if, in the judgment of the Materiel Administrator, the proposal will result in goods and/or services equivalent to or better than those which would be supplied in the original proposal specifications. Bidder must indicate in the solicitation response the manufacturer's name, number and shall submit with the proposal, sketches, descriptive literature and/or complete specifications. Reference to literature submitted with a previous proposal or any other agreement/contract will not satisfy this provision. Proposals which do not comply with these requirements are subject to rejection. In the absence of any stated deviation or exception, the proposal will be accepted as in strict compliance with all terms, conditions and specification, and the Bidder shall be held liable, therefore.

**Y. REJECTION OF PROPOSALS**

The State reserves the right to reject any or all proposals, wholly or in part.

**Z. RESIDENT BIDDER**

Pursuant to Neb. Rev. Stat. §§ 73-101.01 through 73-101.02, a Resident Bidder shall be allowed a preference against a Non-resident Bidder from a state which gives or requires a preference to Bidders from that state. The preference shall be equal to the preference given or required by the state of the Nonresident Bidders. Where the lowest responsible bid from a resident Bidder is equal in all respects to one from a nonresident Bidder from a state which has no preference law, the resident Bidder shall be awarded the contract. The provision of this preference shall not apply to any contract for any project upon which federal funds would be withheld because of the provisions of this preference.

**II. TERMS AND CONDITIONS**

**Bidders should complete Sections II through VI as part of the proposal.** Bidder is expected to read the Terms and Conditions and initial either accept, reject, or reject and provide alternative language for each clause. The bidder should also provide an explanation of why the clause was rejected or why the clause was rejected with alternative language provided. By signing the solicitation, bidder is agreeing to be legally bound by all the accepted terms and conditions, and any proposed alternative terms and conditions submitted with the proposal. The State reserves the right to reject or negotiate the bidder's rejected or proposed alternative language.

**If the State and bidder fail to agree on the final Terms and Conditions, the State reserves the right to reject the proposal. The State reserves the right to reject proposals that attempt to substitute the bidder's commercial contracts and/or documents for this solicitation.**

Bidders must submit with the proposal any license, user agreement, service level agreement, or similar documents that the bidder wants incorporated in the Contract. The State will not consider incorporation of any document not submitted with the bidder's proposal. These documents shall be subject to negotiation and will be incorporated as addendums if agreed to by the Parties.

If a conflict or ambiguity arises after the Addendum to Contract Award has been negotiated and agreed to, the Addendum to Contract Award shall be interpreted as follows:

1. If only one Party has a particular clause, then that clause shall control;
2. If both Parties have a similar clause, but the clauses do not conflict, the clauses shall be read together;
3. If both Parties have a similar clause, but the clauses conflict, the State's clause shall control.

**A. GENERAL**

The Contract resulting from this solicitation shall incorporate the following documents:

These documents constitute the entirety of the contract.

Any ambiguity or conflict in the contract discovered after its execution, not otherwise addressed herein, shall be resolved in accordance with the rules of contract interpretation as established in the State of Nebraska.

Contractor and State shall identify the contract manager who shall serve as the point of contact for the executed contract.

Communications regarding the executed contract shall be in writing and shall be deemed to have been given if delivered personally, electronically or mailed. All notices, requests, or communications shall be deemed effective upon receipt.

**C. PCO'S REPRESENTATIVE**

The State reserves the right to appoint a PCO's Representative to manage [or assist the PCO in managing] the contract on behalf of the State. The PCP's Representative will be appointed in writing, and the appointment document will specify the extent of the PCO's Representative authority and responsibilities. If a PCO's Representative is appointed, the Contractor will be provided a copy of the appointment document and is required to cooperate accordingly with the PCO's Representative. The PCO's Representative has no authority to bind the State to a contract, amendment, addendum, or other change or addition to the contract.

**D. GOVERNING LAW (Statutory)**

Notwithstanding any other provision of this contract, or any amendment or addendum(s) entered into contemporaneously or at a later time, the parties understand and agree that, (1) the State of Nebraska is a sovereign state and its authority to contract is therefore subject to limitation by the State's Constitution, statutes, common law, and regulation; (2) this contract will be interpreted and enforced under the laws of the State of Nebraska; (3) any action to enforce the provisions of this agreement must be brought in the State of Nebraska per state law; (4) the person signing this contract on behalf of the State of Nebraska does not have the authority to waive the State's sovereign immunity, statutes, common law, or regulations; (5) the indemnity, limitation of liability, remedy, and other similar provisions of the final contract, if any, are entered into subject to the State's Constitution, statutes, common law, regulations, and sovereign immunity; and, (6) all terms and conditions of the final contract, including but not limited to the clauses concerning third party use, licenses, warranties, limitations of liability, governing law and venue, usage verification, indemnity, liability, remedy or other similar provisions of the final contract are entered into specifically subject to the State's Constitution, statutes, common law, regulations, and sovereign immunity.

The Parties must comply with all applicable local, state and federal laws, ordinances, rules, orders, and regulations.

**E. BEGINNING OF WORK**

The awarded Bidder shall not commence any billable work until a valid contract has been fully executed by the State. The awarded Bidder will be notified when work may begin.

**F. AMENDMENT**

This Contract may be amended only in writing, within scope, upon the agreement of both parties.

**G. CHANGE ORDERS OR SUBSTITUTIONS**

The State and the Contractor, upon the written agreement, may make changes to the contract within the general scope of the solicitation. Corrections of any deliverable, service, or work required pursuant to the contract shall not be deemed a change. The Contractor may not claim forfeiture of the contract by reasons of such changes.

The Contractor shall prepare a written description of the work required due to the change and an itemized cost sheet for the change. Changes in work and the amount of compensation to be paid to the Contractor shall be determined in accordance with applicable unit prices if any, a pro-rated value, or through negotiations. The State shall not incur a price increase for changes that should have been included in the Contractor's proposal, were foreseeable, or result from difficulties with or failure of the Contractor's proposal or performance.

No change shall be implemented by the Contractor until approved by the State, and the Contract is amended to reflect the change and associated costs, if any. If there is a dispute regarding the cost, but both parties agree that immediate implementation is necessary, the change may be implemented, and cost negotiations may continue with both Parties retaining all remedies under the contract and law.

In the event any product is discontinued or replaced upon mutual consent during the contract period or prior to delivery, the State reserves the right to amend the contract to include the alternate product at the same price.

The Contractor agrees to defend, indemnify, and hold harmless the State and its employees, volunteers, agents, and its elected and appointed officials (“the indemnified parties”) from and against any and all third party claims, liens, demands, damages, liability, actions, causes of action, losses, judgments, costs, and expenses of every nature, including investigation costs and expenses, settlement costs, and attorney fees and expenses (“the claims”), sustained or asserted against the State for personal injury, death, or property loss or damage, arising out of, resulting from, or attributable to the willful misconduct, negligence, error, or omission of the Contractor, its employees, subcontractors, consultants, representatives, and agents, resulting from this contract, except to the extent such Contractor liability is attenuated by any action of the State which directly and proximately contributed to the claims.

**2. PERSONNEL**

The Contractor shall, at its expense, indemnify and hold harmless the indemnified parties from and against any claim with respect to withholding taxes, worker’s compensation, employee benefits, or any other claim, demand, liability, damage, or loss of any nature relating to any of the personnel, including subcontractors and employees, provided by the Contractor.

**3. SELF-INSURANCE**

The State of Nebraska is self-insured for any loss and purchases excess insurance coverage pursuant to Neb. Rev. Stat. § 81-8,239.01 (Reissue 2008). If there is a presumed loss under the provisions of this agreement, Contractor may file a claim with the Office of Risk Management pursuant to Neb. Rev. Stat. §§ 81-8,829 – 81-8,306 for review by the State Claims Board. The State retains all rights and immunities under

the State Miscellaneous (§81-8,294), Tort (§81-8,209), and Contract Claim Acts (§81-8,302), as outlined in Neb. Rev. Stat. § 81-8,209 et seq. and under any other provisions of law and accepts liability under this agreement to the extent provided by law.

**4. ATTORNEY GENERAL**

The Parties acknowledge that Attorney General for the State of Nebraska is required by statute to represent the legal interests of the State, and that any provision of this indemnity clause is subject to the statutory authority of the Attorney General.



The Contractor is solely responsible for fulfilling the contract. The Contractor or the Contractor's representative shall be the sole point of contact regarding all contractual matters.

The Contractor shall secure, at its own expense, all personnel required to perform the services under the contract. The personnel the Contractor uses to fulfill the contract shall have no contractual or other legal relationship with the State; they shall not be considered employees of the State and shall not be entitled to any compensation, rights or benefits from the State, including but not limited to, tenure rights, medical and hospital care, sick and vacation leave, severance pay, or retirement benefits.

By-name personnel commitments made in the Contractor's proposal shall not be changed without the prior written approval of the State. Replacement of these personnel, if approved by the State, shall be with personnel of equal or greater ability and qualifications.

All personnel assigned by the Contractor to the contract shall be employees of the Contractor or a subcontractor and shall be fully qualified to perform the work required herein. Personnel employed by the Contractor or a subcontractor to fulfill the terms of the contract shall remain under the sole direction and control of the Contractor or the subcontractor respectively.

With respect to its employees, the Contractor agrees to be solely responsible for the following:

1. Any and all pay, benefits, and employment taxes and/or other payroll withholding;
2. Any and all vehicles used by the Contractor's employees, including all insurance required by state law;
3. Damages incurred by Contractor's employees within the scope of duties under the contract;
4. Maintaining Workers' Compensation and health insurance that complies with state and federal law and submitting any reports on such insurance to the extent required by governing law;
5. Determining the hours to be worked and the duties to be performed by the Contractor's employees; and,
6. All claims on behalf of any person arising out of employment or alleged employment (including without limit claims of discrimination alleged against the Contractor, its officers, agents, or subcontractors or subcontractor's employees)

If the Contractor intends to utilize any subcontractor, the subcontractor's level of effort, tasks, and time allocation should be clearly defined in the bidder's proposal. The Contractor shall agree that it will not utilize any subcontractors not specifically included in its proposal in the performance of the contract without the prior written authorization of the State.

The State reserves the right to require the Contractor to reassign or remove from the project any Contractor or subcontractor's employees.

Contractor shall insure that the terms and conditions contained in any contract with a subcontractor does not conflict with the terms and conditions of this contract.

The Contractor shall include a similar provision, for the protection of the State, in the contract with any subcontractor engaged to perform work on this contract.

Rev. Stat. §§ 48-1101 to 48-1125). The Contractor guarantees compliance with the Nebraska Fair Employment Practice Act, and breach of this provision shall be regarded as a material breach of contract. In the event that any policy written on a claims-made basis terminates or is canceled during the term of the contract or within six (6) months of termination or expiration of the contract, the contractor shall obtain an extended discovery or reporting period, or a new insurance policy, providing coverage required by this contract for the term of the contract and six (6) months following termination or expiration of the contract.

If by the terms of any insurance a mandatory deductible is required, or if the Contractor elects to increase the mandatory deductible amount, the Contractor shall be responsible for payment of the amount of the deductible in the event of a paid claim.

Notwithstanding any other clause in this Contract, the State may recover up to the liability limits of the insurance policies required herein.

**1. WORKERS' COMPENSATION INSURANCE**

The Contractor shall take out and maintain during the life of this contract the statutory Workers' Compensation and Employer's Liability Insurance for all of the contractors' employees to be engaged in work on the project under this contract and, in case any such work is sublet, the Contractor shall require the subcontractor similarly to provide Worker's Compensation and Employer's Liability Insurance for all of the subcontractor's employees to be engaged in such work. This policy shall be written to meet the statutory requirements for the state in which the work is to be performed, including Occupational Disease. **The policy shall include a waiver of subrogation in favor of the State. The COI shall contain the mandatory COI**

**subrogation waiver language found hereinafter.** The amounts of such insurance shall not be less than the limits stated hereinafter. For employees working in the State of Nebraska, the policy must be written by an entity authorized by the State of Nebraska Department of Insurance to write Workers' Compensation and Employer's Liability Insurance for Nebraska employees.

**2. COMMERCIAL GENERAL LIABILITY INSURANCE AND COMMERCIAL AUTOMOBILE LIABILITY INSURANCE**

The Contractor shall take out and maintain during the life of this contract such Commercial General Liability Insurance and Commercial Automobile Liability Insurance as shall protect Contractor and any subcontractor performing work covered by this contract from claims for damages for bodily injury, including death, as well as from claims for property damage, which may arise from operations under this contract, whether such operation be by the Contractor or by any subcontractor or by anyone directly or indirectly employed by either of them, and the amounts of such insurance shall not be less than limits stated hereinafter.

The Commercial General Liability Insurance shall be written on an **occurrence basis**, and provide Premises/Operations, Products/Completed Operations, Independent Contractors, Personal Injury, and Contractual Liability coverage. **The policy shall include the State, and others as required by the contract documents, as Additional Insured(s). This policy shall be primary, and any insurance or self-insurance carried by the State shall be considered secondary and non-contributory. The COI shall contain the mandatory COI liability waiver language found hereinafter.** The Commercial Automobile Liability Insurance shall be written to cover all Owned, Non-owned, and Hired vehicles.

**B. TAXES (Statutory)**

The State is not required to pay taxes and assumes no such liability as a result of this solicitation. The Contractor may request a copy of the Nebraska Department of Revenue, Nebraska Resale or Exempt Sale Certificate for Sales Tax Exemption, Form 13. Any property tax payable on the Contractor's equipment which may be installed in a state-owned facility is the responsibility of the Contractor.

Final inspection and approval of all work required under the contract shall be performed by the designated State officials.

The State and/or its authorized representatives shall have the right to enter any premises where the Contractor or subcontractor duties under the contract are being performed, and to inspect, monitor or otherwise evaluate the work being performed. All inspections and evaluations shall be at agreed upon times and in a manner that will not delay work.

**D. PAYMENT (Statutory)**

Payment will be made by the responsible agency in compliance with the State of Nebraska Prompt Payment Act (See Neb. Rev. Stat. § 81-2403). The State may require the Contractor to accept payment by electronic means such as ACH deposit. In no event shall the State be responsible or liable to pay for any goods and services provided by the Contractor prior to the Effective Date of the contract, and the Contractor hereby waives any claim or cause of action for any such services.

**E. LATE PAYMENT (Statutory)**

The Contractor may charge the responsible agency interest for late payment in compliance with the State of Nebraska Prompt Payment Act (See Neb. Rev. Stat. §§ 81-2401 through 81-2408).

**F. SUBJECT TO FUNDING / FUNDING OUT CLAUSE FOR LOSS OF APPROPRIATIONS (Statutory)**

The State's obligation to pay amounts due on the Contract for a fiscal years following the current fiscal year is contingent upon legislative appropriation of funds. Should said funds not be appropriated, the State may terminate the contract with respect to those payments for the fiscal year(s) for which such funds are not appropriated. The State will give the Contractor written notice 30 calendar days prior to the effective date of termination. All obligations of the State to make payments after the termination date will cease. The Contractor shall be entitled to receive just and equitable compensation for any authorized work which has been satisfactorily completed as of the termination date. In no event shall the Contractor be paid for a loss of anticipated profit.

**G. RIGHT TO AUDIT (Statutory)**

The State shall have the right to audit the Contractor's performance of this contract upon a 30 days' written notice. Contractor shall utilize generally accepted accounting principles, and shall maintain the accounting records, and other records and information relevant to the contract to enable the State to audit the contract. (Neb. Rev. Stat. § 84-304 et seq.) The State may audit, and the Contractor shall maintain, the Information during the term of the contract and for a period of five (5) years after the completion of this contract or until all issues or litigation are resolved, whichever is later. The Contractor shall make the Information available to the State at Contractor's place of business or a location acceptable to both Parties during normal business hours. If this is not practical or the Contractor so elects, the Contractor may provide electronic or paper copies of the Information. Under no circumstance will the Contractor be required to create or maintain documents not kept in the ordinary course of contractor's business operations, nor will contractor be

required to disclose any information, including but not limited to product cost data, which is confidential or proprietary to contractor.

## V. PROJECT DESCRIPTION AND SCOPE OF WORK

### Eugene T. Mahoney Summer and Winter Theater Melodrama Production

#### A. Scope of Services

##### 1. Introduction

The Nebraska Game and Parks Commission (Commission) is seeking proposals for a qualified contractor to produce and direct family-oriented melodramas for the entertainment of the public at the Denman and Mary Mallory Kountze Memorial Theater located at Eugene T. Mahoney State Park for the summer and winter season.

Eugene T. Mahoney State Park offers year-round accommodations and recreational use. Located near Ashland, just off Interstate 80 at exit 426, Mahoney is nestled on 690 acres along the picturesque Platte River. The Park offers a spectacular array of camping, lodging, group meeting facilities and activities for the public. Visitors can enjoy a wide variety of entertainment, including a water park complete with wave pool and water slides, horseback riding, a miniature golf and driving range, fishing, paddle boating and ice skating. The Denman and Mary Mallory Kountze Memorial Theater is located centrally in the park approximately 1/8th of a mile from the main lodge.

The Denman and Mary Mallory Kountze Memorial Theater is located centrally in the park approximately 1/8th of a mile from the main lodge. The facility is an indoor, climate controlled, traditional theater, seating 165 audience members comfortably.

##### 2. Operations of the Theater

###### a. Contractor's Responsibilities:

- iii. Stage direction, stage lighting, sound amplification, special effect direction, music selection and direction;
- iv. Selection of scripts (with approval of Park Superintendent), cast selection, melodrama direction, costuming (including the cleaning of costumes), makeup, program design and printing, lighting and equipment control, set design, music selection, musician selection and equipment;
- v. Payment of all applicable copyright or licensing fees and royalties associated with performances and musical selections used, as outlined by companies holding rights to such selections;
- vi. Promotion and advertising of productions. Contractor must consult with Park Superintendent on how to best publicize the theater productions and for approval of all printed advertising material before circulation.;
- vii. Promotion of the park and facilities both verbally and with printed materials provided by the Commission;
- viii. Repainting/staining of set and support props.
- ix. Daily housekeeping, custodial services and trash removal for the stage, dressing rooms, and prop rooms within the facility;
- x. Securing and inspecting the theater building at the end of each performance;
- xi. Consulting with the Park Superintendent prior to any permanent modifications to the theater building, stage, seating area, storage areas or related facilities;
- xii. Meeting all terms and payment provisions of any subcontracted work entered into by the Contractor; and,
- xiii. Use of theater props stored in the basement requires written permission of the Park Superintendent, and damaged items must be replaced.

###### b. Commission Responsibilities

- i. Provide access to, and use of, the theater building to the Contractor for production of shows and set construction;
- ii. Review the content of all melodramas or scripts. It is understood by the parties that theater productions are to be family friendly entertainment, suitable for the entire family.;
- iii. Review/approve all set modifications. Set modifications may be arranged with the Commission, but all support props are the responsibility of the Contractor. All set construction is the responsibility of the Commission. All set construction costs are subject to review by the Park Superintendent for consideration of budgetary limits. Construction debris and materials shall be cleaned up daily, storage of construction materials within the theater will be minimized and storage areas will be mutually agreed to between the parties.;
- iv. Provide a safe and comfortable environment for theatergoers;
- v. Theater box office management;



- vi. Order and sell tickets at park offices and theater concession stand, document and account for all ticket sales;
- vii. Concession stand operation and directing theater guests to their seats;
- viii. Provide and maintain appropriate sound and lighting equipment, and a piano to be used in theater productions;
- ix. Maintain theater facility and the surrounding grounds;
- x. Clean and maintain all areas of the theater facility, with the exception of the stage, dressing room area and prop room;
- xi. Payment of basic utility (electric, gas and trash removal) of the theater facility, exclusive of costs associated with unique lighting needs for productions, phone and internet services;
- xii. Cooperative marketing within the Commission's facilities, social media outlets, website or printed materials. Commission shall approve content for any advertising with Commission facilities or materials.;
- xiii. Provide a separate lock/ key or the two (2) dressing rooms located backstage for securing personal belongings The Commission is not responsible for any personal belongings left within the dressing rooms. A key will also be provided to the Park Superintendent so the area can be accessed for repairs or emergencies. Keys will be issued to the Contractor at the start of the contract and keys must be returned at the conclusion of the contract. Contractor will be responsible for replacement costs associated with lost keys or rekeying of lock sets.

**3. Summer Performances**

- a. Contractor agrees to stage a minimum of one melodrama performance per day on the schedule listed below. Rotating between three melodramas from May 26, of each contract year through August 13, of each contract year.
  - i. Performances will run Tuesdays, Wednesdays, Fridays, and Saturdays at 7:30pm and Sundays at 3:00pm;
  - ii. The theater will be closed to customers on Mondays and Thursdays;
  - iii. The fourth melodrama will be staged Fridays and Saturdays at 7:30pm and Sundays at 3:00pm from August 18 – October 22, of each year of the Contract period.
- b. Either party may agree to stage more shows if:
  - i. Doing so will not interfere with other theater uses;
  - ii. It will result in greater efficiency in the operation of the theater; and,
  - iii. Public demand for additional performances is adequately met. Starting times and days of the week for the performances may be adjusted by consultation by the parties.
- c. Summer Ticket prices are set by the Commission. Ticket prices for each summer performance will be:
  - i. no less than \$9.00 for adults,
  - ii. no less than \$7.00 for children 12 years and under,
  - iii. no less than \$28.00 Family Package (Family package includes 2 adult and 2 children).
- d. Winter Ticket Prices are set by the Commission. Ticket prices for each Winter performance will be:
  - i. no less than \$10.00 for adults
  - ii. no less than \$8.00 for children 12 years and under;
- e. Park Superintendent must receive a list of desired rehearsal dates from the Contractor prior to rehearsals for review of scheduling considerations.
- f. Past summer attendances are:
  - i. 2015 Season – Adults: 4,465 and Children: 773 Family Package: 674;
  - ii. 2016 Season – Adults: 5,091 and Children: 736 Family Package: 608
  - iii. 2017 Season – Adults: 5,520 and Children: 704 Family Package: 653
  - iv. 2018 Season – Adults: 5,694 and Children: 840 Family Package: 747
  - v. 2019 Season – Adults: 5,999 and Children: 911 Family Package: 792
  - vi. 2020 Season – Adults: 0 and Children: 0 \*(2020 season closed due to COVID19)
  - vii. 2021 Season – Adults: 4,389 and Children: 645 Family Package: 545
- g. Performances may be cancelled due to weather conditions, when the Park Superintendent and the Contractor agree that a cancellation of the performance is warranted.

**4. Winter Performances**

- a. Contractor agrees to stage a minimum of one performance a Month on either Friday or Saturday's starting November 26, of each contract year through May 21, of each contract year.
- b. Either party may agree to stage more shows if:
  - i. Doing so will not interfere with other theater uses;

- ii. It will result in greater efficiency in the operation of the theater; and,
- iii. Public demand for additional performances is adequately met.
- c. Starting times and days of the week for the performances shall be mutually agreed to by the parties.
- d. Park Superintendent must receive a list of desired rehearsal dates from the Contractor prior to rehearsals for review of scheduling considerations.
- e. Past winter attendances are:
  - i. 2018-2019 Adults: 518 Children: 222 (12 total shows)
  - ii. 2019-2020 Adults: 244 Children: 117 (7 total shows)
  - iii. 2020-2021 Adults: 0 Children: 0 (No Shows due to Covid)
  - iv. 2021-2022 Adults: 75 Children: 40 (Through shows 2 of 7)
- f. Performances may be cancelled due to weather conditions, when the Park Superintendent and the Contractor agree that a cancellation of the performance is warranted.

**5. Financial Arrangement**

- a. Gross receipts shall include all receipts from ticket sales, except refunded sales, for performances.
- b. Gross receipts shall not include receipts from the sale of concessions.
- c. Gross receipts shall be totaled on a nightly basis and shall include receipts of pre-sold tickets for each performance.
- d. A record shall be kept of all ticket sales for each performance.
- e. Contractor shall be allotted no more than four (4) complimentary tickets for each performance. Complimentary tickets shall not be included in the gross receipts for the night.
- f. Gross receipts shall be determined by the Commission on a weekly basis each Monday, during the theater season, for the performances from the previous week's shows. After such determination is made, payment will be made upon receipt of an invoice from the Contractor, per quoted prices.

Who can help our lovely damsels and their cuddly reptile? Hopefully, Orlando, a mysterious and handsome wandering minstrel, will be able to save the day!

Something's Rotten in Green Bend: Spunky Holly Hathaway, who loves all things Shakespeare and her job managing the Green Bend Community Theater, is thrilled that an actual Shakespeare Troupe is coming to town! However, she is about to find that the Marlowe Family Players come with drama of their own. Will the domineering Viola Marlowe be too much for our

heroine to handle? Will good-hearted, handsome, talented Billy Marlowe open Holly's eyes to possibilities she hadn't expected? And will spoiled, ruthless Monty Marlowe ruin everything for them all?

Rustlers of Red Rock: A classic western. Lovely young rancher Blossom White and all of Red Rock County is suffering from a rash of rustling run by the notorious bad man Black Bart Bushwacker. Only handsome ranch hand Steve Dashing can save her, but will he be too late?

- d. Describe theater productions the bidder has directed or produced.

Bidder Response:

I have directed and produced over 15 family-friendly melodramas at Eugene T. Mahoney State Park. Additionally, I have directed and produced several middle and high school level play productions and musicals. Prior to my experience in education, I also worked with Optimist International, a non-profit organization, to produce traveling Shakespeare shows with at-risk youth in the community. I grew up attending melodramas at Eugene T. Mahoney State Park and look forward to continuing the tradition of fun family-friendly entertainment and inspiring other young actors.

- e. Explain bidder's knowledge and experience in cast selection.

Bidder Response:

We have successfully cast productions for the Melodramas at Eugene T. Mahoney State Park since 1993. For our current productions we will be using a cast of five actors, plus a piano player, for the summer. One show will have six actors and a piano player. Criteria casting requires knowledge of theatrical staging and an ability to improvise during the audition process. In addition to the cast we also utilize a Master of Ceremonies who introduces the show, serves as stage manager and technical operator.

- f. List bidder's experience with stage props, lighting, and sound application.

Bidder Response:

We have successfully designed and maintained stage designs, stage props, designed lighting plots and sound plots for the melodramas at Eugene T. Mahoney State Park since 1993. In addition, we have worked with the park to continue to update the lighting to be safer and more cost efficient.

- g. Provide experience of selection and maintenance of costumes and make up.

Bidder Response:

We require our actors to be responsible for their own makeup needs unless a specialty makeup is required. The Director works with the cast on makeup and hair designs for each character. For the past three seasons we have bought costumes from a costume house in Elkhorn, Nebraska for our shows. Maintenance of the costumes is a responsibility assumed by the company and any required repairs are done by the costume house.

- h. Bidder acknowledges they can contact the Park Superintendent for any clarifications regarding park laws and regulations established by the Commission.

Bidder Response:

Yes. Working with the Park Superintendent, Jake Rodiek, has been a very easy experience as he has always been able to answer any questions we have had in regards to park laws and regulations established by the Commission. We have enjoyed partnering with Eugene T. Mahoney State Park since 1993.


