Dilution Ratio - TBD (determined by customer)

Yield Factor – Determined by Dilution Ratio

Locations are using our Folgers liquid coffee today. The liquid coffee will stay the same if the State of Nebraska decides to move forward with US Foods and the Premier program.

Ratio Examples

At a ratio of 28:1, a case (2/2 L) of our liquid coffee will dispense 3,921 ounces of brewed coffee.

At a ratio of 30:1, a case (2/2 L) of our liquid coffee will dispense 4,191 ounces of brewed coffee.

At a ratio of 32:1, a case (2/2 L) of our liquid coffee will dispense 4,461 ounces of brewed coffee.

The ratios can be adjusted on our liquid coffee equipment.
