The Parties shall pay their own costs of the audit unless the audit finds a previously undisclosed overpayment by the State. #### V. PROJECT DESCRIPTION AND SCOPE OF WORK

#### A. PROJECT OVERVIEW

Nebraska Educational Telecommunications Commission (NETC) plans to expand its network of FM radio stations across the state of Nebraska by adding three additional full power class C3 radio stations, KGNE-FM, KUNE-FM, and KNNE-FM. The locations of these three new stations will be Broken Bow, NE, Columbus, NE, and McCook, NE. Construction permits for these stations were obtained as a result of the FCC's November 2021 NCE FM filing window. Due to staffing shortages, NETC is seeking the services of a contract engineer through this RFP document to assist with the project management and construction of these stations before the FCC Construction Permits expire in early 2025.

#### B. CURRENT ENVIRONMENT

NETC currently has FM translators for the Columbus and McCook markets. These translators will be turned off when the full power stations are put on the air. For Columbus, NETC is currently in negotiations with Vertical Bridge REIT, LLC regarding tower space. For Broken Bow, the new FM station will utilize space on a tower owned by Great Plains Communications, and the McCook station will be placed on a tower owned by NETC.

NETC distributes programming for its main/HD1 and HD2 channels via terrestrial IP and each of its full power sites has terminal and processing equipment in place that completes the air chain and routes audio into the transmitter. This is a pre-planned design that is common across all NETC owned sites. The contractor hired will build to this specification with equipment purchased by NETC.

#### C. SCOPE OF WORK

Consultant will provide overall project management for build out of the three FM sites. A complete project schedule will be created, managed, and maintained by the consultant.

Initial site visit: Consultant to come on site and tour the three sites plus an additional site that NETC has completed. This site visit may take up to a week of time as soon as the contract is signed.

Project management and consulting assistance. May include: Initial observations, reports, tour report, weekly updates/reports, commissioning reports and assistance with communication between client and vendors, equipment build out, and commissioning.

Contractor shall be responsible for installation, commissioning, and testing of equipment needed for site build out. Considering integration with existing equipment, the staging location is likely to be at the three FM sites.

The goal of this project is for the consultant to build out three FM Full power sites as per NETC's specifications. NETC staff has done the groundwork of selecting the FM transmitting antennas and transmitters and will work with the consultant on delivery dates for those items. NETC is also responsible for signal delivery to the sites. It will be the consultant's responsibility to build out the air chain at each site.

For Broken Bow and McCook sites: a minimum of one week on-site after the antenna and transmission lines installed. This must include FM RF Spectrum Analysis. Include option for a second contiguous week per site. For Columbus, if AM tower is used, must include pre-construction AM base current readings, a minimum of one week plus one extended week on-site after antenna and transmission line installed. Must include FM RF spectrum analysis and post-construction AM base current readings. However, the exact duration of on-site work before and after RF installations may vary at the discretion of the contractor, with the goal of maximizing efficiency.

Consultant is not necessarily responsible for ordering equipment. NETC staff will assist with that process. Consultant will be responsible for mounting equipment, rack assembly, and wiring the equipment as per NETC provided drawings and specifications. The consultant should have the equipment racks and associated equipment at all three sites built as similarly as possible.

NETC will provide consultant a list of vendor contacts and other information so they can interact with vendors.

Consultant will be allowed to hire independent contractors if needed. If independent contractors are used, they will be directed by the consultant in their day-to-day work.

NETC will obtain local electrical contractors to furnish the electrical power needs and requirements for each site.

#### D. DELIVERABLES

- 1. Consultant shall provide overall project management and construction of the three FM stations, as outlined in the aforementioned statement of work (SOW), which includes developing project schedules, check list, and conducting periodic meetings with client.
- 2. Consultant shall deliver as-built drawings and documentation for each site, containing site-specific information on installation, configuration, test data, commissioning, and any modifications warranting future improvements.

#### VI. PROPOSAL INSTRUCTIONS

This section documents the requirements that should be met by bidders in preparing the Technical and Cost Proposal. Bidders should identify the subdivisions of "Project Description and Scope of Work" clearly in their proposals; failure to do so may result in disqualification. #### SCOPE OF WORK

### PROJECT: FM TRANSMITTER SYSTEM PROJECT MANAGEMENT, ASSEMBLY, INSTALLATION, COMMISSIONING AND TESTING CONSULTATION

#### 1. INTRODUCTION

- 1.1. Goal: Nebraska Educational Telecommunications Commission (NETC) has three existing FM cp's that need to be built out and commissioned prior to expiration in early 2025.
  - 1.1.1. KGNE 207C3 89.3, Broken Bow NE, at 262 ft AGL on ASRN1292659 owned by Great Plains Communications with 12kW ERP and a nondirectional antenna. CP expires 1/31/2025
  - 1.1.2. KUNE 204C3 88.7, Columbus NE, at 190 ft AGL on ASRN1040699, AM tower owned by County of Platte NE and managed by Vertical Bridge with 10kW ERP and a directional antenna. CP expires 3/1/2025
  - 1.1.3. KNNE 214C3 90.7, McCook NE, at 230 ft AGL on ASRN1027242 owned by Nebraska ETC with 275 Watts H pol, 11kW V pol ERP and a nondirectional antenna. CP expires 2/11/2025

#### 2. PROJECT MANAGEMENT

- 2.1. Scope OTA RF will provide overall project management for the three FM station build outs including vendor communication, input rack build-outs, overall system installation, testing, and commissioning. We will manage the project such that NETC interface with vendors and site contractors is kept to a minimum. Most answers needed from NETC are to be answered during periodic meetings.
- 2.2. Periodic status meetings OTA RF will hold periodic meetings with NETC to provide them status updates and a forum for project questions and answers. The use of a consistent periodic meeting format provides rapid solution of potential problems and gives each party faith in the outcome of the project.
- 2.3. Schedule A complete project schedule will be prepared and continually updated with new information by OTA RF to ensure timely execution and transparency to the customer.

#### 3. SYSTEM DESIGN, VENDOR SELECTION AND MANAGEMENT

- 3.1. Site surveys Trips to NETC main studio, an existing FM site, and the three new FM sites will be made, dimensions and photos will be taken, so that prior to any design work on the project a full understanding of the systems and sites is known. These surveys will be scheduled as soon as the contract is signed between the parties.
- 3.2. Input equipment A detailed review of the NETC supplied input equipment layout and selections will be undertaken to ensure that it provides what the customer expects and includes all the updates derived from prior station construction. NETC will supply OTA RF a list of vendor contacts and other vendor information so that they can interact on their behalf to order and manage delivery of the items for the three sites. It is NETC's intention to have



the equipment racks and associated equipment at all three sites be as similar as possible.

- 3.3. Transmitter NETC has selected Nautel as the vendor of choice and has a purchasing plan in place. OTA RF will specify the required TPO and ensure that the transmitter and its ancillary components operate as expected. OTA RF will manage the order and delivery of each transmitter such that it arrives on time as ordered.
- 3.4. Antenna OTA RF will oversee the antenna system design at each site, prepare a specification, obtain competitive bids and make a recommendation based on the specification for each site. NETC will have the ultimate say in the selection of the vendor. OTA RF will manage the order and delivery of each antenna such that it arrives on time as ordered.
- 3.5. Transmission line (FM Isolator at Columbus) OTA RF will oversee the transmission line design at each site, prepare a specification, obtain competitive bids and make a recommendation based on the specification for each site. NETC will have the ultimate say in the selection of the vendor. OTA RF will manage the order and delivery of each transmission line such that it arrives on time as ordered.
- 3.6. Monitoring OTA RF will make a recommendation for monitoring the RF system based on the specification for each site. NETC will have the ultimate say in the selection of the vendor. OTA RF will manage the order and delivery of any monitoring system such that it arrives on time as ordered.
- 3.7. Antenna/line Installation OTA RF will prepare a rigging specification, obtain competitive bids and make a recommendation based on the specification for each site. NETC will have the ultimate say in the selection of the vendor. OTA RF will manage the order and completion of equipment installation at each site.
- 3.8. Electrical contractor OTA RF will prepare an electrical installation specification if needed at a particular site, obtain competitive bids and make a contractor recommendation based on the specification for each site. NETC will have the ultimate say in the selection of the vendor. OTA RF will manage the electrical contractor to ensure they complete the specified items on time as ordered.
- 3.9. Mechanical contractor OTA RF will prepare a mechanical installation specification if needed at a particular site, obtain competitive bids and make a contractor recommendation based on the specification for each site. NETC will have the ultimate say in the selection of the vendor. OTA RF will manage the mechanical contractor to ensure they complete the specified items on time as ordered.

#### 4. ASSEMBLY OF RACKS

4.1. Concept All input and monitoring equipment will be placed in standard type 19" racks which may be pre-assembled and tested off site from the transmitter installation. Due to the large number of components that need to be installed in the racks, OTA RF recommends that this be done in or near the NETC studios or at each site so that all equipment can be received and staged until the complete compliment is available. It does not seem beneficial to send that equipment out of NE due to the number of items and the size of the completed racks that would have to be shipped to the individual transmitter sites.



- 4.2. Completion OTA RF will arrive at the staging location of the rack equipment and do the assembly per the specification of the three stations' racks (1 or 2 each) at one time. This saves cost and ensures commonality between them.
- 4.3. Testing Testing of each rack will be undertaken to ensure that the proper selection and addressing of the components provides consistent results. Derivation of any scripts and costs of test equipment are not included in this scope and proposal. It is assumed that NETC equipment can be used for all of this testing.
- 4.4. Movement to site OTA RF will arrange for shipping the racks to its prospective site when the site is ready if needed. The shipping costs are NOT included in the proposal. It is expected that the rack assembly, and testing may occur at different dates than the installation and would require storage before shipment.

#### 5. INSTALLATION, COMMISSIONING, TESTING

- 5.1. Scope OTA RF will manage the delivery and installation of the complete transmission system defined above for each site. While several independent contractors may be used for their particular area of expertise, they will be directed by OTA RF in their day to day work. NETC should not be required to visit the site other than as desired to witness progress.
- 5.2. Racks Each station will receive their racks and they will be located as previously planned during the design phase.
- 5.3. Transmitter The transmitter will be drop shipped (if possible to receive it from a truck on site) to the site from Nautel as needed per the schedule with direction from the OTA RF project manager.
- 5.4. Antennas/Transmission line A professional rigging crew with broadcast equipment installation experience will be selected and managed to install the antenna and transmission line.
- 5.5. AC power Managed as needed.
- 5.6. Fiber/Cable Internet Managed as needed.
- 5.7. Microwave Managed as needed.
- 5.8. Antenna And Transmission Line Testing
  - 5.8.1. VSWR check The antenna and transmission line will be tested before the rigging crew leaves the site to ensure they are installed correctly and meet the requirements.

#### 5.9. Transmitter And Site Commissioning

5.9.1. Scope OTA RF will manage and perform as needed, the commissioning of the transmission site components as directed by the equipment vendor installation manuals. RF spectrum analysis will be completed for each installation during commissioning to ensure optimum performance and agreement with FCC rules. AM tower base current readings will be taken before and after addition of equipment as needed. If independent contractors are used, they will be directed by OTA RF in their day to day work. NETC should not be required to visit the site other than as desired to witness progress.



#### 6. DOCUMENTATION

- 6.1.1. Scope OTA RF will provide as built drawings and documentation for each installation such that NETC could rebuild or repair any piece of the system at any point after commissioning. This will consist of the following:
