A.1	Data processing services should be a vendor supported, secure, online web location, accessible by the NDOT to upload recorded video for data processing. Contractor shall provide video processing services to the NDOT upon request.		
A.2	Recorded video of turning movement studies and the average daily traffic counts must be stored for at least thirty (30) calendar days and organized at a secure, vendor supported, web location, so the video can be viewed online by an unlimited amount of NDOT users.		
A.3	All videos submitted by NDOT shall be permanently deleted by the Contractor thirty (30) calendar days <u>after</u> the Department's access of the report generated from each video submission.		
A.4	The price bid for data processing services per one (1) hour of recorded video shall include all costs associated in processing the video, extracting the turning movement and classification data from the video, extracting the average daily traffic counts and classification data, providing the data classification reports, and temporary storage of each video.		
A.5	Contractor shall provide data processing services, including the associated Data Report and Summary Report within three (3) business days of NDOT's upload of recorded video to the Contractor's online web location. Contractor shall notify NDOT when reports are available. If delays in data processing services and reports are anticipated, Contractor shall

A.6	Contractor must be able to expand data collection capabilities for data collection, processing, and reporting at Roundabouts; to include all classifications identified in Section IV. C. Scope of Work at the request of the NDOT.		
	Data Report Requirements Data and Summary Reports and Samples		
B.1	Contractor shall provide a data report, to include a summary page, to the NDOT upon completion of requested data processing services. The report provided must capture traffic counts for pedestrians, bikes, and all standard classifications as identified in the Federal Highway Administration classes, divided into each vehicle type.		
B.2	Each classification in the report shall be broken down into 15-minute increments, with the ability to summarize each movement from each approach of an intersection.		
В.3	The Contractor produced report shall also include the capability to identify the peak hour volumes at an intersection.		
B.4	Report should include headers, footers, or comment sections which are customizable to identify the data received, including location of count, date collected, duration of data collection, and classification group of the data as described in this RFP.

B.8	Data reports provided by the Contractor shall become property of the NDOT.		
B.9	Reports shall be provided by the Contractor in a format which can be exported to a spreadsheet.		
B.10	Contractor shall not use any file format which prevents the Department from viewing reports after the contract period has ended.

C.1	Contractor shall provide phone and/or online technical support to the NDOT during the normal business hours of Monday through Friday, 8:00 a.m. to 5:00 p.m. CST, for the duration of the contract and warranty period; whichever is later.
