This RFI does not obligate the State to reply to the RFI responses, to issue an RFP, or to include any RFI provisions or responses provided by vendors in any RFP.

C. COMMUNICATION WITH STATE STAFF

E. ORAL INTERVIEWS/PRESENTATIONS AND/OR DEMONSTRATIONS

The Review Committee(s) may conclude that oral interviews/presentations and/or demonstrations are required. All vendors may not have an opportunity to interview/present and/or give demonstrations. The presentation process will allow the vendors to demonstrate their RFI offering, explaining and/or clarifying any unusual or significant elements related to their response.

Any cost incidental to the oral interviews/presentations and/or demonstrations shall be borne entirely by the vendor and will not be compensated by the State

F. SUBMISSION OF RESPONSE

The following describes the requirements related to the RFI submission, handling and review by the State.

To facilitate the response review process, one (1) original of the entire RFI response should be submitted. RFI responses should be submitted by the RFI due date and time.

A separate sheet must be provided that clearly states which sections have been submitted as proprietary or have copyrighted materials. G. PROPRIETARY INFORMATION

Data contained in the response and all documentation provided therein, become the property of the State of Nebraska and the data become public information upon opening the response. If the vendor wishes to have any information withheld from the public, such information must fall within the definition of proprietary information contained within Nebraska's public record statutes. All proprietary information the vendor wishes the state to withhold must be submitted in a sealed package, which is separate from the remainder of the response. The separate package must be clearly marked PROPRIETARY on the outside of the package. Vendor may not mark their entire Request for Information as proprietary. Failure of the vendor to follow the instructions for submitting proprietary and copyrighted information may result in the information being viewed by other vendors and the public. Proprietary information is defined as trade secrets, academic and scientific research work which is in progress and unpublished, and other information which if released would give advantage to business competitors and serve no public purpose (see Neb. III. PROJECT DESCRIPTION AND SCOPE OF WORK

The bidder should provide the following information in response to this Request for Information.

- A. Quote for cost of Instrument, to include all shipping and handling charges, cost of hardware, software and onsite customer familiarization/training. Also to include onsite assay setup in software. Cost of hardware, software, computer, printer, installation, customer familiarization, warranty, reagent kits for drugs/metabolites.
- B. Quote for cost of listed reagents to include cost of necessary and optional consumables (whether equipment, chemicals, or reagents (e.g., "stop reagent" or "color developing" reagent, etc.).
- C. Separate quote for cost of a service agreement following the expiration of any warranty is required. Service agreement shall explicitly state what services are included (e.g., whether onsite repair is included, what parts are covered within the agreement, etc.).

Required Instrument Specifications

Toxicology casework screening instrumentation MUST meet the following criteria:

- The basic detection technology must be enzyme-linked immunosorbent assay (ELISA).
- The system must be able to analyze both blood and urine samples.
- Hardware and software must be designed to be used with ELISA immunoassay reagents that can detect drugs of abuse as well as pharmaceutical drugs known to cause central nervous system impairment.
 - O At a minimum, the system must be able to detect the drugs / metabolites at the concentrations provided for each sample matrix that are described in Table 1 (at end of document).
- System must be capable of producing semi-quantitative results with ELISA immunoassay kits.
- System must be capable of semi-automated liquid handling, at a minimum.
- System must be capable of providing hardcopy calibration, quality control, and sample data.
- Vendor must provide onsite installation of hardware and software, and onsite customer familiarization / training. It is preferred that the vendor assist with on-site assay set-up in the software.
- Quotes shall include the cost of hardware, software, computer, printer, installation, customer familiarization, warranty/warranties, shipping and handling, and reagent kits for drugs / metabolites listed in Table 1.
 - o Shipping and Handling shall be FOB.
 - o The vendor may assume a caseload of approximately 500 cases per year when pricing reagents.
 - o It is preferred that information be provided regarding the cost of necessary and optional consumables (whether equipment, chemicals, or reagents [e.g., "stop reagent," or "color developing reagent," etc.].
- Technical support must be readily available via phone and email. When necessary, it is preferred that onsite technical support be provided.
- Warranty conditions shall be explicitly stated, e.g., whether onsite repair is included, what parts are covered by the warranty, etc.
- A quote for the cost of (a) service contract(s) following the expiration of any warranty / warranties is required.
- Service contract(s) shall explicitly state what services are included, e.g., whether onsite repair is included, what parts are covered by the service contract, etc.
- Vendor shall comply with State of Nebraska Purchasing Requirements.
