This RFI is requesting information on all aspects of managing a Medicaid prescription drug and drug rebate system across the Fee for Service (FFS) and managed care service delivery models. The State of Nebraska has a single Preferred Drug List (PDL) and the managed care plans must follow the state's PDL. Medicaid also processes rebates for claims from all delivery systems (both FFS and managed care) in the State. The operations support of the Point of Sale (POS) System is for processing FFS claims only.

Current Pharmacy Program Delivery Models – Question #12	8	The RFI indicates that "post implementation of DMA, the DMA vendor will send the MDR extract files which will identify the drug-rebatable encounters based on rebate criteria and rules." The State of Nebraska would expect the Medicaid Drug Rebate (MDR) solution to have the capability to identify the rebatable claims.

Can you please elaborate on this question? What is the State referring to when it states, "vendor-maintained system" and "IT solution"?	Currently the State of Nebraska owns and maintains the Federal MDR system and State staff process drug rebates using the State maintained system. The question is asking the timeline for a vendor to implement their drug rebate solution for use by State staff to perform operations of a Federal and/or supplemental drug rebate program.
