Questions and Answers

Following are the questions submitted and answers provided for the above-mentioned Request for Information. The questions and answers are to be considered as part of the Request for Information. It is the Bidder's responsibility to check the State Purchasing Bureau website for all addenda or amendments.

After reviewing all questions, the State of Nebraska clarifies the following:

- 1. This is a Request for Information (RFI) issued for planning purposes to gather information regarding companies interested in developing electronic government services applications to be part of the Portal. Responses may be used to formulate requirements for any future procurement.
- 2. If future procurement takes place, the State of Nebraska, through the Nebraska State Records Board (NSRB) may enter into one or more contracts for application development services. Such contracts would be made available for use by state and local government agencies, as needed. There would be no guarantee of work. The NSRB would provide an oversight function for such contracts; however, project specifications and requirements would be provided by the agency requesting application development. The specific details of the project would need to be discussed and agreed upon with such agency. The NSRB anticipates this would take place through use of a Statement of Work executed by all parties.

The NSRB does not have a set of established key performance indicators (KPIs) but anticipates that vendors would develop KPIs in conjunction with the agency requesting application development.
4	Is Nebraska State Purchasing Bureau open to an Agile / DevOps model that works in two (2) week sprints?	Yes.
5	Does Nebraska State Purchasing Bureau expect a need for historical data to be migrated from legacy/other systems? Is there any idea on the type and volume of data needed to be migrated?	Any need for migration of data would depend on the specific agency request.
6	It is assumed that Nebraska State Purchasing Bureau will run and own User Acceptance Testing (UAT) testing (test planning, test script creation, test results). Is	The NSRB anticipates that any agency using the vendor's application development services would complete User Acceptance Testing (UAT) prior to launch. Vendor would then be expected to fix bugs and

The specific details of UAT (test planning, test script creation, test results) would need to be discussed and agreed upon with the agency requesting application development.
7	Are there specific types of training or organizational change management (OCM) requirements that Nebraska State Purchasing Bureau prefers (e.g., train the trainer, job aids, communication plans, banners, etc.)?	The NSRB anticipates that any agency using the vendor's application development services would want training for staff on use of the application. The specific details of training would need to be discussed and agreed upon with the agency requesting application development.
8	How do you normally get the pulse of employees when major changes take place?	Each agency has their own method of communicating change and receiving feedback from their employees.
9	Is Nebraska State Purchasing Bureau comfortable with out of box (OOB) portal creation aligned with Nebraska State Purchasing Bureau branding / styles or is Nebraska State Purchasing Bureau looking for a more custom / UX / UI experience?	Each agency will have their own preference for style and branding of their application. The specific details of the style and branding would need to be discussed and agreed upon with the agency requesting application development.
10	Does Nebraska State Purchasing Bureau have any external users that would need to access the Portal (i.e., County residents / citizens)? We assume no, and that the portal and solution will solely be used for internal employees and IT Contractors at this point in time.	The Portal provides electronic access to public records and electronic information and services to the general public. Although specific application requirements may vary by agency, Portal applications are generally public facing, with external public users accessing the public facing services only.
11	Are there any mobile device requirements?	Yes. Please review RFI Section III. B., paragraph 3.

12	Are the solutions that need to be integrated with on premise or SaaS? Can Nebraska State Purchasing Bureau provide more information on the type of data it is expecting to exchange with the proposed solution? Can you please specify if the integrations are to be uni or bi- directional? Do the systems to be integrated have open APIs available for integration purposes?	Existing solutions include both on premise and SaaS solutions. The NSRB anticipates that most solutions would need to be bi- directional (receive and send information). The NSRB does not anticipate there will be any open APIs, and any integration with a state application would require a secure connection. The specific details would need to be discussed and agreed upon with the agency requesting application development and follow all NITC standards.
13	At this time, are there language requirements outside of English?	Not at this time, however, agencies may have specific language requirements to meet the population served.
14	What is the expected duration of vendor provided support post go- live?	The NSRB anticipates that support would be needed for the duration of the life of the application, unless other arrangements are made with the agency requesting application development.
15	Can you please clarify if you have an integration service bus or existing mid servers that can be leveraged for integration related needs?	The NSRB does not anticipate there will be an integration service bus or existing mid servers that can be leveraged for integration related needs.
16	Please describe Nebraska State Purchasing Bureau's planned governance structure for status, decisions, escalation, visibility, etc?	Day-to-day work on the project would be handled at the agency level. It is anticipated that project status reports would be submitted to the NSRB by the vendor, and the NSRB would review vendor performance with the agency requesting the application development and with the vendor.
17	Will Nebraska State Purchasing Bureau dedicate a project management resource or	The specific details would need to be discussed and agreed upon with the agency requesting application development. However, project

No. The State of Nebraska is not able to provide guidance on the expected budget due to the variation in the scope and size of possible projects.
