Highway Safety Information System

Introduction

The Highway Safety Information System (HSI) is the accident records data system that is used by the Nebraska Department of Roads.

The HSI System is accessed through CICS1. A series of menus will guide you through the system. To select an item listed on a menu, type in the Line Number of the desired screen on the Command Line and press ENTER, or move the cursor to the appropriate line of the column headed "Sel," type in "s" for SELECT and hit ENTER.

After accessing CICS1, you will find yourself in the Department of Roads (DOR) Menu. Select the HSI option. This will take you to the HSI Main Menu. From the HSI Main Menu, select the first option, "Highway Safety Data Entry."

HSI Sub Menu 0A1, "Highway Safety Data Entry Selections," is the starting point for the data entry operation. The basic screens that you will use for the data entry operation are displayed here. Besides these screens, there are a number of other screens that you may find useful, including query screens and prompt screens, which are intended to make the data entry job easier.

New accident cases should be entered from the "Add or Restart and Accident Case" screen. Additions, deletions, and updates to existing cases can be made from any of the other screens.

Moving Between Screens

Once into the HSI System, there are several methods of moving between screens:

Screen Name on Command Line

Each screen has a "Screen Name" which consists of the letters HSIX followed by a 3-digit number. For example, the "Accident Data" screen listed on the above sub menu has a screen name of "HSIX019." Entering this screen name on the COMMAND LINE at the bottom of any screen and pressing ENTER will take you directly to the requested screen.

PF Keys

Several of the 24 PF Keys are programmed to take you directly to another screen. The functions of the PF Keys are listed at the bottom of each screen. For example, PF22 will take you to the "Driver Data (Insurance)" screen from most other screens.

Screen Aliases

Most of the data entry screens have two-letter screen aliases that allow you to easily move between screens. Type in the two-letter alias for the desired screen on the Command Line and press ENTER.

Data Entry Instruction Manual

Accident Data Screen (HSIX019)

Accident Date

Enter the date on which the accident occurred in this field. This date can be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use. Although the MMDDYY method requires fewer key strokes, you will have to press the TAB key to advance the cursor to the next field to continue entry.

County Code

Enter the two-digit county code that indicates the county in which this accident occurred.

When accidents occur near county boundaries, it is often difficult to determine in which county the accident should be placed. The First Harmful Event rule is the determining factor. The accident should be located at the spot where the First Harmful Event (the first event which produced injury or damage) occurred.

When an accident occurs exactly on a county line, the accident should be assigned to that county which the driver most at fault was leaving.

Investigator Report Received Date

This date, which should be stamped in the box in the upper right hand corner of the report, can be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use. Although the MMDDYY method requires fewer key strokes, you will have to press the TAB key to advance the cursor to the next field to continue entry.

Accident Time

A four-digit code should be entered indicating the time by hour and minute when the accident occurred, as expressed in military time:

Examples: An accident that occurred at 11:25 p.m. should be entered as 2325

An accident that occurred at 1:05 a.m. should be entered as 0105

If the time of the accident is Not Stated, enter 2499

Police Notified Time

A four-digit code should be entered indicating the time by hour and minute that the police were notified of the accident, as expressed in military time.

The coding is similar to that used for the Accident Time.

Engineering Study Switch

This information should be entered directly off the investigator's report from the box labeled "Should location have engineering study?" If there is no investigator's report for the accident, or if neither box on the investigator's report was checked, enter a '0' which indicates "not available or not stated."

Valid Codes

0 – Not available/not stated

1 – Yes

2 – No

City Name/City Code

City must be entered for all incorporated cities, towns, and villages in Nebraska, regardless of population. You can indicate the proper city by entering **either** "City Name" **or** "City Code." It is not necessary to enter both fields. Choose whichever field is easier for you.

If "City Name" is entered, the actual name of the appropriate city must be typed in and spelled correctly. If an incorrect spelling is used, an error message will appear. By striking PF1 you can access a help screen that lists all valid city names in alphabetical order, along with their appropriate city codes.

Each city, town or village in Nebraska has a 4-digit census code. Instead of typing in the "City Name," this number can be entered in the "City Code" field. A list of all Nebraska cities with their appropriate census codes can be accessed by striking PF1.

CADD Zone Number

Only locations within the city limits of Omaha and Lincoln have CADD zones. If the accident does not occur in one of these cities, no entry should be made in this field. Accidents which happen within Omaha or Lincoln should be coded to the appropriate CADD zone, as determined from the zone maps.

1st or 2nd Accident Switch

Valid Codes

- 1 Yes, a driver or parked vehicle was involved in a 1st or 2nd Accident
- 2 No, or not applicable

This switch relates to those situations when a vehicle is involved in one accident, the situation stabilizes, and then the same vehicle is involved in one or more additional accidents. This switch should be coded '1,' or "Yes," for any accident which is related to other accidents in this manner. It makes no difference whether it is the first accident, second accident, or any other succeeding accident in the overall chain of events.

For the vast majority of accidents, this situation will not apply, and '2,' or "No," should be entered. The "1st or 2nd Accident Switch" is related to the "DMV Exclusion Code" which is located on the Driver Data (Insurance) Screen (HSIX009). This code is discussed on page 45.

Example: Vehicle #1, driven by Bob Jones, is in collision with a second vehicle. The Jones vehicle is stalled in the street, where it is later struck by a third vehicle. Since the situation had stabilized, Jones is considered to have been involved in two accidents. To indicate that these two accidents are related, the "1st or 2nd Accident Switch" is coded '1.'

Location

The location line is where the accident location is described. There are 49 spaces available to be used in a location line. **Try to limit your entries to 30 spaces or less**, since many of the reports that we produce use fewer spaces for this field. Below are some of the basic rules for the location line:

Punctuation

The following rules describe when to use dashes (-), periods (.), quote marks (") and single quote marks or apostrophes (').

1) Only use dashes for separating mileage, directional information, entrances, private property prefixes, railroad crossings and bridges. (-) Do not use spaces before or after a dash.

Examples: N71=3 S OF CRAWFORD or CR "A" S OF CR 3=W OF BEATRICE.

US81 S OF CR 6-JOHN DEERE ENT

LOT-84TH & "F" ST

MAIN ST(N79) AT UPRR-N OF 5TH ST

N12 BRDG OVER AOWA CRK-S OF NEBRASKA ST(S26E)

2) Periods for abbreviations are not used in the location line. (.)

Example: 48TH ST N OF VINE ST-WENDY ENT not 48TH ST. N OF VINE St.-WENDYS ENT.

3) County roads and city streets named with the letters of the alphabet require quote marks. (")

Example: "D" ST & 24TH ST or CR 3 N OF CR "P"-SW OF LYONS

4) Single quote marks or apostrophes should not be used in the location line. (')

Examples: 4161 S 84TH ST-WENDYS ENT not 4161 S 84TH ST-WENDY'S ENT ST MARYS AVE W OF 20TH ST not ST MARY'S AVE W OF 20TH ST

Highways

1) Highway numbers used in the location line should be used with the following prefixes.

Interstate"I"180	Link"L"L28K
US highway"US"US6	Spur"S55M
State highway"N"N38	Rec Road"R"R92A

2) Outside the city limits, use the highway prefix and number only. Do not use the street name.

Example: US6 E OF 84TH ST not CORNHUSKER HWY(US6) E OF 84TH ST

3) Always use the road names that are highest in precedence in the location line.

Example: US275 & R28C not US275 & 264th St

4) When an address is given for an accident occurring on a highway which is outside the corporate limits or does not have a street name, use the address, then HWY and then the highway number without a prefix.

Examples: 9601 HWY 370 or 1111 E HWY 30

5) To describe a highway ramp in the location line, use the direction of the highway to which the ramp is assigned.

Examples: US77 & RAMP FROM EB US30 or 180 WB RAMP TO N44

6) When a highway joins and then leaves another highway, these two highways form two separate junctions that are identified by a directional prefix. The correct junction can be determined by referring to The Nebraska Highway Reference Log Book and a map. In the location line, use the directional prefix first, then "jct" and then the remainder of the location information.

Examples: N JCT US34 & N61 or S JCT US34 & N61 E JCT US77 & N41 or W JCT US77 & N41

7) In the Location Line, use the "0" (zero) for Links, Spurs and Recreation Roads which only have a single digit number.

Example: R07B not R7B

8) Alleys and frontage roads use the highway number in the location line.

Example: ALLEY-BET 38TH ST & 39TH ST-S OF DODGE ST(US6)

Street Names

1) Standard roadway abbreviations should be used where appropriate. The abbreviation "St" can often be omitted. However, other abbreviations must be included because there may also be avenues, circles, or drives with the same street name. For streets named with letters, always use the appropriate abbreviation.

Examples: 72nd St, 72nd Ave, 72nd Ct

2) For streets named with letters, always use the appropriate roadway abbreviation.

Examples: "A" St, "B" Ave, "C" Cr

3) All numbered streets should be either written as **Third** or **3rd**. Use the official NDOR city maps to identify which is the correct method to be used in each city.

Examples: The NDOR map of Wood River uses Third St.

The NDOR map of Greenwood uses 3rd St.

4) Use the entire official name of a street.

Examples: Blair High Rd **not** Blr Hgh Rd

Cornhusker Hwy not Crnhskr Hwy

5) Always abbreviate the direction used in front of street names.

Examples: W Center Rd, N 24th St, E Main St, S First St

County Roads

1) When a county road is assigned two names, use the name, number or letter which is consistent with the names, numbers or letters of the other roads in the county.

Example: In Kearney County - CR 4 not Heartwell Blacktop

Unincorporated Towns

1) For non-highway accidents, use the name of the unincorporated town at the beginning of the location line and then the remainder of the location information. For highway accidents, use the highway first, then the name of the unincorporated town and then the remainder of the location information.

Examples: WHITMAN-LOT-MAIN ST

WHITMAN-MAIN ST S OF OAK

N2-WHITMAN-S OF OAK

2) Do not abbreviate unincorporated town names.

Addresses

1) When an address and the direction to the nearest cross street are both stated on an accident report, use the nearest cross street in the location line.

Example: The front of the accident report reads 2750 S 11TH ST, however the diagram shows 11TH ST N OF VAN DORN ST, use 11TH ST N OF VAN DORN ST.

2) When the block number is the only information available and the nearest cross street can not be identified, the block number is used after the street name.

Example: 19TH AVE-2700 BLK not 2700 19TH AVE

Unknown Locations

Occasionally an accident report will be sent in that does not have complete location information. If all efforts have been taken to find an exact location, such as letters or phone calls by the supervisor, and the information is still incomplete, use the following rules for the location line.

1) When the direction from an intersection where an accident occurred can not be determined, NR (near) may be used.

Example: PEACH ST NR 9TH ST

2) When an accident report only identifies one road and no other information, only use the road stated. Do not assume any other road information to use with the known road.

Example: The only information given on the accident report is 6th St and no other information is obtained, only use **6TH ST** in the location line.

- 3) When an accident occurs **inside** the corporate limits of a city at an unknown location, use **CITY STREET.** When an accident occurs **inside** the corporate limits of a city at an unknown location and has been determined to be on private property, use **LOT-CITY STREET.**
- **4)** When an accident occurs **outside** the corporate limits of a city at an unknown location, use **COUNTY ROAD.** When an accident occurs **outside** the corporate limits of a city at an unknown location and has been determined to be on private property, use **LOT-COUNTY ROAD.**

Accident Exclusions

If an accident has been determined to be an "Accident Exclusion", use one of the statements listed below for the location line. (For the definitions of "Accident Exclusions" refer to the Data Entry Instruction Manual)

- 1) DELIBERATE INTENT
- 2) LEGAL INTERVENTION
- 3) NOT AN ACCIDENT

1st & 2nd Accidents

1) The location line for the 2nd accident does not necessarily need to be the same as the location line for the 1st accident.

Example: Two vehicles collide in the intersection of 25th St & Hickory. The final resting place of vehicle #2 is outside of the intersection on Hickory, east of 25th St. A few minutes later another vehicle collides with vehicle #2. The location of the 1st accident would be **25TH ST & HICKORY.** The location of the 2nd accident would be **HICKORY E OF 25TH ST.**

Intersecting Road 1 Intersecting Road 2

Intersecting Road 1 and Intersecting Road 2 are to be used only when an intersection (& or "at") accident occurs. Each road of the intersection must have a distinctive name. Since there are only 15 spaces available, the Intersecting Road 1 and 2 fields will require a different format than the location line. The location line rules will remain as stated in the Location Guideline Manual. These 2 fields must be in all capital letters! The Intersecting Road 1 and Intersecting Road 2 fields are only used for accidents starting in 2002.

Do not use Frontage Roads in the Intersecting Road fields, since they do not have distinctive names.

If one or both of the roads is unnamed, then leave both fields blank.

For roads that have distinctive names (other than letters or numbers) do not use the road suffix. (ST, AVE, CIR, etc.)

For roads named with numbers or letters, use the road suffix(ST, AVE, CIR, etc). EX: Ave "A", 1st St, "D" Ave, First St

Quotation marks are needed for the roads named with letters. EX: "A" ST Use the numbered road name in the Intersecting Road 1 field.

Use the highway prefix and number. EX: US75 not KENNEDY FRWY(US75)

Ramps and Cutoffs

Use the highway prefix, highway number, direction, and "ramp" or "ctf". EX: US6 WB RAMP, N2 EB CTF

Use "ramp to" or "ramp from" in the Intersecting Road 2 field, when the ramp is assigned to the highway used in Intersecting Road 1.

Junctions

When two separate junctions are formed by the same two highways use N JCT, E JCT, etc. in the Intersecting Road 1 field.

Private Property

Do not use private property roads, named or unnamed.

Highway Number

Highway number must always be entered for roads on the State Highway System. These roads will appear in the **Nebraska Highway Reference Log Book.**

Four spaces are provided to enter the highway number. The fourth position is optional and is often not used, but entry is required in the first three spaces. For those highways with less than three digits in their number, leading zeros must be entered. The prefixes L, S, or R, which indicate that the road is a state link, spur, or recreation road, should always be entered in the first column.

Examples:

Reference Post Number

Any accident that occurs on the State Highway System receives a highway number and should also be given a reference post number.

Six spaces are reserved for the reference post number, including a decimal point, which **must** be entered. Leading zeros need not be entered. Reference posts should be calculated to an accuracy of one hundredth of a mile, or two places to the right of the decimal point.


The reference post number may appear on the accident report, but it is more likely that it will have to be calculated. The **Nebraska Highway Reference Log Book** and the **Urban Reference Post Log** will be useful in determining the precise reference post to be entered.

Related Highway Number and Related Reference Post


These fields are used only when an intersection-related accident occurs entirely on an off-system leg of an intersection with a highway, including Interstate. Enter the "Related Highway Number" and the "Related Reference Post" in the same format as was described for "Highway Number" and "Reference Post." Otherwise, simply tab over these fields.

Intersection-Related Accident – If any of the vehicles involved was in the process of stopping, turning, slowing down, or making any type of maneuver that was a result of the presence of an intersection, the accident was intersection-related.

Examples: A vehicle is southbound on 60th Street in Omaha, making a left-turn to enter the eastbound I-80 entrance ramp, when it is struck broadside by a northbound vehicle. This accident takes place totally on 60th Street, but is related to the state highway intersection with the I-80 ramp terminal. The field "Related Highway Number" should be coded '080' and the field "Related Reference Post" should be coded '45066.' (See diagram)



A northbound vehicle is stopped for a red traffic signal at the intersection of 40th Street and N-2 in Lincoln and is rear-ended by a northbound truck. This accident is related to a state highway intersection, but occurs entirely on the off-system leg (40th Street). The field "Related Highway Number" should be coded '002' and the field "Related Reference Post" should be coded '46109.' (See diagram)



Road Class Code

This code indicates the classification of roadway on which an accident occurred.

Valid Codes

- 0 Non-Applicable
- 1 Recreation Roads
- 2 Local Roads and Streets and cutoffs
- 3 Highway (non-Interstate) rest areas/weigh scales
- 4 Highway (non-Interstate) ramps
- 5 Highway (non-Interstate) and cutoffs

- 7 Interstate ramps
- 8 Interstate mainline

The codes are listed from the lowest to the highest classification of roadway.

Code '0,' "Non-Applicable," should be used for those accidents which do not fit into any of the other categories. Examples would include accidents which happen in parking lots or other non-trafficway locations.

Code '1,' "Recreation Roads," should be used to code accidents which take place on numbered State Recreation Area Roads (such as R51E).

Code '2,' "Local Roads and Streets," should be used to code all accidents which occur on city streets, county roads, or other roads that are not a part of the State Highway System.

Code 3-5 should be used for State Highways other than the Interstate.

Accidents that occur within rest areas or weigh scales along these highways should be coded '3.' Accidents occurring on ramps should be coded '4.' The majority of highway accidents, those that occur on the highway mainline, should be coded '5.'

Codes 6-8 are used for Interstate highway.

Accidents that occur within Interstate rest areas or weight scales should be coded '6.' Interstate ramp accidents are coded '7.' Accidents that occur on the mainline Interstate should be coded '8.'

Private Property Code

Valid Codes

Y – Yes, accident occurred on private property N – No, accident did not occur on private property

If an accident occurs on private property, this field should be coded 'Y'. Include as private property roads on military bases, roads on the campuses of universities, colleges, hospitals, or other institutions, and roads through public parks. Maintenance of these roads is usually the responsibility of the institution itself, rather than the highway or street department of the city or county within which they lie, or the Nebraska Department of Roads.

If an accident occurs on the regular roadway/street system, it should receive a code of 'N.'

In Traffic Switch

Most motor vehicle accidents are **traffic accidents**, so the "In Traffic Switch" should be coded '1.' The "In Traffic Switch" should be coded '2' if the accident was a non-traffic accident.

Valid Codes

1 – Yes, accident occurred in traffic

2 - No, non-traffic accident

To be considered a **traffic accident** an accident must originate or a harmful event must occur on a **trafficway**. A trafficway is defined as a place reserved or commonly used for vehicular travel that is open to the public as a matter of right or custom. A trafficway extends in width from property line to property line. Thus, it includes the roadway, shoulders, and all the other area that lies between the property line and the roadway.

Most motor vehicle accidents occur on trafficways. Those that don't are known as **non-traffic accidents.** Included among non-traffic accidents are those which take place in private driveways, parking stalls and parking aisles of public parking lots, as well as those accidents which occur on airfield roads, farms, industrial premises, mines, quarries, and other private grounds which are not open to the public as a matter of right or custom.

Roads which are under construction or temporarily closed to travel are not considered trafficways **if** traffic is prohibited from entering by signing or barriers which are in conformance with applicable standards.

Private ownership does not exclude a road from trafficway status **if** it is open to the public for vehicular travel. For example, a private boat dock is a trafficway if the owner allows any member of the public to use it. Major roads through private shopping centers, and approaches to public buildings, docks, and stations are also considered trafficways.

One-Way Switch

This field indicates whether or not an accident occurred on a one-way street. This information will normally be taken directly off the accident report form.

Valid Codes

0 – Not stated

1 – Yes

2 – No

Intersection Involvement Code

This element should be coded if the accident occurred within the boundaries of an intersection, or if the accident was in some way related to an intersection. If any of the vehicles involved was in the process of stopping, turning, slowing down, or making any other type of maneuver that was a result of the presence of an intersection, the accident was intersection-related.

Valid Codes

Y – Yes, an intersection was involved

N - No, an intersection was not involved

Bridge Involvement Code

This element should be coded to indicate the involvement of a bridge in an accident. For an accident to be considered bridge-involved, it is not necessary that the bridge be struck by a vehicle. If the fact that the bridge was there contributed to the accident occurrence, then the accident is bridge-involved.

Example: A vehicle goes out of control on an icy bridge deck, but does not leave the roadway until it has crossed the bridge. Although neither the bridge nor the approach guardrail are struck, the accident is still considered bridge-involved.

Valid Codes

Y – Yes, a bridge was involvedN – No, a bridge was not involved

Latitude

Enter the latitude at which the accident occurred if it is listed on the investigator's report. The latitude should be entered as a number in the format NNN.NNNNN.

Example: 041.291177

Longitude

Enter the longitude at which the accident occurred if it is listed on the investigator's report. The longitude should be entered as a number in the format NNN.NNNNN.

Example: 099.378832

Railroad Involvement Code

This element should be coded to indicate the involvement of a train, a railroad crossing, or other railroad property in an accident. For an accident to be considered railroad-involved, it is not necessary that a train, crossing, or railroad equipment be struck. If the fact that a railroad crossing was present contributed to the occurrence of an accident, then the accident was railroad-related.

Valid Codes

Y – Yes, railroad involvement N – No railroad involvement

Federal Railroad Crossing Number

This element provides 7 spaces to identify the railroad grade crossing to which an accident is related.

This element should be coded for any accident where a railroad grade crossing is involved. Private crossings do have crossing numbers, but they are usually not known, since they do not appear on railroad crossing maps. If the Federal Railroad Crossing Number for a private crossing is noted on the accident report, however, go ahead and enter it.

Union Pacific crossings normally start with '8' (example: 817048M), Burlington Northern Santa Fe crossings with '0' (example: 070580J), and Chicago Northwestern crossings with '1' (example: 188269B). This does not always hold true, however, because crossings on railroad lines that change hands, often through the merger of railroad companies, usually retain their old numbers. Thus, many Union Pacific crossings which were once a part of the Missouri Pacific line (which has merged with the U.P.) still begin with '4.'

Railroad Name Code

This element is used to code the name of the railroad company whose train, crossing, or equipment was involved in a railroad-related accident. The letter code should be entered which indicates the appropriate railroad. If this is not a railroad-related accident, code '0' should be entered.

The list to the right shows valid codes for those railroad lines currently operating in Nebraska. The most common entries will be Burlington Northern Santa Fe and Union Pacific. The list below indicates those companies no longer in operation, but which may be needed to code old railroad accidents.

Point of Impact with Train Code

This element is important when motor vehicles collide with trains or other railroad vehicles or equipment that travel on the railroad tracks.

Code '0,' "No impact with train," should be entered for all accidents which do not involve a collision between a motor vehicle and a train or other railroad vehicle.

Code '1,' "Vehicle hit train," should be used when a vehicle-train collision occurs in which the motor vehicle strikes a train or any other track-mounted railroad equipment or vehicles.

Explanation of First Harmful Event Codes

Non-Collision Accidents

Overturn/rollover (Code 01): An accident where a vehicle upsets onto its top or side. A motorcycle is always coded 01.

Fire/explosion (Code 02): An accident resulting from a fire which starts or an explosion which takes place while a vehicle is in transport.

Immersion (Code 03): An accident that results from a vehicle plunging into water, such as a lake or river.

Jackknife (Code 04): An accident that results from unintended contact between any two units of a multi-unit vehicle, such as the tractor and trailer of a truck combination.

Cargo/equipment loss or shift (Code 05): An accident that results from material, gear, or other load falling from a vehicle or shifting position on a vehicle and affecting its balance.

Other non-collision (Code 12): Any non-collision accident that results in damage or injury, but does not fit into any of the other available categories. Examples include vehicle damage caused by driving through potholes or damage to lawns when vehicles drive on them.

Unknown non-collision (Code 13): An accident resulting from any non-collision event where the specifics are unknown.

Collision Accidents

Pedestrian (Code 14): A collision with any person who is not an occupant of a transport vehicle. This includes persons on foot, persons sitting, lying, or working on a trafficway, and persons in a human-powered device (other than those propelled by pedaling), such as a baby carriage, child's wagon, ice or roller skates, scooters, sleds, and wheel chairs.

Bicycle (Pedalcycle) (Code 15): A collision with a non-motorized, human-powered vehicle which is propelled by pedaling. Examples include bicycles, tricycles, and unicycles.

Railway vehicle (Code 16): A collision with any vehicle that is designed to move on rails, including engines or any other track-mounted railroad vehicles.

Animal (Code 17): A collision with any animal that is herded or unattended, such as deer, cows, etc. Animals which are being ridden or which are pulling vehicles, such as carts or buggies, are considered transport vehicles and should be coded as '21', "Other movable object."

Motor vehicle in transport (Code 18): Any collision between two motor vehicles in transport.

Parked motor vehicle (Code 19): A collision between a motor vehicle in transport and a motor vehicle that is not in transport. This includes vehicles parked in places designated for parking, vehicles parked or stopped along the roadway where parking is permitted by normal usage (such as on shoulders), vehicles stopped or parked illegally, but not in the roadway traffic lanes, and vehicles stopped, disabled, or abandoned off the roadway. Vehicles stopped or parked in traffic lanes where parking is prohibited are not considered parked vehicles.

Work zone maintenance equipment (Code 20): A collision with any construction machinery or road maintenance equipment that is actively engaged in work. Examples include a snowplow while plowing snow or a road grader while grading a road. These same pieces of equipment, if moving from place to place on a road and not in the process of working, are considered motor vehicles.

Other movable object (Code 21): A collision with an object that is movable or moving (but not set in motion by a motor vehicle, in which case it would be considered a part of the motor vehicle). Examples include vehicles drawn by animals, animals (such as a horse) being ridden by a person, objects dropped from motor vehicles, but not in motion (such as a chair which fell from a pickup truck and is lying in the roadway), and fallen trees or rocks (which are no longer moving).

Unknown movable object (Code 22): A collision with an object of undetermined nature that is movable or moving (but not set in motion by a motor vehicle, in which case it would be considered a part of the motor vehicle).


Fixed Object Collisions

Fixed Object: A fixed object is an object that is permanently attached to the terrain or is intentionally placed on or along the roadway for an official purpose (such as construction barricades). Objects that are in motion are excluded.

Impact attenuator (crash cushion) (Code 23): A protective device designed to present errant vehicles from impacting fixed object hazards. It is intended to lessen the effect of a crash by absorbing energy at a controlled rate. Most often used on high volume roadways, several different types of devices are common, including sand barrels and collapsible systems employing water or plastic foam.

Bridge: A structure, including supports, which carries a roadway over a depression or obstruction, such as water, another roadway, or a railroad track. Bridges are made up of several components. Motor vehicle collisions with various bridge components are categorized separately under First Harmful Event. (See diagram)

Bridge overhead structure (Code 24): The main bridge structure that carries a roadway or railroad track over another roadway. Collisions with the bridge piers are not included. The most common use of this code would be when a truck with an unusually high load attempts to go under a bridge and strikes the overhead structure.




Bridge pier or abutment (Code 25): The walls or columns that support a bridge structure. (Abutments support the bridge ends, piers are the intermediate supports.) Collisions with these objects will normally involve vehicles traveling under bridges.

Bridge parapet end (Code 26): The end of the low wall, or bridge rail, that runs along the upper portion of a bridge and is an especially hazardous object when struck by a vehicle. Bridge parapet ends are often shielded by guardrail, attenuators, or other protective devices.

Bridge rail (Code 27): A barrier that extends along the length of a bridge structure which is intended to prevent straying vehicles from going over the side of the structure. The most common types of bridge rail are metal rails or concrete parapets.

Most highway bridges are protected by a combination of guardrail and bridge rail. The barrier that extends along the length of the bridge structure is bridge rail. The approaches to the bridge are normally protected by guardrail, which prevents vehicles from striking the parapet ends. A transition section is used to connect the guardrail with the bridge rail to provide continuous protection. When information on the accident report is not sufficient to distinguish whether a bridge-related collision was with bridge rail or approach guardrail, code it to bridge rail. (See diagram.)



Guardrail: A barrier placed lengthwise along the edge of the roadway for the purpose of protecting a vehicle that strays from its intended path from striking a hazard, and redirecting it towards the roadway. The type of guardrail used in Nebraska is usually steel beam or cable. The guardrail codes used for First Harmful Event are broken down into two categories:

Guardrail face (Code 28): The face is the front portion of the guardrail which is intended to be struck by vehicles which stray from the roadway. It represents by far the greatest part of a guardrail system. Accidents which involve a collision with guardrail, but for which information is too sketchy to allow one to accurately determine which part of the guardrail system was actually struck, should be coded as "Guardrail Face."

Guardrail end (Code 29): The end of a guardrail installation, if struck by a vehicle, is particularly hazardous. Because of this, most guardrail ends are built with special end treatments such as breakaway cable terminals (BCT), flared and buried ends, and Texas twists. This code should be used when it can be determined from the accident report that the end, rather than the face of a guardrail, was the first object struck.

Median barrier (Code 30): A permanent barrier usually made of concrete or steel rail, which runs lengthwise along the roadway in the median of a divided highway to prevent vehicles from crossing over into opposing traffic.

Highway traffic sign post (Code 31): Includes all highway regulatory, warning, and guide signs along the side of a roadway and the posts that support them. Private advertising signs or billboards are not included.

Overhead sign support (Code 32): A structure used to support traffic signs that is mounted over the lanes of a roadway.

Light/luminaire support (Code 33): The poles or other structures that support luminaires that are intended to light the roadway.

Utility pole (Code 34): Poles which support wires or cables belonging to a public utility (electrical power, telephone, television, etc.).

Other post, pole, or support (Code 35): Any poles, posts, or other supports that do not fit into another category. This includes reflectorized steel delineator posts (sometimes called reflector posts) that are placed along the side of a roadway to outline the pavement edge.

Culvert (Code 36): Drainage structures designed to carry water under a roadway. The culvert opening, headwalls, wing walls, and inlets should all be considered part of a culvert.

Curb (Code 37): A structure built along the edge of the roadway to provide drainage control, pavement edge support, and pavement edge delineation. It is normally twelve inches or less in height and may be vertical or sloped.

Ditch (Code 38): A narrow channel built along the side of a roadway to collect and carry the surface water that has run off the roadway.

Embankment (Code 39): A raised structure often, but not always, made of earth. It may be built intentionally to hold back water or to carry a roadway, or may be the result of excavation or washout. The backslope of a cut section of highway, as well as creek beds should be coded as embankments.

Fence (Code 40): A barrier intended for containment, such as to prevent animals from escaping, or to mark a boundary.

Mailbox (Code 41): A receptacle intended for the deposit of mail, including its post or other supports.

Tree (Code 42): Any tree or other woody plants and bushes.

Other fixed object (Code 43): Any fixed object not included in another category. It includes walls, buildings, tunnels, etc.

Work zone maintenance equipment (Code 44): Construction machinery or road maintenance equipment that is not in transport, but parked along a roadway.

Unknown fixed object (Code 45): A fixed object of undetermined nature.

<u>Other</u>

Other (Code 46): Any collision or non-collision accident that fits in no other category.

Unknown (Code 47): Any accident of undetermined nature

Relation to Roadway Code

This code is used to place the location of the First Harmful Event of an accident in relation to the roadway. It must be determined from a thorough reading of the case, including the diagram and narrative.

Code '1,' "On roadway," should be used for all accidents where the "First harmful event" occurs on the roadway. The roadway is that part of the trafficway which is intended for vehicle travel.

Code '2,' "Shoulder," should be used for accidents where the "First harmful event" occurs on the shoulder of the

road. The shoulder is that portion of the road immediately next to the driving surface which is intended to accommodate stopped vehicles, for emergency use, and for lateral support of the roadway structure. The shoulder may be paved or made of earth.

Code '3,' "Median," should be used for accidents where the "First harmful event" occurs on the highway median. The median is that portion of a divided highway that separates opposing traffic flows. It is not intended for vehicle traffic.


Besides separating traffic, it can also provide a stopping area for emergency situations and a recovery area for out-of-control vehicles. Median vary greatly in width, from a minimum of 4-feet to 80-feet or more. They are usually grass in rural areas, but are often raised concrete in urban areas.

Code '4,' "Beyond left shoulder," should be used for accidents where the "First harmful event" occurs beyond the left shoulder.

Code '5,' "Beyond right shoulder," should be used for accidents where the "First harmful event" occurs beyond the right shoulder.

Codes '4' and '5' will most commonly be used for single vehicle accidents. In a single vehicle accident, left and right should be determined in relation to the direction the driver is originally traveling. For multi-vehicle collisions, determine left and right from the original direction of travel of the driver who is most at fault in the accident, or who has strayed the farthest from his intended path.

Code '6,' "Off roadway (unknown)," should be used for accidents where it is determined that the "First harmful event" occurred off the roadway, but it is not possible from the information given to tell whether the accident occurred on the shoulder. beyond the shoulder, or in the median.



Code '7,' "Gore," should be used for accidents where the "First harmful event" occurs at a roadway gore. A gore is the area, often triangular in shape, where two roadways which carry traffic traveling in the same direction, come together or split apart. (See diagram)

Code '8,' "Unknown," should be used for accidents where, because of a lack of information, it is impossible to tell where the "First harmful event" occurred.

Directional Analysis Code

This code is used to indicate the type of collision that is the First Harmful Event in multi-vehicle collisions. It must be determined from a careful reading of the case, including the diagram and narrative.

The most important consideration in determining which directional analysis code to assign to an accident is the direction of the vehicles involved just prior to the collision. The angle at which the vehicles collide is a secondary consideration.

Example: Two vehicles collide at a normal four-leg intersection. One of the vehicles was traveling northbound and the other westbound. At the last moment, one of the drivers swerves in an attempt to avoid the accident, his vehicle spins out of control, and the other vehicle collides into its rearend. This accident should be coded as an angle collision. (The determining factor is the direction of travel of the vehicles just prior to the collision.)

In those cases where the direction of travel is the same for more than one directional analysis choice, select the code which best describes the angle at which the vehicles collided.

Example: When vehicles traveling in opposite directions on the same roadway collide, the accident may be coded either as a head-on collision. or a sideswipe (opposite direction) collision, depending on whether the vehicle collided head-to-head or head-to-side.

Code '0,' "Not applicable," should be entered when the accident is not a multi-vehicle collision.

Code '1,' "Rearend," should be entered when a multi-vehicle collision occurs between two or more vehicles traveling in the same direction, and one vehicle collides into the rear of another.



Code '2,' "Head-on," should be entered when a multi-vehicle collision occurs between two vehicles traveling in opposite directions on the same roadway, and they strike front-to-front.


Code '3,' "Angle," should be entered when a multi-vehicle collision occurs between vehicles traveling on roadways, or other driving paths, which cross at such an angle (approximately 90 degrees) as to put them into direct conflict. This includes both vehicles traveling in a straight path and vehicles intending to turn.




Code '4,' "Sideswipe (same direction)," should be entered when a multi-vehicle collision occurs between two vehicles traveling in the same direction, and one of the vehicles collides into the side of the other. This type of accident will often happen when a vehicle is changing lanes on a multi-lane roadway, when a vehicle goes out of control, or when a vehicle attempts to pass another vehicle.




Code '5,' "Sideswipe (opposite direction)," should be entered when a multi-vehicle collision occurs between two vehicles traveling in the opposite direction on the same roadway, and one vehicle strikes the other in the side.



Code '6,' "Left-turn leaving," should be entered if a multi-turning vehicle strikes or is struck by another vehicle which is traveling on the same roadway in the opposite direction. (This does not include collisions between left-turning vehicles and vehicles traveling on crossing roadways. These are single collisions.)



Code '7,' "Backing," should be entered when a multi-vehicle collision occurs in which one of the vehicles involved is in the process of backing up.



Code '8,' "Unknown," should be entered when a multi-vehicle accident occurs, but where the information is not sufficient to determine the directional analysis type.

Investigation at Scene Switch

This information should be entered directly off the investigator's report from the box labeled "Was Investigation Made at Scene?" If there is no investigator's report for the accident or neither box on the investigator's report is checked, enter a '0', which indicates "not available or not stated."

Investigator Type Code

This code is entered to indicate the law enforcement agency which investigated the accident. This should be determined from the "Department" box in the investigator's signature area at the bottom of the back page of the investigator's report.

4 - Other Agency

Code '0,' "Not investigated," should be entered if no investigator's report is received for an accident.

Code '1,' "Nebraska State Patrol," should be entered if the investigating officer was a member of the Nebraska State Patrol.

Code '2,' "County Sheriff," should be entered if the investigating officer is the sheriff of any county or one of his deputies.

Code '3,' "City Police," should be entered if the investigating officer is a member of the police force of any city or village.

Code '4,' "Other Agency," should be entered if the investigating officer is identified as a member of any agency other than those listed above. Example would include Bureau of Indian Affairs police or military police

Vehicle Data Screen (HSIX014)

Information on all vehicles involved in an accident, including parked and towed vehicles, must be entered on this screen.

Investigator Estimated Damage

Enter the dollar damage to this vehicle as estimated by the investigating officer. This information should be taken directly off the investigator's report form. If there is no investigator's report for this accident, or the investigator makes no estimate, leave this field blank.

Round all estimates off to whole dollar amounts. Entry of cents is not allowed. The number entered should not include a dollar sign or commas.

Examples: An estimate of \$569.75 should be entered as: 570

An estimate of \$11,575 should be entered as: 11575

Other Used Symbols: > = Greater Than < = Less Than +/- = \$1001

Rpt Received Date

This hidden field will only appear on the screen when you attempt to enter an "Investigator Estimated Damage" amount without first entering the "Investigator Report Received Date" on the Accident Data Screen (HSIX019).

When this field is highlighted, you may key in the date that the officer's report was received on this screen, rather than having to page back to the Accident Data Screen to make the update.

Use Driver Estimate Switch

This switch should be coded "Yes" whenever a driver's estimate of damage to his vehicle is accepted. It should be coded "No" if a driver's estimate is not received or when a "Proof of Damage" letter is sent to the driver. Based on the driver's response to the "Proof of Damage" letter, it may later be changed to "Yes."

Driver/Owner Estimated Damage

Enter the dollar damage to this vehicle as estimated by its driver or owner. This information should come directly off the individual's accident report. If there is no individual's report, or no estimate is made by the driver or owner, leave this field blank.

Round all estimates off to whole dollar amounts. Entry of cents is not allowed. The number entered should not include a dollar sign or commas.

Examples: An estimate of \$569.75 should be entered as: 570 An estimate of \$11,575 should be entered as 11575

Vehicle License Number

Enter the plate number in this field. This information is taken from the "License Plate Number" field on the investigator's report. Nebraska license plates should be entered without dashes, spaces or plate types. Non-Nebraska plates (including Canadian and Mexican plates) are entered exactly as written in by the officer. You can include dashes and spaces in these types of plates. Examples are provided below.

Vehicle License Year

Enter the four-digit year in which the vehicle license plate expires. This information comes directly off the accident report form. If the year the license plate expires is 2003, for example, the Vehicle License Year should be entered as '2003'.

Vehicle License State

Enter the two-character code that indicates the name of the U. S. state, Canadian province, Mexican state, or U.S. territory where the vehicle is registered. This information is taken from the "License Plate State" field on the investigator's report.

Vehicle Model Year

Enter the four-digit model year for this vehicle. This information comes directly off the accident report form. If the year the license plate expires is 2003, for example, the Vehicle License Year should be entered as '2003'. If the vehicle involved in the accident is government owned and has an Exempt license plate number, level this area blank.

Vehicle Make Code

Enter the two-digit code that indicates the make of this vehicle. This information comes directly off the accident report form.

Vehicle Bodystyle Code

Enter the two-digit code that indicates the correct bodystyle for this vehicle. Although bodystyle is collected on the accident reports, it is often not reported in the manner we want.

The coding of "Bodystyle" is based exclusively on how the body of the vehicle is configured. It is not to be confused with the function the vehicle is performing. For instance, a van used to bus children to a rural school should be coded '17,' "Full size van," not as a bus.

Bodystyle codes requiring some additional clarification are presented below.

Trucks and Buses (Codes 02-09, 37-40)

These codes relate directly to the Supplemental Truck and Bus Accident Report. The Bodystyle Code for any vehicle included on a Supplemental Truck and Bus Report should be taken directly from the "Vehicle Configuration" box on that report.

Any vehicle that is a truck with a Gross Vehicle Weight Rating (GVWR) or Gross Combination Vehicle Weight Rating (GCVWR) of 10,001 pounds or more must be assigned a code from 02-09. Any bus designed to carry 9 or more passengers, including the driver, must be assigned either code 37 or 38. Any vehicle that does not meet either of these qualifications, but is displaying a hazardous materials placard, must be assigned either code 39 or 40.

Code '09,' "Unknown heavy truck," should be used when the vehicle is known to be a heavy truck, but information it too sketchy to determine the precise bodystyle.

Vans (Codes 16-17)

The following lists give examples of vehicle models that should be included in the two van categories. The lists are not necessarily complete.

Minivans: Buick-Terraza; Chevrolet-Astro, Lumina, Uplander, Venture; Chrysler Town and Country, Voyager; Dodge-Caravan, Grand Caravan; Ford-Aerostar, Windstar, Freestar; GMC-Safari, Savana; Honda-Odyssey; Hyundai-Entourage; Isuzu-Oasis; Kia-Sedona; Mazda-MPV; Mercury-Monterey, Villager; Mistubishi-Minivan; Nissan-Altra EV, Axxess, Quest, Van; Oldsmobile-Silhouette; Plymouth-Voyager, Grand Voyager, Vista; Pontiac-Transport, Montana; Saturn-Relay; Toyota-Previa, Sienna; Volkswagon-Camper, Eurovan, Vanagon.

Motorized Cycles (Codes 21-25)

Motorized cycles include only vehicles that have three or fewer wheels. *Code '21,' "Motorcycle and dirtbike"* is the most common category of motorized cycle. When in doubt, a motorized cycle should be entered in this category.

Only use the less common motorized vehicle codes (Minibike, Moped, Motorscooter, or Three-wheel ATV) when a vehicle is clearly described on the accident report as belonging to one of these categories.

Farm Equipment (Code 29)

Any self-propelled farm vehicles, such as tractors, combines, floaters, etc., should receive code '29.' This code **should not** be used for trucks, which should receive the appropriate truck code.

Construction/Maintenance Equipment (Code 30)

Any self-propelled equipment used for road construction or maintenance, such as road graders, pavers, bulldozers, earthmovers, etc., should receive code '30.' This code should **not** be used for trucks, which should receive the appropriate truck code.

Other (Code 31)

"Other" should be used for vehicles that fit into none of the above bodystyle categories. Try not to overuse this category. If a vehicle closely resembles one of the listed bodystyles, but does

not precisely fit, it may be better to include it with the bodystyle it resembles, rather than selecting "Other."

Example: If you know the vehicle is a truck, try to fit it into one of the truck categories, rather than choosing "Other."

Driverless Code

This data element is used to indicate various situations where a vehicle involved in an accident either has no driver or the identity of the driver is not known. It must be determined by a careful reading of the case, including the diagram and narrative.

Code '0,' "MV has driver," should be used for the majority of vehicles in accidents, where the vehicle has a driver and the identity of that driver is known.

Code '2,' "No driver," should be used for those vehicles involved in accidents that had no driver.

This switch should be coded '1' or "Yes" if an emergency vehicle, such as an ambulance, police car, or fire truck, is traveling in emergency mode (siren or flashing lights on).

Because the Heavy Truck/Bus Data screen will be used to collect information on heavy trucks and their trailing units, only information on bodystyles other than trucks will be collected here.

Code '2,' "Trailer," should be used if this vehicle is towing any type of trailer. This includes horse trailers, boat trailers, other vehicles on trailers, etc.

Code '3,' "Farm Machinery," should be used if this vehicle is towing any type of farm machinery or implement.

Code '4,' "Other," should be used if this vehicle is towing something other than the items listed above.

Government Ownership Code

If this vehicle is owned by the government, enter the appropriate code.

Owner Name

An Owner Name should be entered only when there is no driver name available. This includes situations where the vehicle is parked, the driver is unknown, or the vehicle is driverless.

Name format:

1. Proper names should be entered in the format:

LAST, FIRST, MIDDLE with no spaces separating the parts of the name.

All proper names must include two commas.

Example: Richard, Richard, L

If only the last name is known, enter it with two commas at the end.

Example: Jones,,

If no middle initial is available, enter a second comma after the first name.

Example: Wilson, Larry,

Any additional middle names or name suffixes such as Jr, Sr, II,III, etc. should be entered after the second comma. In no case should more than two commas be used.

Examples: James, John, K Jr

Mitchell,Robert,III

Thompson, Angela, Mary Ann

2. Business names should be entered with no commas.

Example: XTZ Electronics Company

Driver Data (Insurance) Screen (HSIX009)

A Driver Data (Insurance) Screen should be created and filled out for every vehicle driver involved in an accident. This includes all vehicles that have a "Driverless Code" of '0.'

Report Received Date

Enter the date when this driver's individual accident report was received. It should be stamped in the upper right hand corner of the report. If no report was received from this driver, leave the field blank

The date can be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use. Although the MMDDYY method requires fewer key strokes, you will have to press the TAB key to advance the cursor to the next field to continue entry.

Personal Driver Attributes

A group of five data elements listing personal driver attributes is entered next. Entry of these elements differs for drivers licensed in Nebraska and those licenses elsewhere or having no license.

Search for Drivers with a Nebraska License

If a driver holds an active Nebraska driver's license, the DMV Driver Record file must be searched before data for any of the five fields listed above will be accepted by the system.

Search by Driver License Number

First attempt to search the Driver Record file by "Driver License Number." Enter the Driver License Number as it appears on the accident report and hit PF4. If a match is found on the Driver Record file, the data for these five fields will be entered into the screen for you.

Search on Driver Name

If the Driver License Number on the accident report is not correct, the search will be unsuccessful. You will have to search the file again, this time by "Driver Name." Blank out the Driver License Number by typing spaces in the field. Then press PF4. This will take you to the Licensed Driver Prompt screen, where the name search begins.

After accessing the prompt panel (PF4), key in the driver name. Names should be entered in the format: LAST,FIRST,MIDDLE with no spaces separating the parts of the name.

All names must include two commas.

Example: Richardson, Rhonda, L

If only the last name is known, enter it with two commas at the end.

Example: Jones,,

If no middle initial is available, enter a second comma after the first name.

Example: Wilson, Larry,

Any additional middle names or name suffixes such as Jr, Sr, II, III, etc. should be entered after the second comma. In no case should more than two commas be used.

Examples: James, John, J Jr

Making a Selection

After entering the "Search Name," a list of names similar to the one entered will be displayed along with other driver information. The more precisely you enter the name, the smaller the list should be.

Each of the names on the list is identified by a line number (noted on the left of the screen as "Ln No"). The cursor will be located on the Command Line. Type the line number of the correct name here and press ENTER. You will return to the Driver Data (Insurance) screen and the proper information will be inserted into the five related fields.

An Unsuccessful Search

If the accident report indicates the driver has a Nebraska license, but you do not find a match on the DMV file, return to the Driver Data (Insurance) screen by passing PF12 and manually type the information provided on the report in the five related fields. After you finish entering data for the entire screen and hit ENTER, a highlighted field "Accept Lic SW" will appear on the screen.

Accept Lic SW – This field appears on the screen only when data entered on a Nebraska driver is not found on the DMV file or when there is an incomplete match with DMV's records. Two of the three fields (1) driver name, (2) birth date, and (3) driver's license number must be the same before data from an incomplete match can be accepted. In order for the system to accept the data entered, this switch must have a "Yes" response. Enter a 'Y' or '1' to indicate "Yes."

Entry for Drivers Not Licensed in Nebraska

For drivers who do not hold a valid Nebraska driver's license, the information for the fields (1) Driver License Number, (2) License State Code, (3) Driver Name, (4) Date of Birth, and (5) Sex Code must be entered manually.

Driver Name

Thirty-five spaces are provided for entering the driver's name.

Proper names should be entered in the format: **Last, First, Middle** with no spaces separating the parts of the name.

All proper names must include two commas.

Example: Richardson, Rhonda, L

If only the last name is known, enter it with two commas at the end.

Example: Jones,,

If no middle initial is available, enter a second comma after the first name.

Example: Wilson, Larry,

Any additional middle names or name suffixes such as Jr, Sr, II, III, etc. should be entered after the second comma. In no case should more than two commas be used.

Driver License Number

Enter the driver's license number for this driver. Twenty spaces are provided. This information should be taken directly from the accident report form. If this information is not available, leave the field blank.

Date of Birth

Enter the driver's date of birth from the accident report form. The date can usually be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

Exception: If the year of the driver's birth was1920 or earlier,

the second date format (YYYY-MM-DD) must be used.

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use. Although the MMDDYY method requires fewer key strokes, you will have to press the TAB key to advance the cursor to the next field to continue entry.

Sex Code

Enter the driver's sex as listed on the accident report form.

Code '1,' "Machine Working," is used when an accident occurs between a vehicle determined to be a "machine working" and another motor vehicle in transport. The driver of the "machine working" receives the code of '1.' The drivers of any other vehicles involved in the accident would receive codes of '0.'

* Requires approval by Accident Records Supervisor

A "machine working" is any construction machinery, industrial or farm machinery, road grader, or similar device that is engaged in work. The concept of "use" at the time of the accident is critical here. If this same machine is in transport, moving from one place to another on a public way, then it is a motor vehicle and should not be considered "machine working."

Example: A truck has a blade attached to its front for plowing snow. While it is actually engaged in plowing snow, this vehicle is a "machine working." If this same vehicle has the blade raised, and it is moving down a roadway in preparation for plowing snow elsewhere, it is a motor vehicle in transport, not a "machine working."

Before "machine working" is coded, the case must be approved by the Accident Records Supervisor.

Code '2,' "Second Accident," is used if this driver is involved in two or more accidents that are related to the same incident. Entering this code will prevent the driver from being charged with two or more separate accidents on his driving record.

This code is related to the "1st or 2nd Accident Switch" which is located on the Accident Data Screen (HSIX019). When the "DMV Exclusion Code" is coded '2,' then the "1st or 2nd Accident Switch" should be coded '1,' or "Yes," for the second accident and any succeeding accidents in which this driver is involved that are related to a single incident. Only the information from the 1st accident will be transferred to the DMV Driver Records file.

Example: Vehicle #1, driven by Bob Jones, is in collision with a second vehicle. The Jones vehicle is stalled in the street, where it is later struck by a third vehicle. Since the situation had stabilized, Jones is considered to have been involved in two accidents. To indicate that these two accidents are related to the same incident, the "1st or 2nd Accident Switch" is coded to "Yes" by entering '1.' To prevent Jones from being charged with two accidents on his driving record, the "DMV Exclusion Code" would be coded '2' for the second accident.

Code '3,' "Legal Intervention," is used when a law enforcement officer intentionally causes an injury or damage producing incident while in the course of arresting or attempting to arrest law breakers or performing other law enforcement actions by means of a motor vehicle. Such an incident is **not an accident** and should be excluded from the driver records of **all drivers** involved.

Events resulting in injury or damage beyond what was originally intended by the officer are accidental, and should not be coded as "legal intervention."

Before "legal intervention" is coded, the case must be approved by the Accident Records Supervisor.

Code '4,' "Deliberate Intent," is used when a motor vehicle is employed as an intentional means of inflicting injury or damage to a specified person or motor vehicle. The two most common instances of "deliberate intent" are suicide or self-inflicted injury and homicide or purposely inflicted damage or injury. If an accident is determined to be "deliberate intent," it is **not an accident** and code '4' should be coded for **all drivers** involved.

Random acts of mischief, such as throwing rocks at a motor vehicle from an overpass, should not be considered "deliberate intent" unless it is shown that the actions were directed at a specific vehicle or person. Events resulting in injury or damage beyond what was originally intended are accidental, and should not be coded as "deliberate intent."

Before "deliberate intent" is coded, the case must be approved by the Accident Records Supervisor.

Code '5,' "Not an Accident," is used for any other incident, besides those already mentioned, which is determined to have not been an accident. Examples include collisions between a "machine working" and a fixed object, incidents where a trailer is blow over by high winds without the vehicle going out of control, incidents where a tree limb falls on a parked vehicle, and incidents which are originally reported as accidents but are later found to be untrue.

If an incident is determined to be "Not an Accident," code '5,' should be entered for **all drivers** involved.

Before "Not an Accident" is coded, the case must be approved by the Accident Records Supervisor.

Officer Contacted Switch

This code is used to show whether or not this driver indicated that a police officer had been contacted in regard to the accident. The information is taken directly from the "Was There a Police Officer Contacted?" box on the individual's report form for this driver. If no individual's report is received from this driver, or neither box on the individual's report is checked, then the field should be coded "Not Stated."

Valid Codes

0 - Not Stated

1 – Yes

2 – No

Insurance Company ID/Insurance Company Name

All insurance company names are identified by a 4-character code. To enter the proper code, you must use the Insurance Company Prompt Screen, which is accessed by pressing PF4.

Insurance Company Prompt Screen

When you first access this screen, the cursor will be located on the search line at the top of the screen. Enter the insurance company name here and press ENTER.

You do not need to enter the entire insurance company name. A partial name will also result in a list of companies being displayed. The more accurately you enter the company name, however, the shorter the list will be.

After you type the name and press ENTER, a list of insurance companies with names similar to the one entered will appear in a scroll region. Each of these companies is identified by a line number, or "Ln Num."

Example: Entry of the name "Mutual" resulted in the following display:

After the list is displayed, the cursor moves to the command line. If the correct insurance company name is displayed, enter the appropriate line number.

If, for instance, "Mutual of Omaha" is the correct insurance company name, enter '4' on the command line and press ENTER. You will be returned to the Driver (Insurance) Data Screen and the correct Insurance Company Name and Insurance Company ID will be inserted.

If you know the Insurance Company ID, you can bypass the Insurance Company Prompt Screen, and type it directly into the 4-character field provided on the Driver (Insurance) Data Screen. This may be most useful when the insurance company is either unknown or the driver is not insured. The following special codes exist on the Insurance Company Names table, but are not really insurance company names:

If a driver's accident report is received, but the insurance information is not filled out, "Not Stated" (ID 0001) should be entered.

If a driver's accident report is received with no insurance tab attached, "No Tab" (ID 0002) should be entered.

If the driver indicates that he had no insurance, enter "None" (ID 0003).

Some companies are self-insured. If this situation applies to a driver, enter "Self-Insured" (ID 0004). To be considered self-insured, a company must appear on the Self-Insured List provided by the Department of Motor Vehicles.

Government-owned vehicles are exempted from the requirement to show financial responsibility by Nebraska statute 60-561. If this situation applies to a driver, enter "60-561" (ID GVMT).

All insurance company names should be listed on the Insurance ID file. If you cannot find a name, check with the Accident Records Supervisor. The file may need to be updated.

Insurance Agent Name

If no insurance company name is provided on the insurance tab of the individual's accident report, but an insurance agent's name is listed, enter the name of the insurance agent or agency. If no insurance agent name is listed, or an insurance company name is provided, tab over this field.

Business names should be entered with **no** commas.

Examples: XYZ Electronics Company

Insurance Denied Switch

This switch is used to indicate those situations when a driver's insurance has been denied. In almost all cases, the switch will be coded '0' for "Not Stated" when the case is first entered. If we later receive notice from the Department of Motor Vehicles that the driver's insurance was denied, then the field should be updated to "Yes" by entering '1.'

Vehicle Occupant Data Screen (HSIX015)

A Vehicle Occupant Data Screen should be created and filled out for every vehicle that has at least one occupant, including the driver.

The screen is set up differently from the previous screens. The data elements are laid out horizontally, rather than vertically, with one line provided for each occupant in the vehicle.

The Screen Function field is located in the first column and must be entered for each occupant. If you are in the "Add a Case" mode, the Screen Function for the first line will be automatically set to "Add" when you access the screen.

To query on this screen, enter the "Accident Key" and "Vehicle Number" at the top of the screen and hit the ENTER key. No "Q" screen function code is required.

If you are in the "Add a Case" mode, information that has already been entered for the driver on the Driver Data (Insurance) screen will be automatically transferred to this screen and will not need to be reentered. The cursor will position itself on the next field where data entry is needed.

Required Data

Information will be captured on this screen for both injured and uninjured occupants. The fields in which data entry is required differ, depending on whether or not the occupant is injured.

Uninjured Occupants

A limited amount of data is available on uninjured occupants. Entry is required in only the (1) occupant number, (2) driver switch, (3) airbag deployed, (4) restraint use, and (5) seating position fields. This information should be taken from the "Restraint Use" box on the accident report form. The name and other personal information about an uninjured occupant will not be available unless he is a driver. Driver data that is collected on the Driver Data (Insurance) Screen will be automatically inserted into the record.

Injured Occupants

Information on injured occupants is taken from the injury section at the bottom of the front page of the accident report form. In addition to the five fields required for uninjured occupants, if an occupant name is entered, entry of the (1) ejected/trapped, (2) body region with most severe injury, (3) injury severity, and (4) transported to medical facility fields are also required.

Information for any of the other fields on this screen may not be available and can be left blank.

Occupant Number

This number must be entered for each occupant. When you are adding a driver, this number will automatically be filled in. When adding other occupants, be sure the occupant numbers are numbered consecutively.

Driver Switch

When you add a driver, this field will be filled in with a 'Y,' for "Yes," when you access the screen. For non-drivers, the Driver Switch should be coded "No" by entering 'N' or '2.' If it is unknown whether this occupant was the driver, code it "Unknown" by entering 'U' or '0.'

Enter this information directly from the "Airbag Deployed" box on the accident report form. It is a required field for each occupant.

Costume (novelty) Motorcycle Helmet – A helmet that does not meet Federal Safety Standards (FMVSS 218) and subsequently does not have the energy absorbing capacity to protect a motorcycle rider in a crash.

Occupant Name

Enter the occupant's name from the accident report form. Proper names should be entered in the format: LAST,FIRST,MIDDLE with no spaces separating the parts of the name.

All proper names must include two commas.

Example: Richardson, Rhonda, L

If only the last name is known, enter it with two commas at the end.

Example: Jones,,

If no middle initial is available, enter a second comma after the first name.

Example: Wilson, Larry,

Any additional middle names or name suffixes such as Jr, Sr, II, III, etc. should be entered after the second comma. I no case should more than two commas be used.

Examples: James, John, K Jr

Mitchell,Robert,III

Thompson, Angela, Mary Ann

Occupant Birth Date

Enter the occupant's birth date from the accident report form. The date can usually be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

Exception: If the year of birth was 1920 or earlier, the second

date format (YYYY-MM-DD) must be used.

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use. Although the MMDDYY method requires fewer key strokes, you will have to press the TAB key to advance the cursor to the next field to continue entry.

1 – Seating Position

Enter the occupant's seating position from Box 1 in the lower right corner of the accident report form. A diagram showing the location of seating positions within a typical vehicle appears at the bottom of the screen.

More than one occupant can be given the same seating position. For instance, if there are more than nine occupants on a large bus which is involved in an accident, all occupants in excess of nine should be assigned to seating position '10,' "Other enclosed passenger/cargo area."

Heavy Truck/Bus Data Screen (HSIX010)

A Heavy Truck/Bus Data Screen should be created and filled out for every truck with a Gross Vehicle Weight Rating (GVWR) or Gross Combination Vehicle Weight Rating (GCVWR) in excess of 10,000 pounds, vehicle displaying a hazardous materials placard, or bus designed to transport 9 or more passengers including the driver, for which information is reported on an Investigator's Supplemental Truck and Bus Accident Report (green form).

Gross Vehicle Weight Rating Code (GVWR)

Enter this code from information provided in the "Gross Vehicle Weight Rating (GVWR)" box on the green Supplemental Truck and Bus Report.

Carrier Name

Enter the Carrier Name for this vehicle directly off the green Supplemental Truck and Bus Report.

Business names should be entered with no commas.

Example: XYZ Electronics Company

If the information is not available, tab over this field.

Carrier Address

Enter the Carrier Address for this vehicle directly off the green Supplemental Truck and Bus Report. Two lines are provided. If the information is not available, tab over this field.

Carrier City Name

Enter the Carrier City Name for this vehicle directly off the green Supplemental Truck and Bus Report. If the information is not available, tab over this field.

Carrier State Code

Enter the two-character Carrier State Code from information found in the "Carrier Address" box on the green Supplemental Truck and Bus Report. If this information is not available, tab over this field.

Object Data Screen (HSIX013)

An Object Data Screen should be filled out whenever an object is damaged as the result of an accident or when a vehicle is damaged as a result of striking an object. A separate screen is required for each object owner.

Object Owner Name

This number must be entered for each object owner. Order the object owners in sequence, starting with '001.' If you attempt to add an object owner who already exists, an error message will appear and you will have to change the object owner number.

Owner Name

Enter the object owner's name from the accident report form.

Proper names should be entered in the format: LAST,FIRST,MIDDLE with no spaces separating the parts of the name. Two commas are required.

Example: Richardson, Rhonda, L.

Business names should be entered with no commas.

Example: XYZ Electronics Company

Common Object Owner Prompt

A prompt screen is provided so that you can easily enter the names of those owners who most commonly have objects struck in motor vehicle accidents. Pressing PF4 while in the upper portion of the screen will access the Object Owner Common Name Prompt. A list of common object owners is displayed as follows:

The cursor will be on the command line. Enter the line number of the desired object owner and press ENTER. You will be returned to the Object Data Screen with the selected name placed in the Owner Name field.

"Not stated" is one of the selections on the Object Owner Common Name Prompt. This should be used when the owner of the object is not listed on the report or when a vehicle is damaged by hitting an object along the road which has no apparent owner or value, such as a rock, snow bank, ditch, etc.

Estimated Damage Amount

Enter the dollar damage to the property of this owner.

Round all estimates off to whole dollar amount. Entry of cents is not allowed. The number entered should not include a dollar sign or commas.

Examples: An estimate of \$569.75 should be entered as: 570 An estimate of \$11,575 should be entered as: 11575

If you do not know the amount of damage to an object, or if there is no apparent damage to the object, tab over this field. Only enter '0' for estimated damage if it is stated on the report that there was no damage to the object.

Estimate Source Code

Enter the code that indicates the source of the cost estimate for the damage amount entered. If the estimate comes from the Investigator's Report, enter '1,' from the Driver's Report, enter '2,' etc.

If no cost estimate is given, enter '1' if the object is mentioned on the investigator's report, '2' if only a driver's report is available.

Report Received Date

If an individual's accident report is submitted by an object owner, or if an object owner has responded to a letter written by this office, enter the date the report was received here. Otherwise, tab over this field.

This date can be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use.

Object Type Code

The types of objects struck are entered on a scroll region in the bottom portion of the Object Data Screen. A prompt screen is provided to assist you in adding these objects. For each Object Owner, an Object Type Code should be entered for every different type of object damaged.

Object Type Code Prompt

The Object Type Code Prompt is accessed by pressing PF4 while in the bottom portion, or scroll region, of the Object Data Screen.

A list of object types will be displayed and the cursor will be located on the Command Line. If you want to enter a single object, enter the line number of the desired object type in the Command Line and strike ENTER. This will return you to the Object Data Screen with the selected object inserted into the scroll region.

The desired object may not appear on the first screen. You can page forward and backward, using PF8 and PF7, to examine the entire object list.

To shorten the list of objects displayed, you can choose to search by "family" of object. The first two letters of the object type codes are the family code. With the cursor on the Command Line, hit the Return Key. This will move the cursor to the "Object Type Category Code" space at the top of the screen. Enter the desired family code and press ENTER. All objects in the selected family will be displayed and the cursor will go to the Command Line. You can then select the desired object as before.

If you want to add multiple objects, you can do so easily by using the "Select" column that runs down the left side of the prompt screen. With the cursor on the Command Line, strike the Return Key twice, and the cursor will move into the select column. Enter the letter "s" in the "Select" column beside all objects you wish to enter. You can use PF8 and PF7 keys to page through the object list. After you have selected all desired objects, strike the ENTER key. You will be returned to the Object Data Screen and all the selected objects will be inserted into the scroll region.

After returning to the Object Data Screen, you must press ENTER to input the selected object or objects into the system.

Pedestrian/Bicyclist Data Screen (HSIX017)

A Pedestrian/Bicyclist Data Screen should be created and filled out for every non-motorist involved in an accident. For purposes of this screen, the term non-motorist includes pedestrians, bicyclists, other pedalcyclists, and persons riding horses or other animals.

Pedestrian Name

Enter the name of the pedestrian from the accident report form.

Proper names should be entered in the format: LAST,FIRST,MIDDLE with no spaces separating the parts of the name.

All proper names must include two commas.

Example: Richardson, Rhonda, L

If only the last name is known, enter it with two commas at the end.

Example: Jones,,

If no middle initial is available, enter a second comma after the first name.

Example: Wilson, Larry,

Any additional middle names or name suffixes such as Jr., Sr., II, III, etc. should be entered after the second comma. In no case should more than two commas be used.

Examples: James, John, K Jr

Mitchell.Robert.III

Thompson, Angela, Mary Ann

Date of Birth

Enter the pedestrian's date of birth from the accident report form.

The date can usually be entered in either of two formats:

1. MMDDYY or 2. YYYY-MM-DD

Example – July 14, 1992 can be entered as: 071492 or 1992-07-14

Exception: If the year of birth was 1920 or earlier

the second date format (YYYY-MM-DD) must be used.

After entry, the date will always be displayed in the YYYY-MM-DD format, no matter which method you use. Although the MMDDYY method requires fewer key strokes, you will have to press the TAB key to advance the cursor to the next field to continue entry.

Seating Position Code

Enter the pedestrian's seating position from Box 1 in the lower right corner of the accident report form. Only codes '18,' '19,' and '20' are valid for use on this screen. If codes 1-17 apply, the person is a vehicle occupant, not a pedestrian. Use code '20,' "Unknown," for persons who are riding horses or other animals.

The Blood Alcohol Content (BAC) Level for the pedestrian should be entered here, if available. If both reports have results and there is a discrepancy between them, use the results from the county attorney's report.

Accident Add Control Totals for Data Entry Screen (HSIX034)

This screen supplies the screen progression that is needed to enter a new accident case or to add a vehicle to an existing case.

Adding a New Case (Function Code = N)

To enter a new case, type an 'N' in the "Function Code" field. Do not enter an Accident Key, but skip to the line labeled "Number Requested." Examine the accident reports you have received for the case and determine the number of vehicle, object owner, and pedestrian records you will need to create. Enter these numbers under the appropriate column headings on the "Number Requested" line and press ENTER. The system will now lead you through the screens that you need to enter, beginning with the Accident Data screen.

Example: Suppose you have an accident that involves three vehicles, two object owners, and a pedestrian. Fill out the screen as follows:

As you enter the case data, the system will take you through a series of three vehicle screens, two object owner screens, and one pedestrian screen.

Other Fields Important to Screen Progression

For each vehicle that has a driver, you will also need to fill out a Driver Data and a Vehicle Occupant Data screen. Whether or not the Driver Data screen appears in the progression will depend on the "Driverless Code" which is entered on the Vehicle Data screen. If the "Driverless Code" is '0,' "MV has driver," then a Driver Data screen will appear.

The Vehicle Occupant Data screen will appear whether or not there is a driver in the vehicle, since it is possible that there could be injured occupants in a parked vehicle. If there are no occupants in a vehicle that has no driver, you will not need to enter anything on the Vehicle Occupant Data screen. Simply strike ENTER again, without entering any data, and the system will take you to the next required screen.

If the "Bodystyle Code" entered on the Vehicle Data screen is '02' through '09' or '37' through '40', a Heavy Truck/Bus Data screen will also appear. The data that needs to be entered on this screen comes from the Supplemental Truck and Bus Accident Report (green form). If no green form has been received, you can bypass this screen by striking ENTER again.

Restarting a Case (Function Code = R)

If a case in the process of being added using the "Add Case" process is exited for any reason before it is completely entered, it can be restarted later at the place where entry ended.

To recall a partially entered case, query on the case by entering a Function Code of 'Q,' entering the Accident Key, and striking ENTER. Once the data on the lines labeled "Number Requested" and "Number Completed" is retrieved, change the Function Code to 'R' and again press ENTER. The add process will be restarted at the spot where the original entry was discontinued.

Changing the Number of Requested Screens (Function Code = C)

Once the add process for a case is started, you may discover that an incorrect number of screens was requested. The number of screens requested can be changed by returning to the Accident and Control Totals for Data Entry screen, changing the Function Code to 'C,' changing the numbers in the "Number Requested" line as needed, and striking ENTER. This can be done while the case is initially being entered, or afterward. If the case is not active, you will have to query on the Accident Key to retrieve the case data.

Using PF Keys Within the Add a Case Process

While entering a new case in the "Add a Case" process, most of the PF keys that are normally available in the HSI system are not active. To make any changes in the screen progression, you must first return to the Accident and Control Totals for Data Entry screen (HSIX034). This can be done by pressing PF12.

Once in the Accident and Control Totals for Data Entry screen, the number of screens requested can be changed by using Function Code 'C.' You can also access the Vehicle Data Screen (HSIX014) by pressing PF21. This will allow you to make changes in the "Driverless Code" and "Bodystyle Code" fields that control whether or not the Driver Data (Insurance) and the Heavy Truck/Bus Data screens appear.

Accident Incident Data Entry Screen (HSIX033)

This screen is used to tie together accidents that are related to one another into incidents. These are accidents where the "1st or 2nd Accident Switch" on the Accident Data screen (HSIX019) was coded "Yes."

Creating a New Incident

After all the accidents that are related to a single incident have been entered into the system, an incident should be created by accessing the "Accident Incident Data Entry" screen (HSIX033).

At the top of the screen, enter the "Incident Date" and "County" which correspond to the incident at hand. Leave the "Incident Sequence Number" blank. Press PF4 to access the "Accident Incident Case Prompt." All the accidents on the date and within the county you selected which have the "1st or 2nd Accident Switch" coded "Yes," and which have not already been placed into an incident, are displayed in a scroll area.

Here is an example for an incident that occurred in Lancaster County (County 55) on January 25, 1991:

Scan the displayed cases and choose those that should be included in the incident by typing an "A" into the screen function column on the far left of the scroll region. If the list is longer than one screen, you can page through it using PF7 and PF8. After all the appropriate cases have been selected, press ENTER. The system will create a new incident, filling in the "Incident Sequence Number."

You can then return from the prompt screen to the "Accident Incident Data Entry" screen by striking PF12. Only those cases that you included in the incident are now displayed. If you later determine that one or more of the included accidents should not have been contained in the incident, they can be deleted here.

Deleting a Case from an Incident

To delete a case from an incident, you must first query the incident on the "Accident Incident Data Entry" screen. If you have just entered the incident, the data will be displayed when you return from the prompt screen by striking PF12.

To query an incident that has been previously entered, enter the Incident Date, Incident Sequence Number, and County Code at the top of the screen and press ENTER. The cases included in the selected incident will be displayed.

Other incidents that occurred in the same county on the same day can be scanned by using the PF10 (Next Record) and PF11 (Previous Record) keys. If you queried on Incident Sequence Number '006,' for example, but later determined that this was not the incident needed, you could access the next lower Incident Sequence Number by pressing PF11 or the next higher Incident Sequence Number by pressing PF10.

To delete cases from an incident, enter a "D" in the screen function column on the far left of the scroll region for those cases you want to remove. Then strike PF2.

To delete an entire incident, place a "D" in the screen function column for all the cases in the incident and press PF2.

Items for Supervisor Review (HSIX004)

This screen should be used to alert the Data Entry Supervisor that a problem exists with a case that will require some additional action, such as sending a letter or making a phone call. It can be accessed from any of the data entry screens by pressing PF14. Unlike most of the other PF keys on the HSI system, PF14 can be used to access this screen while the "Add a Case" process is active.

Depending on which screen you access the items for Supervisor Review screen from, the system makes some assumptions about whom you want to contact for additional information. No matter which screen you are on, the system will place a "How Involved Code" into the Items for Supervisor Review screen when you PF to it. On many screens, it will also pull a name into the "Need Information From" field. The following "How Involved Codes" will appear when you access the Items for Supervisor Review from each of the listed screens.

The "How Involved Code" and name that are automatically placed into the Items for Supervisor Review screen may not always indicate the correct person to whom a letter needs to be sent. If not, the name and/or the "How Involved Code" should be changed. Type the correct name or code over the one that the system placed in the "Need Information From" field.

A list of twelve problem codes appears beneath the name information. These are the most likely reasons why a letter would need to be sent to the person listed. Indicate why we need to contact this person by typing an 'A' in the "Add" column, along the left edge of the screen, for the problem or problems that need to be addressed, and press ENTER.

Example: A driver's report is received which lacks a signature, an estimate of damages, and the names and injuries of occupants. The Items for Supervisor Review screen is accessed from the Driver Data (Insurance) screen. It should be filled out as follows:

After the above information is entered into the system, it is used by the Data Entry Supervisor to prepare letters. If necessary, the information can easily be changed. If you query on the case in the above example, for instance, the screen now appears with the problems that were selected, separated by a blank line from the other problem choices. You are now in "Update" mode. Any of the problems that

appear above the blank line can be deleted by placing a 'D' in the "Add" column along the left side of the screen. Any of the problems which appear below the blank line can be added by placing an 'A' in the "Add" column.

To delete all the information on the problem screen, place a 'D' in the "Screen Function" field at the top of the screen and strike ENTER.
