NATURAL RESOURCES FLOODPLAIN MANAGEMENT SPECIALIST

<u>DESCRIPTION</u>: Under limited supervision possess a complete understanding of the Floodplain Management Section, including its relationship to the department, State and Federal Government. Utilizes knowledge of state statutes and minimum standards as they relate to local floodplain management and National Flood Insurance Program. Will also utilize exceptional customer service skills in dealing with lenders, agents and the public; performs related work as required.

Provide program information to Insurance agents and lenders in a clear and concise manner.

Responds to public requests for floodplain management information using Flood Insurance Maps, Flood Insurance Studies and other related materials/sources.

Provides workshops to floodplain management administrator.

Assists Insurance agents in writing flood insurance policies.

Make Flood Insurance Rate Map determinations accurately when providing requested information.

Provide Floodplain Management Program assistance to communities and counties by reviewing status of existing local programs, providing guidance on program implementation, handling administrative procedures and answering questions about problems/concerns.

Maintains/develops several databases and internet site for the Floodplain Management Section. Databases may include community status, project scheduling, ice jam data inventories.

Handles database/clerical updating using knowledge of different software packages.

Performs initial review of projects to ensure compliance with floodplain management regulations.

Prepares reports detailing the findings of project compliance reviews.
