

Card is not redeemable for cash and may not be used for cash withdrawal at any cash-dispensing locations. Card funds are available for a minimum of 90 days after issuance, through the "Expiration Date" shown on the card.

Proof of eligibility required (i.e., current paystub or ID badge). Service discount is subject to the Business Agreement and may be changed, interrupted and/or discontinued without notice. A minimum number of employees, minimum monthly service charge for qualified plans, additional AT&T services or other requirements may apply for eligibility. Service discounts apply only to the monthly service charge of qualified plans unless otherwise provided in your organization's Business Agreement; under some Business Agreements, the service discount can vary monthly depending on the organization's aggregate volume of qualified charges. Service discounts are not available with any unlimited voice plans. For Family Talk plans, service discount applies only to the primary line. For qualified Mobile Share plans, service discount applies only to the monthly service charge for the plan's data allotment, not to the additional monthly device charges. Additional plan and other restrictions apply. Discounts may not be combined. Offer subject to change.
